## **CD-ROM # ONE: INTRODUCTION**

**Introduction:**Welcome to the accompanying free CD-ROM! These are the Adam Walsh case files that the Hollywood Police Department wanted no one to ever see. My attorney fought hard in 1995 to have these files released to the public. Now you get to view them for yourself.

The files on this disc are in Adobe Acrobat PDF format. If you already have copy of Adobe Acrobat reader installed on your system, you may use it to access the files. If you do not have a copy installed, you will need to install it. Most of what I indexed is a general index, plus what is relevant to Adam. Just like the investigation of Adam's abduction, the files are a showcase of the kind of sloppy work the HPD did. Although they could make the argument that it was American Micro-Image that did the sloppy reproduction work, the Hollywood Police are the ones responsible for the slipshod reproduction of the records on microfilm. They accepted this sloppy reproduction. It could also be argued that microfilm is a poor technology for reproduction and storage of images, though that does not explain why so many images are cut off. It is very hard for me to believe some of this was not deliberate. I personally can't help but believe the HPD just didn't give a crap about Adam's case file reproduction and the only image they really cared about was their own.
