

Ottis Elwood Toole was born in Jacksonville, Florida, and lived in the Springfield area most of his life. He is the youngest of nine children, his father was an alcoholic, his mother suffered from mental illness, one brother is currently confined to a mental institution and one sister attempted suicide. He was raised by his natural parents and livwith his mother until her death in 1981. He was never close to his father brothers or sisters. He stated he periodically visited his mother's grave and would lie down beside her grave and felt the dirt very warm and at times felt the ground move.

As a juvenile Toole ran away from home numerous times and was picke up one time for dressing as a girl. He has always been a loner and tends to avoid people because they would insult him as a youngster, calling him a retard. His formal education was in special classes and dropped out after the 7th grade.

He has been a homosexual all his life and learned sexual activitie from the man who lived next door. He married twice to see how it was and thought perhaps marriage might change his sexual gender preference. His first marriage lasted four days because one of his sisters told his wife he was a homosexual. He married again in 1977 and consumated sexual relations but did not enjoy it.

Ottis Toole has numerous arrests in Jacksonville, Florida; Savannah Georgia; Ashland, Kentucky; Birmingham, Alabama; for auto thefts, larce malicious mischief, lewd and lascivious behavior and loitering. He was tried on August 5, 1983 for numerous arsons in the Jacksonville, Florid area and received 20 years in the penitentiary. On one occasion he was arrested in a pornographic theater for propositioning an officer. He has also engaged in obscene telephone calling, window peeping, does cross dressing and exposes himself to the public. He stated he has been burning down buildings since he was a child and would pour gasolin in houses and put paper in them to catch fire. He has been doing this for years because it excites him and he can fantasize sex. At time he would masterbate while watching the building burn. He has stated that he hates blacks and has burned numerous homes belonging to blacks in Florida because of his dislike for their race.

He stated he was in love with Henry Lee Lucas and had requested a photograph of Lucas to be placed in his jail cell in Florida. He traveled extensively with Lucas across the United States and was involved in some murders with Lucas. He said on occasion he remained in the car they were traveling in while Lucas murdered his victims and committed burglaries of residences. On occasion while they were committing armed robberies they shot the victims numerous times and in each instance there appeared to be an "over kill" taking place. It is believed that in a number of female murders where Lucas had sex with the victim in the presence of Toole, he Toole had entered into the mutilation of the victim due to jealousy and anger over Lucas committing the sexual acts. Lucas has confessed to some murders with Toole in

which the victims were stabbed numerous times, their bodies disembowele with deep cuts along the arms, thighs and legs. On two occasions an "X" was made on the side of the bodies. In some of the murders, an attempt has been made to destroy the body by fire. This fits the M.O. of Toole as an arsonist. One victim had diesel fuel used on the body to set it afire and sometimes diesel fuel was carried in a milk container, obtaining the diesel fuel from the roofing company where they were employed. It is believed that Toole has killed numerous homosexuals and has robbed the victim after death. Lucas stated that on occasion Toole would leave with a male and come back alone with a large sum of money.

On November 2, 1983, the Texas Rangers, Austin, Texas, had in custody two pistols which were sold by Toole to a black male in San Angelo, Texas, sometimes between April and June 1982. These weapons may have been used in some of the murders committed by Lucas and/or Toole. They are described as:

.22 caliber RG, model 14, serial #271535, chambered for long rifle cartridges with 8 lands and grooves inclined to the right with width deminision .040 - .043 per inch and groove width deminsion .041 - .045 per inch.

.25 caliber semi-automatic Italian made Armi Galesi Bresia Brevetto, serial #326427 with 6 lands and grooves inclined to the right with land width deminsion of .040 - .043 and groove width deminsion of .083 - .086 per inch.



Henry Lee Lucas was born in a rural area of Blackburg, Virginia. His father was a double amputee and an alcoholic, as well as his mother was an alcoholic and a very domineering person. He has little formal education, but is very street wise and can improvise when the situation arises. He is a roofer, has knowledge of auto mechanics, carpentry and can repair small appliances. Is an avid watcher of TV newscasts. He can go for several days with little sleep, drinks budweiser and Miller beer, prefers budweiser and smokes Pull Mill (his favorite), Winston and Kool of parettes. He is a shabby dresser, wearing clothes from rescue missions, etc., which may not fit properly. On occasion Lucas has had a mustache and/or beard.

Lucas states at the age of 13 he murdered his first victim, one of his female school teachers; however, this teacher is alive and living in Virginia. On January 2, 1960, he murdered his mother in Tecumseh, Michigan.

Henry Lee Lucas has traveled extensively across the United States, mainly following Interstate highways, but on occasion traveled on off roads. He also traveled across the southern U.S. on I-10, I-20, and I-40 and in the northeastern U.S. around the seaboard and great lakes region. His mode of travel was in older model cars and pickups or by hitchhiking. He could move rapidly from one state to another by hitchhiking with truck drivers and often the truckers would solicit another ride for him through means of the C.B. radio. When his vehicle broke down he would abandon it on the roadside. Gasoline and oil were obtained for his vehicles from cars broke down or parked on the side of the road. He mainly lived in the vehicle he was travelling in, eating canned goods, asking for food and handouts and sleeping in roadside parks, side roads and desolate areas. He frequently went to churches and rescue missions for assistance and sold blood to blood banks for spending money.

On June 11, 1983, Lucas was taken into custody by the Montague County Sheriff's Department and allegedly admits to 100 to 150 murders throughout the United States. His method of operation varied from time to time, but the following was his general intentions.

He is a sex deviate, appearing to attempt to build an ego in regards to his masculinity. He imagines in his mind that his victims are not afraid of him, willing to go with him and willingly submit to his sexual desires. He stated he did not feel comfortable having sex with women who were alive and practiced necrophilia. At times he would have sex with domestic animals, preferring dogs. He would kill the animal and cut away the sex organs. He likes to travel with a pet chihuahua and pet poodle dog.

He was mainly a perpetrator of crimes of opportunity and seldom

stalked his victims. He chose his female victims that were hitch-hiking along highways or females that were having car trouble and on occasion would kidnap a female from a convenience store parking lot. It is believed he often chose his victim from bus depots, truck stops, residental and business areas, rescue missions, hospitals and/or blood banks. He may also be responsible for murders of male victims during robberies and some homosexual murders. In residental burglaries where he killed the victim, telephone wire was used. On one occasion in a residental burglary committed by Lucas and Ottis Elwood Toole (describe later in this article) the elderly female victim was killed and they cut open a feather pillow and scattered the feathers over the victim's body.

Lucas was to be considered as "good" in gaining entry to a private residence to commit burglary where no signs of forced entry was found.

He could con his way into a residence using various stories. It is believed he would often carry an empty milk container to the victim's door pretending the radiator on his car had boiled over and neede water. Also believed flammable liquids were carried in milk containers where Lucas and Toole committed arson.

He admits killing white females, black females, hispanic females and oriental females with ages ranging from children to elderly women. He would stab the victim repeatedly around the neck and chest area, sometimes cutting the victim's throat and sometimes disemboweling her. He sometimes shot the victim using a .22 cal. revolver or automatic, .25 cal. automatics; .22, .38, and .357 magnums. Has also used single shot automatic and lever action rifles of .22, .308 and .30-30 calibers He was also known to carry a 410 gauge shotgun. When the victim was strangled to death he would use his hands, a piece of cloth or clothing belonging to the victim. He is very fond of knives and has killed with homemade knives, steak knives, large pocket knives, butcher knives machetes and a bayonet. Numerous victims were also killed by being beaten to death. Instruments used were pipes, rocks and pieces of lumber.

Some of the victims may not show signs of rape due to the fact that Lucas sometimes reached a climax, ejaculating in his clothing while killing the victim. He was known to bite nipples off the breasts and mutilate the body. On one occasion he decapitated the victim and took the head, and on another occasion the head of the victim was carried in his car for several days and fisposed of in another state. He normally undressed the victim before disposing of the body. Bodies would be left along the highway, back roads just off main highways or close to a roadside park. Several of the bodies were discovered nude with the exception of their socks. Lucas apparently has a "phobia" about socks since he does not wear them at any time and will not wash his feet.

He disposed of the victim's clothing by scattering them along the side of the highway, in trash receptables at roadside parks and desolate areas. He has been known to leave clothing close to the victim's body. He would rarely take the jewelry from the body and rarely took credit cards.

He was careful not to leave any fingerprints at the scene; however, traces of tar could have been found from his clothing since he was a roofer. Also some of the victims could have had traces of animal hair on their bodies due to the fact that he liked to travel with dogs.

Lucas arrived in Jacksonville, Florida in 1976 and met Ottis Elwood Toole at a rescue mission. It has since been learned that Lucas and Toole burned the mission down and moved in with Toole's family.

On many occasions Lucas traveled with Toole and Toole's niece Freda "Becky" Powell, white female, age 15. Freda Powell had escaped from a children's home in the latter part of 1982 and became Lucas' common law wife. In June 1983, he allegedly murdered Freda "Becky" Powell by stabbing her to death and dismembered her body and buried her in Denton County, Texas.

 Car Lot in Jacksonville, Florida in 1978 or 1979
- 1970 or 1971 Chrysler New Yorker, white, which was purchased from Spencer's Car Lot in Jacksonville, Florida, in 1978 or 1979
- 1965 Chevrolet Impala, green, which was purchased from an unknown individual in Jacksonville, Florida in 1978 or 1979 and junked in Jacksonville
- 1965 Plymouth Station Wagon, blue, which was purchased in the State of Washington in 1979, and kept approximately 2 months. Sold to an unknown individual in Jacksonville, Florida
- 1969 Cadillac, black vinyl over gold, which was purchased from Spencer's Car Lot in Jacksonville, Florida, in 1980 and kept for approximately 1 month
- 1973 Cadillac, black vinyl over white, which was purchased from Reeves Auto Sales in Jacksonville, Florida in 1980 or 1981, and kept for approximately 7 months and given back to the car lot






