A. Yeh I think about June or July some time around there. I can't recall the day of the month or the day it happened.

Q. So at the time that they stole your truck until the time of this police report that you assaulted OTTIS you never seen OTTIS between those two dates?

A. No he did not.

A. No

Q. Do you know where their whereabouts were?

A. No I do not. I questioned them but they never would tell me.

Q. You spoke to OTTIS about where FRIEDA and FRANK were?

A. Yeh I said where in the hell are they.
