This statement is with reference to certain knowledge and information that Mr. LAW may possess concerning a homicide that occurred within the City of Hollywood, Broward County, Florida at 300 Hollywood Mall, occurring July 27, 1981. This statement is being obtained by Det. R. Hickman #0434 and Det. J. Hoffman #0038 of the Hollywood Police Department, and is being obtained in the Duval County Jail in Jacksonville, Florida on Wednesday, November 2, 1983 at 7:54 P.M.

A. No, I haven't seen him.

Q. You haven't seen him. When was the last time you saw Ottis?

A. Uh, the first part of the year I was with him. I met him at some

We have information that you were knowledgeable concerning Toole's attitude on a job site that he was bullish and he was protecting Henry when anyone would make any comments about Henry because they were homosexuals and they were lovers and he was very protective about their relationship to a point where once he chased a guy off of a roof with a shovel and on another occasion he had left the job site, got a shotgun and come back to the job site with the shotgun and threatened to shoot somebody.

A. If he did, I was at another job, it wasn't the job I was on.

Q. During the time period that you knew Ottis, did you ever see him own or operate any vehicles?

A. A Cadillac.

Q. What color?

A. A gold Cadillac.

Q. Two door, four door?

A. Uh, four door.

Q. Do you remember what year it was?

A. It was an old one.
