I don't know where he is, I think he's in Arizona, we had a conflict about four years ago, my mom and dad got a divorce and all that, and he ended up bringing me to court for some theft and I wanted to go find him, he wanted to kill me, I wanted him, nobody in the family wanted to tell me where he is.
