THE FOLLOWING WILL BE A BRIEF SUMMARY OF SOME OF THE EVENTS OF THIS INVESTIGATION:

ON 7-27-81 AT 1:55P.M. REVE WALSH REPORTS TO THE HOLLYWOOD POLICE DEPARTMENT THAT HER SON WAS MISSING FROM THE TOY DEPARTMENT AT THE SEARS STORE AT THE HOLLYWOOD MALL. MRS. WALSH STATED THAT SHE LEFT HER SON TO PLAY THE VIDEO GAMES AS SHE SHOPPED AT THE LAMP DEPARTMENT. MRS. WALSH STATED THAT SHE RETURNED TO THE TOY DEPARTMENT APPROXIMATELY 10 MINUTES LATER, UNABLE TO LOCATE HIM. THE SUBSEQUENT SEARCH OF SEARS AND SURROUNDING AREAS COULD NOT LOCATE ADAM UNTIL HIS PARTIAL REMAINS ARE RECOVERED ON 8-10-81 AT 6:45 P.M. IN A CANAL ADJACENT TO THE NORTHBOUND LANES OF THE FLORIDA TURNPIKE APPROXIMATELY 124 MILES NORTH OF HOLLYWOOD.

THE MEDICAL EXAMINER REPORTS THAT THE DEATH WAS DUE TO ASPHYXIATION AND THE CHILD HAD BEEN DEAD AT LEAST 10 DAYS. FURTHER INQUIRY WITH THE MEDICAL EXAMINER'S OFFICE REVEALED THAT THE WOUNDS TO THE REMAINS WERE POST-MORTUM.

FAMILY AND FRIENDS WERE INTERVIEWED, AND DUE TO CIRCUMSTANCES YOU WILL READ ABOUT IN THE SUPPLEMENT REPORTS, WERE ALSO INVESTIGATED.

IN NOVEMBER OF 1981, ONE EDWARD JAMES SURFACED AS A SUSPECT AND APPARENTLY NOT SUCCESSFULLY ELIMINATED. I RECENTLY CONTACTED MR. JAMES IN CENTRAL FLORIDA AND CONDUCTED A LENGTHY INTERVIEW WITH HIM. MR. JAMES DENIED INVOLVEMENT AND, ALTHOUGH THERE WAS NO DECEPTION NOTED DURING THE INTERVIEW, HE VOLUNTARILY SUBMITTED TO A VOICE STRESS ANALYSIS. ACCORDING TO THE EXAMINER, JAMES SHOWED NO SIGNS OF DECEPTION AND HE HAS VOLUNTEERED TO SUBMIT TO A POLYGRAPH EXAMINATION IF FURTHER REQUESTED.

DURING THE SUBSEQUENT INVESTIGATION, SEVERAL PERSONS ALLEGEDLY CONFESSED TO THE MURDER THROUGH VARIOUS PERSONS, AND THE FOLLOW-UPS REVEALED THAT THESE MAY HAVE BEEN BOGUS CLAIMS. UNTIL THE RECENT HINTS VIA TONY LDE BY DONALD LEROY EVANS THAT HE WAS INVOLVED IN THIS CASE, OTTIS TOOLE IS THE ONLY INDIVIDUAL WHO HAS CONFESSED DIRECTLY TO POLICE ABOUT HIS INVOLVEMENT IN THIS CASE. THE FOLLOWING IS A SYNOPSIS OF THE SEQUENCE OF EVENTS IN THE OTTIS TOOLE INVESTIGATION:

ON 10-11-83, DETECTIVE HOFFMAN OF THE HOLLYWOOD POLICE DEPARTMENT WAS NOTIFIED BY A DETECTIVE KINDRICK OF THE BREVARD COUNTY SHERIFF'S OFFICE THAT HE HAD INTERVIEWED OTTIS TOOLE WHO MADE REFERENCE TO HIM THAT HE COMMITTED A SERIOUS CRIME IN THE FT. LAUDERDALE AREA. DET. KINDRICK STATED THAT HE HAD RESPONDED TO THE DUVAL COUNTY JAIL ON 10-10-83 FOR THE PURPOSE OF

INTERVIEWING TOOLE ABOUT AN UNSOLVED MURDER IN HIS JURISDICTION. IT WAS DURING THIS INTERVIEW THAT TOOLE MAKES THE PREVIOUSLY MENTIONED REFERENCE.

WHAT SHOULD BE NOTED IS THAT A T.V. MOVIE ABOUT THIS CASE AIRED ON NATIONAL T.V. LATER THIS SAME DATE AT 9:00P.M. AND IT APPEARS THAT TOOLE'S REFERENCE TO THIS HOMICIDE OCCURRED PRIOR TO THE AIRING OF THE MOVIE. IT IS NOT CLEAR WHAT PROMOTION FOR THE MOVIE TRANSPIRED REGARDING THE SHOW; HOWEVER SEVERAL INMATES WHO SHARED THE SAME POD AS TOOLE WERE LATER INTERVIEWED AND ALL DENIED THAT THE MOVIE WAS VIEWED BY THEMSELVES OR TOOLE. ACCORDING TO DET. KINDRICK, TOOLE BECAME VISIBLY UPSET AND EMOTIONAL AS HE SPOKE OF THIS PARTICULAR INCIDENT.

DETECTIVES HOFFMAN AND HICKMAN RESPOND TO THE JACKSONVILLE SHERIFF'S OFFICE ON 10-12-83 AND OBTAIN A SWORN TAPED STATEMENT FROM TOOLE. IN THIS STATEMENT, WHICH IS ONE OF SEVERAL TOOLE PROVIDES; HE IMPLICATES HIMSELF AND COMPANION HENRY LUCAS IN THE ABDUCTION/MURDER OF A YOUNG W/M BETWEEN THE AGES OF 7 AND 10 YEARS FROM A MALL WITH A SEARS STORE IN THE FT. LAUDERDALE AREA APPROXIMATELY 2 YEARS PREVIOUS. TOOLE PLACES THE TIME OF THIS ABDUCTION AROUND NOON AND PLACES THE CHILD WHEN ABDUCTED OUTSIDE THE STORE.

DURING THE ORIGINAL INVESTIGATION BEGINNING IN JULY 1981; THERE WAS NOTHING NOTED TO SUGGEST ANYTHING HAPPENED INSIDE THE SEARS STORE AT THE TIME OF THE ABDUCTION WHICH WAS BELIEVED TO HAVE OCCURRED IN THE AREA OF 12:30P.M.; AT OR NEAR THE GARDEN SHOP ENTRANCE/EXIT. AT THE TIME, A FEMALE PLAINCLOTHES SECURITY GUARD FOR SEARS BROKE UP A DISPUTE BETWEEN 2 W/M JUVENILES AND 2 B/M JUVENILES AT THE VIDEO GAMES AND ESCORTED BOTH PARTIES OUT SEPERATE EXITS. AT THE TIME, THIS SECURITY GUARD WAS NOT SURE WHETHER ONE OF THE W/M JUVENILES WAS ADAM WALSH BUT DID ESTIMATE THE TIME OF DISPUTE TO BE AROUND THE TIME ADAM WOULD HAVE BEEN IN THE AREA OF THE DISPUTE. I RECENTLY LOCATED THIS SECURITY GUARD IN CENTRAL FLORIDA WHO STATED THAT SHE BELIEVES THAT SHE IS 85% SURE THAT THE YOUNGER OF THE 2 W/M'S WAS ADAM WALSH. THIS SECURITY GUARD WAS CERTAIN THAT SHE ESCORTED THE 2 W/M'S OUT THE GARDEN SHOP EXIT.

IN TOOLE'S SUBSEQUENT STATEMENTS OF ADMISSION; HE STATES THAT THE YOUNG W/M IS STANDING OUTSIDE THE WEST SIDE OF THE STORE WHICH IS WHERE THE GARDEN SHOP EXIT IS LOCATED.

DURING THE INITIAL INTERVIEW OF TOOLE HE DESCRIBES THE WEAPON USED TO SEVER THE VICTIM'S HEAD TO BE A BAYONETTE APPROXIMATELY 18 INCHES IN LENGTH. ON 11-21-83; DETECTIVES HOFFMAN AND HICKMAN INTERVIEW A CHARLES HARDMAN IN JACKSONVILLE. HARDMAN TELLS THE DETECTIVES THAT HE USED TO WORK WITH TOOLE AND AT A TIME SHORTLY BEFORE THIS INCIDENT HE GAVE TOOLE A BAYONETTE WHICH HE ALSO DESCRIBED TO BE APPROXIMATELY 18 INCHES IN LENGTH. HARDMAN STATED THAT HE GAVE TOOLE THIS ITEM TO SHARPEN FOR HIM AND HE NEVER RETURNED IT.

ON 10-20-83; APPROXIMATELY 40 MINUTES AFTER THE INITIAL INTERVIEW WAS TERMINATED; DETECTIVES HOFFMAN AND HICKMAN RECEIVE A SECOND STATEMENT FROM TOOLE. TOOLE AGAIN STATES THAT HE ABDUCTED AND MURDERED THE YOUNG W/M BUT HE DID IT HIMSELF. DETECTIVES HAD APPARENTLY OBTAINED INFORMATION THAT LUCAS WAS IN CUSTODY IN ANOTHER STATE AT THE TIME OF THIS CRIME AND CONFRONTED

TOOLE WITH THIS INFORMATION. TOOLE STATES THAT HE TRIED TO IMPLICATE LUCAS TO GET HIM IN TROUBLE. AT THE TIME THIS STATEMENT IS MADE, LUCAS WAS SUSPECTED OF KILLING TOOLE'S NEICE IN TEXAS AND HE WAS SUBSEQUENTLY CONVICTED OF DOING SO. TOOLE AGAIN STATES THAT THE WEAPON WAS A BAYONETTE WHICH HE SAYS HE RETURNED BACK TO HIS MOTHER'S HOME IN JACKSONVILLE, AND AGAIN DISCUSSES A DIRT ROAD WHICH HE STATES HE PULLED OFF THE HIGHWAY IN ORDER TO DISMEMBER THE VICTIM.

TOOLE STATES THAT IT TAKES 4 OR 5 BLOWS TO THE BACK OF THE UPPER PORTION OF THE NECK NEAR THE BASE OF THE SKULL TO SEVER THE HEAD FROM THE NECK, AND THE HEAD WAS PLACED ON THE FRONT AND REAR FLOORBOARD OF HIS VEHICLE. TOOLE STATES THAT HE DRIVES AN UNDETERMINED DISTANCE NORTH BEFORE HE DISCARDS OF THE HEAD INTO A CANAL ADJACENT TO THE ROADWAY. DURING THIS STATEMENT, TOOLE SAYS HE DISCARDS OF THE OTHER BODY PARTS NEAR THE AREA WHERE THE DECAPITATION TOOK PLACE. ACCORDING TO THE MEDICAL EXAMINER, IT TOOK APPROXIMATELY 5 BLOWS FROM A SHARP INSTRUMENT AT LEAST 3 INCHES IN LENGTH TO SEVER THE HEAD FROM THE NECK AT THE UPPER REAR PORTION NEAR THE BASE OF THE SKULL.

ON 10-21-83, TOOLE IS FLOWN TO HOLLYWOOD AND DRIVEN FROM THE AIRPORT TO THE SEARS AT THE BROWARD MALL WHERE HE STATES THAT IT IS NOT THE SEARS STORE IN QUESTION. TOOLE IS THEN DRIVEN BY THE SEARS STORE IN HOLLYWOOD WHERE HE IDENTIFIES IT AS THE STORE HE ABDUCTED THE YOUNG W/M FROM. TOOLE FURTHER POINTED OUT THE WEST SIDE OF THE STORE AS WHERE HE FIRST OBSERVED THE YOUNG W/M OUTSIDE THE STORE. THE REST OF THIS STATEMENT IS FAIRLY SIMILAR TO HIS PREVIOUS STATEMENTS, ADDING A LITTLE MORE DETAIL ABOUT THE DIRT ROAD.

THIS THIRD STATEMENT IS APPARENTLY TAKEN AFTER HE HAD DIRECTED DETECTIVES TO THE AREA WHERE HE POINTED OUT THIS DIRT ROAD. DETECTIVE HOISINGTON PROVIDES A SUPPLEMENT REPORT REGARDING HIS OBSERVATIONS ON THIS DATE. DET. HOISINGTON DROVE THE VEHICLE IN WHICH TOOLE WAS A PASSENGER IN THE FRONT SEAT. DET. HOISINGTON STATES AT NO TIME WAS TOOLE ASSISTED DURING THE IDENTIFICATION OF THE SEARS STORE AND THE SUBSEQUENT TRAVEL WESTBOUND ON HOLLYWOOD BLVD. AND THEN NORTHBOUND ON THE TURNPIKE. DET. HOISINGTON ADDS THAT TOOLE MAKES REFERENCE TO A CURVE IN THE ROAD HE TRAVELLED ON PRIOR TO REACHING THE TURNPIKE, PRIOR TO TOOLE OBSERVING MILITARY CIRCLE. DET. HOISINGTON ALSO NOTED THAT TOOLE MADE REFERENCE TO THE AREAS OF HOLLYWOOD BLVD. AND I-75 AND THE TRAIN STATION AS BEING FAMILIAR TO HIM PRIOR TO ARRIVING AT SEARS. DET. HOISINGTON ALSO NOTES THAT WHILE VIEWING THE SEARS STORE, TOOLE STATES THAT THE YOUNG W/M HE ABDUCTED WAS STANDING OUTSIDE THE STORE ADJACENT TO THE GARDEN SHOP EXIT.

AFTER POINTING OUT THE PREVIOUSLY MENTIONED DIRT ROAD, TOOLE DIRECTS DETECTIVES TO DRIVE NORTH ON THE TURNPIKE AND STATES THAT THE AREA WHERE THE PARTIAL REMAINS WERE ACTUALLY RECOVERED, APPEARS TO BE THE AREA WHERE HE DISCARDED THE SEVERED HEAD INTO THE CANAL CLOSE TO THE ROADWAY. DET. HOISINGTON STATES THAT TOOLE MAKES REFERENCE TO A WOODEN BRIDGE PRIOR TO SEEING IT AT THIS LOCATION. WHAT SHOULD BE NOTED HOWEVER IS THAT IT APPEARS TOOLE WAS SHOWN A PICTURE OF THIS BRIDGE DURING HIS INITIAL STATEMENT ON 10-19-83 IN JACKSONVILLE. IT SHOULD ALSO BE NOTED HOWEVER THAT THIS BRIDGE IS NOT EASILY SEEN FROM THE ROADWAY AND TOOLE DOES

MAKE THIS REFERENCE PRIOR TO SEEING IT.

LATER ON 10-21-83, DET. TERRY OF THE JACKSONVILLE SHERIFF'S OFFICE PROVIDES A SWORN STATEMENT TO DETECTIVES ABOUT HIS INVOLVEMENT DURING THE INITIAL CONFESSION BY TOOLE. DET. TERRY STATES THAT HIS KNOWLEDGE OF THE FACTS OF THIS CASE WAS LIMITED, AND TOOLE PROVIDED THE ABOVE INFORMATION UNSOLICITED. WHAT IS IMPORTANT TO NOTE IS THAT THE REFERENCE ABOUT THE DIRT ROAD MADE BY TOOLE MAY BE SIGNIFICANT, AS THERE WAS NO PREVIOUS DOCUMENTATION OF THIS LOCATION WHICH WAS APPROXIMATELY 4 MILES SOUTH OF WHERE THE PARTIAL REMAINS ARE RECOVERED AND ACCESSIBLE ONLY TO NORTHBOUND TRAFFIC. SEVERAL TIMES DURING TOOLE'S THIRD STATEMENT, HE STATES THAT HE DESCRIBED THIS ROAD ACCURATELY TO DET. TERRY PRIOR TO BEING TAKEN TO ITS LOCATION.

ACCORDING TO DET. HOISINGTON, HE HAD PERSONALLY TRAVELLED THIS EXACT ROUTE ON MANY OCCASIONS DURING THE SUMMER OF 1981 AND HAD NOTED THAT THERE WERE VERY FEW, IF ANY, LOCATIONS SIMILAR TO THIS DIRT ROAD WHERE ONE COULD EXIT THE ROADWAY AND BE CONCEALED FROM PASSERSBY. SEE DET. HOISINGTON'S, AND DETECTIVES HOFFMAN AND HICKMAN'S SUPPLEMENT REPORTS FOR ADDITIONAL ON THIS MATTER.

THE SUBSEQUENT EXHAUSTIVE INVESTIGATION INTO OTTIS TOOLE'S POSSIBLE INVOLVEMENT PROVED THAT HE COULD NOT BE ACCOUNTED FOR BETWEEN 7-24-81 AT 11:30A.M. WHERE HE IS PROVIDED A GREYHOUND BUS TICKET TO RETURN TO JACKSONVILLE FROM NEWPORT NEWS, VA., AND 8-1-81 AT 4:10P.M. WHERE HE IS INVOLVED IN AN ALTERCATION WITH HIS BROTHER HOWELL IN JACKSONVILLE. BOTH OF THE ABOVE DATES ARE CONFIRMED WITH DOCUMENTATION. ALTHOUGH A RENT RECEIPT IS APPARENTLY LOCATED FOR OTTIS TOOLE AND HIS WIFE FOR A ROOMING HOUSE IN JACKSONVILLE, LISTING THE DATE 7-31-81, IT IS NOT CLEAR THAT TOOLE WAS PERSONALLY SEEN ON SAID DATE. IN FACT, HOWELL TOOLE PROVIDES A STATEMENT WHEREIN HE STATES THAT HE HAD BEEN LOOKING FOR OTTIS FOR SEVERAL WEEKS REGARDING THE THEFT OF HIS PICK-UP TRUCK. HOWELL TOOLE ADDED THAT EVERYONE HE QUESTIONED REGARDING OTTIS' WHEREABOUTS STATED THAT HE HAD NOT BEEN SEEN UNTIL HE LOCATED HIM ON 8-1-81.

THE INVESTIGATION REGARDING THE VEHICLE TOOLE STATES THAT HE DROVE AT THE TIME REVEALED THAT IT HAD BEEN OWNED BY THE PERSON HE SAID HE BOUGHT IT FROM AND THAT HE DID IN FACT HAVE ACCESS TO IT. THE VEHICLE IN QUESTION, A 1971 BLACK/WHITE CADILLAC, WAS NORMALLY PARKED IN THE COMPOUND OF THE ROOFING COMPANY TOOLE HAD WORKED FOR AND WAS NOT ALWAYS ACCOUNTED FOR DURING THE TIME TOOLE STATES THAT HE DROVE IT TO THE SOUTH FLORIDA AREA. IN TOOLE'S PREVIOUS STATEMENT, HE REFERS TO BEING FAMILIAR WITH THE AREA OF BISCAYNE PARK (BELIEVED TO BE BAYFRONT PARK) IN MIAMI AS FREQUENTED BY HOMOSEXUALS SUCH AS HIMSELF, AND THAT HE HAD BEEN THERE IN THE PAST. TOOLE STATES THAT HE STAYS IN THIS AREA PRIOR TO THE ABDUCTION IN HOLLYWOOD. THE STATEMENT REGARDING BISCAYNE PARK BEING FREQUENTED BY HOMOSEXUALS IN 1981 MAY BE AN ACCURATE STATEMENT, AND ONE NOT FAMILIAR TO AN OUT OF AREA DETECTIVE SUCH AS DET. TERRY.

THE F.D.L.E. PROCESSED THE PREVIOUSLY MENTIONED VEHICLE IN JACKSONVILLE AND NOTED AREAS OF LUMINESCENCE AFTER LUMINOL WAS APPLIED TO THE INTERIOR OF THE VEHICLE. THIS LUMINESCENCE OCCURRED IN THE CARPET ON THE FLOORBOARD BEHIND THE DRIVER'S SEAT, AS WELL AS IN THE CARPET ON THE FLOORBOARD IN FRONT OF THE

DRIVER'S SEAT. THE CARPETING WAS LATER SENT TO THE SEROLOGY DEPARTMENT OF THE F.D.L.E. WHERE FURTHER PRESUMPTIVE TESTS REVEALED THAT THESE LUMINESCED AREAS WERE IN FACT BLOOD. ACCORDING TO SEROLOGIST JIM POLLACK, NO FURTHER INFORMATION COULD BE DETERMINED REGARDING THIS BLOOD AT THAT TIME. THE WHEREABOUTS OF THIS CARPETING IS UNKNOWN AT THIS TIME AND MAY HAVE BEEN DISCARDED.

A MACHETE WITH GREEN CANVAS SHEATH WAS ALSO RECOVERED IN JACKSONVILLE FROM A USED CAR DEALER WHO STATED THAT TOOLE MAY HAVE POSSESSED AT SOME TIME. SUBSEQUENT TESTS OF THIS ITEM REVEALED TRACES OF BLOOD ON THE MACHETE BLADE AND ON THE CANVAS SHEATH. THE RESULTS OF FURTHER TESTS WERE THE SAME AS MENTIONED IN THE PREVIOUSLY MENTIONED VEHICLE CARPET. IN JANUARY OF 1995, I DELIVERED THIS ITEM TO THE GENETIC DESIGN LAB IN GREENSBORO, N.C. TO BE FURTHER EXAMINED. THE RESULT WAS THAT THERE WAS NO BLOOD DETECTED ON THE MACHETE OR SHEATH, WHICH APPEARED TO HAVE BEEN CUT IN THE AREAS WHERE BLOOD WAS DETECTED IN 1983. THE WHEREABOUTS OF THESE CUTTINGS ARE ALSO UNKNOWN AT THIS TIME.

ON 10-24-83, ARLENE MAYER CONTACTED DETECTIVES REGARDING THE PHOTOGRAPH OF TOOLE IN A LOCAL NEWSPAPER. MRS. MAYER STATED THAT TOOLE APPEARED TO BE THE SAME INDIVIDUAL WHO FOLLOWED HER AND HER DAUGHTER HEIDI AROUND THE K-MART STORE LOCATED IN HOLLYWOOD SOME TIME IN JULY 1981. MRS. MAYER ADDED THAT SHE WAS POSITIVE THAT IT WAS A FRIDAY OR SATURDAY. (THE ABDUCTION OCCURRED ON A MONDAY) MRS. MAYER STATED THAT THIS INDIVIDUAL INDULGED HER DAUGHTER IN CONVERSATION WHICH FRIGHTENED HER. MRS. MAYER ADDED THAT HER DAUGHTER ALSO STATED THAT THE PICTURE IN THE PAPER WAS THAT OF THE INDIVIDUAL WHO FOLLOWED HER AND TALKED TO HER AT THE K-MART.

ON 10-26-83, DET. HOFFMAN OBTAINED ANOTHER STATEMENT FROM TOOLE IN JACKSONVILLE ABOUT THE INVESTIGATION TO THAT POINT. DURING THIS STATEMENT, TOOLE BECOMES CONFUSED DURING THE DISCUSSION ABOUT HIS ACTIVITIES AFTER HE ARRIVED IN JACKSONVILLE FROM NEWPORT NEWS. TOOLE INITIALLY STATES THAT HE WENT DIRECTLY TO SOUTHEAST COLOR COAT WHERE THE 1971 CADILLAC IS PARKED AND THEN STATES HE MAY HAVE GONE TO HIS WIFE'S LOCATION, ARRIVING AT EITHER LOCATION ON FOOT. AN EXCHANGE OCCURS LATER BETWEEN TOOLE AND DETECTIVES HOFFMAN AND TERRY DURING WHICH HE STATES THAT HE DID NOT KILL ADAM WALSH AND MADE EVERYTHING UP, EVEN THOUGH HE WAS CONFRONTED WITH THE FACT HE WAS ACCURATE ABOUT CERTAIN FACTS BY BOTH DETECTIVES. THIS STATEMENT ENDS WITH TOOLE IN AN EMOTIONAL STATE.

APPROXIMATELY 15 MINUTES AFTER THIS STATEMENT IS COMPLETED, TOOLE PROVIDES ANOTHER STATEMENT, AGAIN ADMITTING TO THE CRIME. TOOLE DOES NOT PROVIDE ANOTHER STATEMENT UNTIL 11-19-83 WHEN HE INFORMS DET. HOFFMAN THAT HIS ADMISSIONS ARE TRUE AND PROVIDES A NEW LOCATION OF DISPOSAL OF THE REMAINDER OF THE BODY. TOOLE STATES THAT HE DISPOSED OF THE REST OF THE BODY AT A JACKSONVILLE LANDFILL AFTER HE HAD BURNED IT IN AN OLD REFRIGERATOR ON HIS MOTHER'S PROPERTY. TOOLE STATES THAT THE TRUNK LINER OF THE 1971 CADILLAC WAS ALSO DISCARDED AT THE LANDFILL AS IT HAD BLOOD ON IT. TOOLE GOES ON TO STATE THAT THE MACHETE, WHICH HE DESCRIBED TO BE ENCASED IN A GREEN CANVAS SHEATH, WAS PROBABLY AT ONE OR TWO LOCATIONS, ONE BEING THE PREVIOUSLY MENTIONED USED CAR DEALER. ACCORDING TO DET. HOFFMAN'S SUPPLEMENT REPORT, HE

INDICATED THAT IT WAS NOT POSSIBLE THAT TOOLE COULD HAVE KNOWN THAT A MACHETE, EXACTLY DESCRIBED, HAD ALREADY BEEN RECOVERED FROM THIS USED CAR DEALER ON 11-2-83. IT SHOULD ALSO BE NOTED THAT THE 1971 CADILLAC BEING REFERRED TO, DID NOT HAVE A TRUNK LINER WHEN INSPECTED. A SUBSEQUENT STATEMENT FROM THE VEHICLE OWNER, FAYE MCNETT, REVEALED THAT SHE USED THE TRUNK OF THIS VEHICLE ON MANY OCCASIONS AND RECALLED THAT IT DID HAVE A TRUNK LINER IN IT.

ON 12-27-83, LIGHT GREEN SHORTS WHICH WOULD FIT A SMALL CHILD WERE UNEARTHED AT THE TOOLE PROPERTY AFTER EXCAVATION, ALONG WITH ONE CHILD'S RUBBER YELLOW ZORI SANDAL. I RECENTLY SHOWED THESE TWO ITEMS TO THE WALSHES AND THEY STATED THEY WERE NOT THE ONE'S ADAM WORE AT THE TIME OF THE ABDUCTION.

ON 1-6-84, DETECTIVES APPROACHED TOOLE AGAIN AT WHICH TIME HE RECANTED AND PROVIDED ANOTHER STATEMENT. ALTHOUGH TOOLE RECANTS, HE STILL CANNOT BE PLACED ANYWHERE, JACKSONVILLE OR SOUTH FLORIDA, SANS THE STATEMENTS BY THE MAYERS.

DURING THIS PART OF THE INVESTIGATION, ONE LARRY WALDO SURFACED AS AN ASSOCIATE OF OTTIS TOOLE. WALDO INFORMED DETECTIVES THAT HE MET OTTIS TOOLE AT A ROOMING HOUSE IN JACKSONVILLE. THIS WAS LATER CONFIRMED THROUGH INTERVIEWS OF PERSONS AT THE ROOMING HOUSE, BUT IT WAS BELIEVED TO BE IN THE LATTER PART OF 1981. AT THE TIME WALDO PROVIDED A STATEMENT TO DETECTIVES, HE RESIDED AT 1608 N. 26 AVE. IN HOLLYWOOD, WHICH IS APPROXIMATELY 1 BLOCK NORTH AND 2 BLOCKS EAST OF THE WALSH RESIDENCE AT THE TIME OF THE ABDUCTION. I RECENTLY TRAVELLED TO JACKSONVILLE TO DETERMINE WHETHER THIS WAS ONLY COINCIDENTAL OR IF WALDO HAD ANY KNOWLEDGE OR ASSOCIATION WITH THE WALSHES. THIS INQUIRY REVEALED THAT WALDO DIED IN 1990 AND ATTEMPTS WILL BE MADE THROUGH FRIENDS OR FAMILY MEMBERS TO CLEAR THIS UP.

IN NOVEMBER OF 1988, TOOLE CONFESSES TO B.S.O. DETECTIVES SCHEFF AND FANTIGRASSI WITH THE ASSISTANCE OF FELLOW INMATE GERARD SCHAEFER. AFTER THIS INTERVIEW, THE DETECTIVE RECOVER A BAYONETTE AND SHEATH FROM TOOLE'S SISTER'S RESIDENCE. TOOLE'S SISTER STATES THAT THIS BAYONETTE HAS BEEN IN HER POSSESSION SINCE 1979, HOWEVER IT IS SIMILAR IN DESCRIPTION TO THE BAYONETTE CHARLES HARDMAN STATES HE GAVE TO TOOLE. AT THIS POINT IN TIME, IT IS NOT CLEAR IF THIS IS THE SAME BAYONETTE OR ONE SIMILAR.

IN JULY OF 1991, DETECTIVE HOFFMAN IS CONTACTED BY A WILLIAM MISTLER. MISTLER CONTACTS DETECTIVE HOFFMAN AFTER READING A NEWSPAPER ARTICLE WHEREIN THE TEN YEAR ANNIVERSARY OF THIS CRIME IS DISCUSSED. IT IS STATED IN THIS ARTICLE THAT TOOLE WAS ELIMINATED AS A SUSPECT IN THIS CASE. AT THE TIME TOOLE WAS MENTIONED AS A SUSPECT IN THIS CASE, MISTLER BELIEVED HE WAS TO BE ARRESTED AFTER VIEWING A PRESS CONFERENCE BY THIS AGENCY. PERSONALLY KNOWING THE CONTENT OF THIS PRESS CONFERENCE, IT IS UNDERSTANDABLE HOW SOMEONE COULD HAVE BELIEVED THIS WOULD OCCUR. MISTLER WENT ON TO STATE THAT HE WAS AT THE SEARS STORE AT THE TIME IN QUESTION AND STATED HE OBSERVED TOOLE TO BE IN AN EARLY 70'S BLACK/WHITE CADILLAC PARKED ADJACENT TO THE GARDEN SHOP ENTRANCE/EXIT. HE LATER OBSERVED TOOLE PLACE A YOUNG W/M INTO THE VEHICLE. MISTLER FURTHER STATED THAT AFTER HEARING OF THE ABDUCTION WHERE THE SUSPECT VEHICLE WAS BELIEVED TO BE A BLUE VAN, HE DID NOT BELIEVE HE OBSERVED AN ABDUCTION.

MISTLER STATES THAT HE RETURNED TO THE SEARS LATER THIS SAME DATE AND OBSERVED WHO HE BELIEVES TO BE JOHN WALSH ARRIVING AT THE STORE DRESSED IN A SUIT. (ACCURATE) MISTLER ALSO RECALLED SEEING A FEMALE HE BELIEVED TO BE REVE WALSH CALLING FOR "COODER". THIS WAS IN FACT ADAM'S NICKNAME. AFTER SEEING TOOLE'S PICTURE IN THE PAPER IN 1983, HE WAS POSITIVE THIS WAS THE SAME SUBJECT PREVIOUSLY MENTIONED. I CONTACTED MISTLER IN 1995 AND HE REMAINED WITH HIS PREVIOUS STATEMENT. MISTLER ACCURATELY DESCRIBED THE PREVIOUSLY MENTIONED CADILLAC, INCLUDING RUST SPOTS AND DENT IN REAR BUMPER ADJACENT TO THE TAG. IT IS NOT CLEAR WHAT INFORMATION, IF ANY, WAS PUBLISHED LOCALLY ABOUT THIS VEHICLE. MISTLER DENIES OBTAINING THIS INFORMATION FROM THE MEDIA, AND A SUBSEQUENT VOLUNTARY POLYGRAPH EXAMINATION WAS RULED INCONCLUSIVE.

IN JUNE OF 1995, TOOLE IS INTERVIEWED BY MYSELF AND DET. NAVARRO. TOOLE BECAME AGITATED ABOUT THE QUESTIONING AND WAS INITIALLY DIFFICULT TO COMMUNICATE WITH. TOOLE DENIED BEING INVOLVED AND DENIED EVER MAKING ANY ADMISSIONS. ALTHOUGH WE SPOKE WITH HIM FOR SEVERAL HOURS OVER A TWO DAY PERIOD, WE DID NOT BECOME ACCUSATORY OR AGGRESSIVE AT THAT POINT IN TIME. THIS TYPE OF INTERVIEW WILL BE ATTEMPTED IN THE NEXT FEW WEEKS.

TWO FORMER CELLMATES OF TOOLE WERE INTERVIEWED AND PROVIDED STATEMENTS WHEREIN THEY STATED TOOLE HAD CONFESSED TO THEM. SEE THEIR STATEMENTS, AS WELL AS ALL OTHER STATEMENTS AND REPORTS PROVIDED IN THIS FILE FOR FURTHER DETAILS.

THE FOLLOWING WILL BE THE FOURTH SUPPLEMENT REPORT SUBMITTED BY DETECTIVE MARK SMITH.

AS STATED IN THE PREVIOUS SUPPLEMENT REPORT, THIS DETECTIVE, ALONG WITH DET. SGT. DUNBAR, RESPONDED TO THE BEHAVIORAL SCIENCES DEPT. OF THE F.B.I. IN QUANTICO, VA. ON 10-23-95. WITH THE ASSISTANCE OF SPECIAL AGENTS WAYNE RUSSELL AND STAN SMITH OF THE MIAMI OFFICE OF THE F.B.I., THIS CASE WAS PRESENTED TO THE CHILD ABDUCTION SERIAL KILLER UNIT (C.A.S.K.U.) OF THE BEHAVIORAL SCIENCES DEPT. FROM 10-23-95 THROUGH 10-25-95. THE RESULTS OF THIS PRESENTATION WILL REMAIN IN THE CUSTODY OF THE F.B.I. AND WILL BE REVIEWED BY THIS DETECTIVE FOR FOLLOW-UP IF WARRANTED AND/OR NECESSARY.

ON 10-30-95, THIS DETECTIVE RECEIVED A PHONE CALL FROM A JENNIE WARREN OF 6313 ARTHUR ST. HOLLYWOOD, MS. WARREN STATED THAT SHE HAS NOT PREVIOUSLY SPOKEN TO THE HOLLYWOOD POLICE DEPT. ABOUT WHAT SHE BELIEVES SHE OBSERVED AT THE SEARS STORE ON THE DATE OF THE ABDUCTION. MS. WARREN STATED THAT SHE ENTERED THE STORE VIA THE WEST MAIN DOORS AND WALKED NORTH TOWARDS THE TOY DEPARTMENT WHERE SHE LEFT HER 8 YEAR OLD GRANDAUGHTER TO PLAY. MS. WARREN STATED SHE OBSERVED WHO SHE BELIEVED TO BE REVE WALSH AND ADAM WALKING FROM THE NORTH (CATALOG) ENTRANCE OF THE STORE. SHE FURTHER STATED THAT SHE OBSERVED SEVERAL JUVENILES PLAYING THE VIDEO GAMES PREVIOUSLY REFERRED TO, AND ADAM WAS LEFT BY REVE TO WAIT HIS TURN TO PLAY. WHEN ASKED TO DESCRIBE REVE WALSH, MS WARREN DID SO ACCURATELY, INCLUDING CLOTHING, PHYSICAL DESCRIPTION, AND HAIRSTYLE.

MS. WARREN STATED SHE OBSERVED REVE WALSH WALKING TOWARDS THE LIGHTING DEPARTMENT AS SHE HERSELF WALKED TO THE BUSINESS OFFICE. WHEN MS. WARREN RETURNED TO THE TOY DEPARTMENT, SHE STATED SHE OBSERVED A W/M SHE BELIEVED TO BE SUSPICIOUS. MS. WARREN DESCRIBED THIS INDIVIDUAL TO BE APPROXIMATELY 5-9 IN HIS 30'S, DIRTY BLONDE HAIR, WEARING KHAKI COLORED SHIRT AND PANTS. MS. WARREN REMEMBERED THAT THIS INDIVIDUAL CONVERSED WITH A W/M EMPLOYEE AT THE CATALOG DEPARTMENT WHOM SHE HAS SEEN EMPLOYED THERE FOR SOME TIME. MS. WARREN STATED THAT THIS PERSON DID MAKE HER FEEL UNEASY AT THE TIME, BUT DID NOT THINK MUCH OF IT AND RETRIEVED HER GRANDAUGHTER AND WALKED INTO THE MALL. APPROXIMATELY 30-40 MINUTES LATER, MS. WARREN STATED SHE HEARD THE PAGE OVER THE INTERCOM FOR A MISSING CHILD.

MS WARREN DESCRIBED THE EMPLOYEE AT THE CATALOG DEPARTMENT AS A W/M, 5-7, MID 30'S, WITH BLACK HAIR AND BLACK RIMMED PRESCRIPTION GLASSES. THIS DETECTIVE CONTACTED SEARS SECURITY AND RECEIVED THE NAMES OF TWO POSSIBLE INDIVIDUALS WHO WORKED THE CATALOG DEPARTMENT DURING THE TIME IN QUESTION WHO FIT THIS GENERAL DESCRIPTION.

ON 11-2-95, THIS DETECTIVE MADE CONTACT WITH ONE OF THESE INDIVIDUALS, GARY SINDELAR OF 703 N. 32 AVE. HOLLYWOOD. MR. SINDELAR WAS POSITIVE THAT HE WAS NOT WORKING AT THE TIME OF THE ABDUCTION ON THE DATE IN QUESTION. LATER THIS SAME DATE, THIS DETECTIVE MADE CONTACT WITH THE OTHER INDIVIDUAL, RONAL NESSMITH OF 6500 LEE ST. HOLLYWOOD. MR. NESSMITH WAS ALSO POSITIVE THAT HE WAS NOT WORKING AT THE TIME ON THE DATE IN QUESTION.

NESSMITH ADDED THAT ANOTHER EMPLOYEE FITTING THIS DESCRIPTION DID WORK AT THE STORE AT THE TIME OF THIS INCIDENT WHO WORKED FULL TIME AND WOULD

HAVE BEEN WORKING AT THE TIME IN QUESTION. MR. NESSMITH STATED THIS PERSON TO BE W/M DENNIS LANCASTER WHOM HE FURTHER DESCRIBED AS FEMININE TYPE AND POSSIBLY HOMOSEXUAL. MR. NESSMITH ADDED THAT LANCASTER WAS ARRESTED DURING HIS TENURE AT SEARS FOR SOME TYPE OF FRAUDULENT REPORT TO POLICE REGARDING A STOLEN VEHICLE.

A GENERAL CRIMINAL HISTORY QUERY OF THIS NAME REVEALED A DENNIS ANTHONY LANCASTER 3-12-47 WAS ARRESTED FOR LEWD AND LASCIVIOUS ACT IN 1972 IN HOLLYWOOD, AS WELL AS A MAKING FALSE REPORT INCIDENT IN POMPANO IN 1978. A CHECK WITH SEARS SECURITY WITH THIS INDIVIDUAL'S SOCIAL SECURITY NUMBER COULD NOT CONFIRM HIS EMPLOYMENT WITH SEARS. FURTHER CRIMINAL HISTORY QUERY REVEALED THAT THIS INDIVIDUAL HAD A CRIMINAL HISTORY IN CALIFORNIA WITH ARRESTS FOR FORGERY IN DECEMBER 1979 AND SOLICITING LEWD ACTS IN JUNE AND AUGUST 1982. LANCASTER WAS ALSO DISCOVERED TO HAVE BEEN ARRESTED IN PHOENIX, ARIZONA IN 1967 FOR LEWD AND LASCIVIOUS ACT AND IN NEW YORK FOR THE SAME OFFENSE IN 1972. ATTEMPTS WILL BE MADE TO LOCATE LANCASTER TO CONFIRM IF HE INFACIT WAS EMPLOYED AT THE SEARS STORE DURING SAID TIME, OR DETERMINE IF HE WAS PRESENT IN THE STORE AT THE TIME OF THE ABDUCTION. THE RESULTS OF THIS WILL BE COVERED IN A FOLLOW-UP SUPPLEMENT REPORT.

DURING THE REVIEW OF THE FILE AND PREVIOUSLY NOTED, THIS DETECTIVE DISCOVERED SEVERAL AREAS WHICH WARRANTED FURTHER REVIEW AND FOLLOW-UP. ONE OF THESE AREAS WAS THE INVESTIGATION OF EDWARD HAROLD JAMES W/M 6-3-31. JAMES HAD BEEN ARRESTED IN NOVEMBER 1981 IN POMPANO BEACH FOR KIDNAPPING A W/F JUVENILE. WHILE INCARCERATED, THIS AGENCY RECEIVED INFORMATION FROM A FELLOW INMATE BY THE NAME OF JOHN TERRY THAT JAMES HAD CONFESSED TO THE ADAM WALSH MURDER. THE SUBSEQUENT FOLLOW-UP OF THIS INFORMATION LED TO INTERVIEWS WITH A NEIGHBOR AND THE SEARCH OF JAMES' VEHICLE. A REVIEW OF F.D.L.E. LAB REPORTS REVEALED THAT NO PHYSICAL EVIDENCE WAS DISCOVERED TO IMPLICATE JAMES. JAMES WAS INTERVIEWED AT THE TIME AND APPARENTLY MADE NO ADMISSIONS, AND IT APPEARED THAT THE INVESTIGATION ENDED AT THAT POINT. A CRIMINAL HISTORY QUERY REVEALED THAT JAMES WAS PAROLLED IN 1994 AND BELIEVED TO BE LIVING IN CLERMONT, FL..

ON 11-8-95 THIS DETECTIVE MADE CONTACT WITH MR. JAMES AT HIS RESIDENCE. MR. JAMES INVITED THIS DETECTIVE INTO HIS RESIDENCE AFTER INTRODUCTION WAS MADE AND HE WAS MADE AWARE OF THE REASON FOR CONTACT. MR. JAMES APPEARED CALM AND CORDIAL AND AGREED TO PROVIDE THIS DETECTIVE WITH A SWORN TAPED STATEMENT. DURING THE APPROXIMATE 1 HOUR PRE-TAPED INTERVIEW, JAMES SPOKE VOLUNTARILY OF HIS ARREST AND INCARCERATION FOR THE 1981 ARREST AND REMEMBERED DETECTIVES FROM HOLLYWOOD SPEAKING WITH HIM. MR. JAMES DENIED ANY INVOLVEMENT IN THE ADAM WALSH ABDUCTION/MURDER, AS WELL AS HIS GUILT IN THE 1981 ARREST. MR. JAMES AGREED TO SUBMIT TO QUESTIONING GEARED FOR COMPUTER VOICE STRESS ANALYSIS AT THE CONCLUSION OF THE TAPED INTERVIEW, AND STATED HE WOULD BE WILLING TO SUBMIT TO A POLYGRAPH EXAMINATION IF NECESSARY.

ALTHOUGH NO DECEPTION WAS NOTED BY THIS DETECTIVE DURING THE ENTIRE INTERVIEW WITH JAMES, THIS DETECTIVE LATER PRESENTED SAID TAPE TO BE ANALYZED BY AGENT ROBERT TIPPETT OF THE ORLANDO OFFICE OF THE F.D.L.E.. AGENT TIPPETT NOTED NO DECEPTION IN JAMES' ANSWERS TO RELEVANT QUESTIONS WHICH INCLUDED WHETHER HE HAD EVER TOLD ANYONE HE HAD KILLED ADAM WALSH. DURING THE INTERVIEW, JAMES RECALLED AN INDIVIDUAL BELIEVED TO BE JOHN TERRY WHO HE DESCRIBED AS A "DRUNK". JAMES ADDED THAT HE HAD A BRIEF CONVERSATION WITH THIS INDIVIDUAL WHILE INCARCERATED WHICH INCLUDED NOTHING TO DO WITH THE ADAM WALSH CASE. THIS DETECTIVE HAD EARLIER ATTEMPTED TO LOCATE JOHN TERRY WHOSE CRIMINAL HISTORY AND DRIVER'S LICENSE QUERY SHOW THAT HE LIVED IN PERRY, FL.. ACCORDING TO PERRY P.D., TERRY DOES NOT HAVE

ANY RECENT CONTACTS AND NO ONE BY THIS NAME RESIDES AT THE REPORTED ADDRESS. NOTED IN THE INITIAL CONTACT WITH TERRY IN 1981 WAS THE FACT THAT HE WAS ADVANCED IN AGE AND SICKLY, AND HE MAY BE DECEASED AT THIS TIME. BASED ON THE RESULTS OF THE INTERVIEW AND C.V.S.A., AS WELL AS NEGATIVE RESULTS OF FORENSIC TESTING IN 1981, THE INVESTIGATION INTO EDWARD JAMES WILL NOT CONTINUE UNLESS NEW INFORMATION IS OBTAINED.

ON 11-9-95 THIS DETECTIVE MADE CONTACT WITH TERRY ALAN GREEN W/M 5-1-54 AT THE MELBOURNE OFFICE OF THE F.D.L.E.. THIS CONTACT WAS ARRANGED TO FOLLOW-UP INFORMATION GREEN PROVIDED THIS DETECTIVE AND PREVIOUSLY NOTED IN THIS DETECTIVE'S INITIAL SUPPLEMENT REPORT. MR. GREEN AGREED TO PROVIDE THIS DETECTIVE WITH A SWORN TAPED STATEMENT REGARDING WHAT HE BELIEVED HE OBSERVED. PREVIOUSLY NOTED IN THE AFOREMENTIONED SUPPLEMENT REPORT REGARDING GREEN, THIS DETECTIVE OPINED THAT GREEN APPEARED SOMEWHAT BIZARRE AND UNSTABLE, AND THIS PERSONAL CONTACT WITH HIM WOULD TEND TO CONFIRM THIS OPINION. REGARDLESS, THIS DETECTIVE PROCEEDED WITH THE TAPED INTERVIEW WHEREIN GREEN STATED THAT HE BELIEVED HE OBSERVED ADAM WALSH IN A MR. DONUT SHOP AT 101 BABCOCK RD. MELBOURNE IN THE EARLY MORNING HOURS DURING THE FIRST WEEK OF AUGUST OF 1981. GREEN WENT ON TO STATE THAT HE SAW THE CHILD ACTING STRANGELY IN THE COMPANY OF A W/M WHO HAD EXITED A NAVY BLUE FULL CONVERSION CUSTOM VAN. GREEN STATED THAT THE CHILD HE BELIEVED TO BE ADAM WALSH ENTERED THE BLUE VAN WITHOUT RESISTANCE AND IT DROVE AWAY FROM THE REAR OF THE DONUT SHOP.

GREEN STATED THAT SEVERAL DAYS LATER HE WAS INFORMED BY THE BAKER AT THE DONUT SHOP, BOB SCHULTZ, THAT HE OBSERVED BLOOD INSIDE AND OUTSIDE THE DUMPSTER IN THE REAR OF THE DONUT SHOP AND SURMISED IT MAY HAVE BEEN HUMAN REMAINS. GREEN INFORMED THIS DETECTIVE THAT THE BLOOD SIGHTING CAN BE CONFIRMED BY THE PREVIOUSLY MENTIONED BAKER, AND AN INDIVIDUAL NAMED JOHN BELCHER WHO IS CURRENTLY EMPLOYED BY THE MELBOURNE FIRE DEPARTMENT.

GREEN WENT ON TO STATE THAT AN INDIVIDUAL WHO WORKED FOR THE SANITATION COMPANY AT THE TIME BY THE NAME OF DON SLACK ALSO COULD CONFIRM THIS OBSERVATION AND ADDED THAT SLACK DUMPED THIS PARTICULAR LOAD AS A PRANK BEHIND THE TRAILER OF AN INDIVIDUAL BY THE NAME OF L.B.MABE WHO RESIDED ON THE PROPERTY OF THE BREVARD COUNTY LANDFILL ON SARNO RD. IN MELBOURNE.

DURING THE INTERVIEW WITH GREEN, IT WAS APPARENT THAT HE IS SOMEWHAT OBSESSED WITH THIS CASE, WHETHER ACTUALLY BELIEVING WHAT HE OBSERVED TO BE TRUE, OR FOR OTHER UNDETERMINED REASONS. DURING THE QUESTIONING, GREEN STATED THAT HE BELIEVED THE W/M WHO WAS IN THE COMPANY OF THE CHILD AT A TRAILER PARK WHERE THERE WERE PERSONS THAT OWNED A WHITE CADILLAC. AFTER THIS STATEMENT BY GREEN, HE WAS ASKED IF HE HAD READ ANY NEWSPAPERS OR PERIODICALS ABOUT THIS CASE. GREEN RESPONDED THAT HE HAD READ AT ONE TIME SOMETHING ABOUT A WHITE CADILLAC IN REFERENCE TO THIS CASE. GREEN FURTHER ADDED THAT HE LATER SAW A PICTURE OF OTTIS TOOLE IN THE NEWSPAPERS AND BELIEVED HIM TO BE THE W/M IN THE COMPANY OF THE CHILD AT THE DONUT SHOP.

AT THE CONCLUSION OF THIS STATEMENT, THIS DETECTIVE MADE CONTACT WITH BOB SCHULTZ AT HIS RESIDENCE IN MELBOURNE. SCHULTZ STATED THAT HE WORKED AS A BAKER AT THE DONUT SHOP IN QUESTION FROM 1976-1992. SCHULTZ HAD A VAGUE RECOLLECTION OF THE BLOOD ON THE DUMPSTER AT THE APPROXIMATE TIME THAT GREEN HAD MENTIONED, AND REMEMBERED NOT GIVING IT TOO MUCH THOUGHT AS IT WAS BELIEVED TO HAVE BEEN FROM AN ANIMAL CARCAS.

THIS DETECTIVE MADE CONTACT WITH JOHN BELCHER WHO IS CURRENTLY EMPLOYED AS A FIRE INSPECTOR WITH THE MELBOURNE FIRE DEPARTMENT. MR BELCHER STATED THAT HE WAS SHOWN THE BLOODY DUMPSTER BY GREEN WHEN HE WAS EMPLOYED WITH THE MELBOURNE POLICE DEPARTMENT WHILE ON A BREAK AT THE DONUT SHOP. MR

BELCHER SEEMED TO RECALL THAT THIS OCCURRED SOME TIME DURING THE WINTER MONTHS AND NOT THE SUMMER MONTHS, AS HE RECALLED WEARING A JACKET AT THE TIME. MR. BELCHER RECALLS NOTIFYING A LT. MCDIVIT (PHONETIC) OF THE MELBOURNE P.D. OF HIS OBSERVATIONS AND DOES NOT KNOW WHAT TRANSPIRED AFTER THAT. MR. BELCHER ALSO STATED THAT IT WAS BELIEVED THAT THE BLOOD WAS THE RESULT OF A DISCARDED CARCAS SUCH AS A DEER, WHICH WOULD NOT HAVE BEEN AN UNCOMMON PRACTICE BY THE RESIDENTS IN THE GENERAL AREA OF THE DONUT SHOP AT THAT TIME.

BASED ON GREEN'S ABOVE COMMENTS, IT WAS DECIDED THAT A POLYGRAPH EXAMINATION WOULD BE CONDUCTED TO DECIPHER WHAT GREEN MIGHT HAVE ACTUALLY OBSERVED, OR ONLY READ IN THE NEWSPAPERS. GREEN AGREED TO SUBMIT TO THE EXAMINATION WHICH WAS SCHEDULED FOR A LATER DATE AND WILL BE COVERED LATER IN THIS SUPPLEMENT REPORT.

THIS DETECTIVE MADE CONTACT WITH NATHANIEL KNIGHT WHO IS A SUPERVISOR AT THE BREVARD COUNTY LANDFILL. MR. KNIGHT WAS INFORMED OF THE STATEMENT MADE BY GREEN AND STATED HE WAS FAMILIAR WITH THE AREA THAT L.B.MABE, WHO NO LONGER LIVED THERE, HAD HIS TRAILER. MR. KNIGHT SHOWED THIS DETECTIVE THE AREA IN QUESTION WHICH HAS SINCE BEEN COVERED BY DIRT AND FILL AT LEAST TEN FEET DEEP AND 100 YARDS LONG AND WIDE.

THIS DETECTIVE LATER MADE CONTACT WITH L.B.MABE AT HIS RESIDENCE IN YULLEE, FL.. MABE STATED THAT HE WAS CONTACTED BY GREEN SEVERAL WEEKS PREVIOUS ABOUT THIS SUPPOSED INCIDENT WHICH HE HAD NO KNOWLEDGE OF. MABE STATED THAT HE BELIEVES HE WOULD HAVE REMEMBERED IF A LOAD OF WASTE HAD BEEN DUMPED BEHIND HIS TRAILER AND BELIEVED THAT IT DID NOT OCCUR. MABE ALSO STATED THAT HE DID NOT KNOW THE NAME OF DON SLACK, THE SUPPOSED FRONT LOAD TRUCK OPERATOR FOR THE SANITATION COMPANY. THIS DETECTIVE MADE PHONE CONTACT WITH HARRIS SANITATION WHO SHOWED NO RECORD OF A DON SLACK WORKING THE MELBOURNE AREA AT ANY TIME.

ON 11-10-95, THIS DETECTIVE RESPONDED TO THE OKEECHOBEE COUNTY SHERIFF'S OFFICE. AS NOTED IN A PREVIOUS SUPPLEMENT REPORT, AN ANONYMOUS CALLER INFERRED THAT AN INDIVIDUAL BY THE NAME OF JOHN ALDEN CONFESSED TO THE MURDER OF ADAM WALSH AND TO PLACING THE REMAINS IN AN OIL DRUM AND BURYING IT OFF OF S.R.70. ACCORDING TO THE CALLER, ALDEN WAS A NEIGHBOR AND HE (CALLER) WAS AN EX-POLICE OFFICER. DET T.J.BROCK OF THE OKEECHOBEE COUNTY SHERIFF'S OFFICE RESEARCHED THIS INFORMATION AND DETERMINED THE CALLER TO POSSIBLY BE A KENNETH BOSCH 5-6-39 OF 6140 S.E. 97 TRAIL OKEECHOBEE WHO IS AN EX-POLICE OFFICER WITH RIVIERA BCH., FL.. ACCORDING TO DET. BROCK, DET. SUTTLE HAS BEEN CONDUCTING AN INVESTIGATION INVOLVING BOSCH AND HIS NEIGHBOR MERTON ALDEN OF 6080 S.E.97 TRAIL.

IN SEPT. 1995, BOSCH AUTHORED A LETTER TO THE OKEECHOBEE COUNTY SHERIFF'S OFFICE WHEREIN HE STATED ALDEN BURGLARIZED HIS HOUSE. THIS DETECTIVE REVIEWED THIS LETTER, AS WELL AS THE SUBSEQUENT INVESTIGATION AND DEEMED BOSCH A RATHER BIZARRE INDIVIDUAL. AT THIS TIME, THE ALLEGATIONS MADE BY BOSCH ABOUT THE BURGLARY INCIDENT APPEAR TO BE WITHOUT MERIT. ON THE SURFACE, IT APPEARS THAT BOSCH MAY HAVE SOME TYPE OF GRUDGE AGAINST ALDEN FOR UNDETERMINED REASONS, AND A DECISION WAS MADE TO NOT FOLLOW-UP THIS LEAD AT THIS TIME UNTIL THE OKEECHOBEE COUNTY SHERIFF'S OFFICE CONCLUDES THEIR INVESTIGATION. AT THAT POINT IN TIME, THIS INFORMATION WILL BE EVALUATED AND A DETERMINATION WILL BE MADE WHETHER TO CONDUCT A FOLLOW-UP INVESTIGATION.

ON 11-13-95, THIS DETECTIVE MADE PHONE CONTACT WITH A JOANNA BRAUN WHO WAS PREVIOUSLY REFERRED TO AS AN EMPLOYEE AT THE SEARS CATALOG DEPARTMENT ON THE DATE AND TIME OF THIS INCIDENT. MS. BRAUN INFORMED THIS DETECTIVE THAT HER RECOLLECTION OF THE EVENTS ON THAT DATE ARE FAIRLY CLEAR AND

RECALLED BEING INTERVIEWED BY DETECTIVES. IN THE INTERVIEW WITH THIS DETECTIVE, MS BRAUN STATED SHE BELIEVED SHE WORKED THE 10:00AM TO 2:00PM SHIFT THAT DATE AND RECALLED SEEING REVE WALSH AND A CHILD ENTER THE STORE VIA THE CATALOG ENTRANCE A SHORT TIME BEFORE HER BREAK, POSSIBLY IN THE AREA OF 12:30PM. DURING THIS INTERVIEW, AS WELL AS THE PREVIOUS INTERVIEW WITH DETECTIVES AT THAT TIME, MS. BRAUN COULD NOT BE CERTAIN THAT THE CHILD WAS ADAM WALSH BUT DID BELIEVE IT TO BE THE SAME AGE. MS BRAUN ACCURATELY DESCRIBED REVE WALSH'S ATTIRE AND RECALLED SEVERAL OF THE MALE CATALOG EMPLOYEES, INCLUDING JOHN KING WHO WAS PREVIOUSLY REFERRED TO IN THIS DETECTIVE'S SUPPLEMENT REPORTS, MAKING COMMENTS ABOUT HER PHYSIQUE AND CLOTHING. THIS WOULD SEEM TO SOLIDIFY KING'S STATEMENT ABOUT HIS OBSERVATIONS.

MS. BRAUN DID REMEMBER THAT DENNIS LANCASTER, WHO WAS PREVIOUSLY REFERRED TO, WAS EMPLOYED AT THE SEARS STORE AT THE PACKAGE PICKUP BUT WAS NOT CERTAIN THAT HE WAS EMPLOYED ON THE DATE IN QUESTION. MS. BRAUN ADDED THAT A W/M NAMED ALAN NOTKIN (PHONETIC) ALSO FIT THE PHYSICAL DESCRIPTION OF THE INDIVIDUAL DESCRIBED BY JENNIE WARREN. AS OF THIS SUPPLEMENT REPORT, NOTKIN HAS NOT BEEN FURTHER IDENTIFIED OR CONTACTED AND ATTEMPTS WILL BE MADE TO DO SO AND ADDRESSED IN A FOLLOW-UP SUPPLEMENT REPORT.

ON 12-6-95, THIS DETECTIVE RESPONDED TO THE CITY OF JACKSONVILLE SHERIFF'S DEPARTMENT. THE PURPOSE OF THIS RESPONSE WAS TO CONDUCT AN INVESTIGATION INTO LARRY LEON WALDO W/M 7-27-56 AND TO RE-INTERVIEW A CHARLES HARDMAN B/M 3-29-63 AND JOHN WAYNE REDWINE W/M 3-22-67. ALL THREE HAD PREVIOUSLY BEEN INTERVIEWED DURING THE INITIAL INVESTIGATION OF OTTIS TOOLE IN 1983. DURING THIS RE-INVESTIGATION, THIS DETECTIVE DEEMED THESE INDIVIDUALS AS THREE OF SEVERAL PERSONS OF INTEREST TO BE RE-INTERVIEWED.

IN 1983, WALDO PROVIDED A STATEMENT TO DETECTIVES REGARDING HIS ASSOCIATION WITH OTTIS TOOLE IN JACKSONVILLE, WHICH WAS DETERMINED TO HAVE OCCURRED IN NOVEMBER OF 1981, APPROXIMATELY 4 MONTHS AFTER THE ABDUCTION/MURDER. WALDO STATED THAT HE MET TOOLE AFTER HE WAS DISCHARGED FROM A MENTAL HOSPITAL IN JACKSONVILLE AND MOVED INTO THE SAME ROOMING HOUSE AS TOOLE. AT THE TIME WALDO PROVIDED DETECTIVES WITH A STATEMENT, HE WAS AT A RESIDENCE LOCATED AT 1608 N. 27 AVE. HOLLYWOOD. THIS RESIDENCE IS APPROXIMATELY 1 BLOCK EAST AND 2 BLOCKS NORTH OF THE WALSH RESIDENCE AT THE TIME OF THE ABDUCTION/MURDER. IT IS APPARENT THAT THE QUESTIONING OF WALDO DEALT WITH HIS ASSOCIATION WITH TOOLE AND NOT WHETHER HE KNEW OR WAS FAMILIAR WITH THE WALSH FAMILY.

A CRIMINAL HISTORY QUERY REVEALED A MISDEMEANOR RECORD OF ALCOHOL RELATED INCIDENTS BEGINNING IN JUNE OF 1982 IN ST. JOHNS COUNTY AND ENDING IN FEB. 1985 IN DUVAL COUNTY. IN THE 1985 ARREST, WALDO LISTS THAT HE IS EMPLOYED AS A PRIVATE INVESTIGATOR FOR A CHUCK ST. JOHN IN HOLLYWOOD AND THAT HE WAS IN JACKSONVILLE FOR 3 MONTHS.

THIS DETECTIVE RESPONDED TO THE JACKSONVILLE SHERIFF'S OFFICE ON 12-6-95 IN HOPES OF LOCATING WALDO TO INTERVIEW HIM REGARDING HIS ASSOCIATION WITH TOOLE, AS WELL AS HIS PRESENCE IN HOLLYWOOD, MORE SPECIFICALLY 1608 N 27 AVE.. THIS QUERY AT THE JACKSONVILLE SHERIFF'S OFFICE REVEALED THAT WALDO HAS BEEN DECEASED SINCE 1990, CAUSE UNKNOWN. IN HIS 1983 STATEMENT, WALDO STATED THAT HIS MOTHER LIVED AT 2130 ADAMS ST. HOLLYWOOD. ATTEMPTS WILL BE MADE TO LOCATE AND INTERVIEW HER, AS WELL AS THE INDIVIDUAL NAMED CHUCK ST. JOHN, AND THE RESULTS WILL BE COVERED IN A FOLLOW-UP SUPPLEMENT REPORT.

JOHN REDWINE WAS LOCATED AT THE DUVAL COUNTY JAIL WHERE HE WAS INTERVIEWED. REDWINE HAD PROVIDED DETECTIVES WITH A STATEMENT IN 1983 WITHOUT ANY PERTINENT INFORMATION. THIS RE-INTERVIEW ON THIS DATE HAD THE

SAME RESULTS.

LATER ON THIS DATE, THIS DETECTIVE MADE CONTACT WITH CHARLES HARDMAN AT HIS RESIDENCE IN JACKSONVILLE. HARDMAN WAS LOCATED AND INTERVIEWED IN 1983 REGARDING THE INVESTIGATION OF OTTIS TOOLE. HARDMAN INFORMED DETECTIVES THAT HE LOANED TOOLE A BAYONETTE DURING A TIME PRIOR TO THE ABDUCTION/MURDER AND IT WAS NEVER RETURNED. IN 1988, BROWARD SHERIFF'S OFFICE DETECTIVES FANTIGRASSI AND SCHEFF RETRIEVED A BAYONETTE AND METALLIC SHEATH FROM THE RESIDENCE OF VINETTE SYPHURS, TOOLE'S SISTER. IN 1988, BOTH DETECTIVES INTERVIEWED TOOLE REGARDING THIS CASE, AND AS A RESULT, RESPONDED TO SYPHURS'S RESIDENCE TO RETRIEVE THE "MURDER WEAPON". AT THE TIME, SYPHURS GAVE SAID BAYONETTE TO THE DETECTIVES STATING THAT SHE HAS HAD IT FOR QUITE SOME TIME AND IT WAS A COLLECTOR'S ITEM. THIS BAYONETTE WAS BELIEVED TO BE THE SAME BAYONETTE DELIVERED TO AND STORED AT THE BROWARD MEDICAL EXAMINER'S OFFICE, ACCORDING TO CHIEF INVESTIGATOR D.P. HUGHES OF THE MEDICAL EXAMINER'S OFFICE, THIS BAYONETTE WAS DEEMED TO BE THE CLOSEST INSTRUMENT TO THE MURDER WEAPON THAN ANY EXAMINED TO THAT POINT.

ALTHOUGH HARDMAN PROVIDED DETECTIVES WITH THE AFOREMENTIONED INFORMATION IN 1983, IT DID NOT APPEAR THAT THIS BAYONETTE WAS LATER DISCUSSED WITH OR SHOWN TO HIM. ON THIS DATE, THIS DETECTIVE MET WITH HARDMAN AT HIS RESIDENCE IN JACKSONVILLE. HARDMAN RECALLED THE 1983 CONTACT, AS WELL AS THE SUBJECT OF THE INTERVIEW. HARDMAN DESCRIBED THE BAYONETTE AND SHEATH HE WAS REFERRING TO ACCURATELY PRIOR TO POLAROID PHOTOGRAPHS OF IT BEING SHOWN TO HIM. AFTER BEING SHOWN THE PHOTOGRAPHS, HARDMAN BELIEVED IT TO BE THE SAME BAYONETTE AND SHEATH HE HAD LOANED TO TOOLE. HARDMAN RECALLED THAT TOOLE STATED HE LEFT THE BAYONETTE IN QUESTION ON HIS FRONT PORCH AND SOMEONE STOLE IT WHEN ASKED AT THE TIME TO EXPLAIN WHAT HAPPENED TO IT. BECAUSE THIS INSTRUMENT IS NOT UNIQUE, AND HARDMAN DOES NOT KNOW OF ANY UNIQUE IDENTIFYING FEATURES ABOUT IT, IT IS UNKNOWN IF IN FACT THIS IS THE SAME BAYONETTE AND SHEATH HE REFERRED TO. FOR THE ABOVE REASONS, THIS DETECTIVE WILL ATTEMPT TO LOCATE VINETTE SYPHURS FOR RE-INTERVIEW AND GAUGE HER TRUTHFULNESS AND SINCERITY REGARDING HER PREVIOUS STATEMENT. THE RESULTS OF THIS ATTEMPT WILL BE COVERED IN A FOLLOW-UP SUPPLEMENT REPORT.

EARLIER ON THIS SAME DATE, THIS DETECTIVE RESPONDED TO THE FLORIDA STATE PRISON FOR THE PURPOSE OF A RE-INTERVIEW WITH OTTIS TOOLE. CONTACT WAS MADE WITH INVESTIGATOR STEVE ARNOLD OF THE STATE PRISON FOR THE PURPOSE OF THIS INTERVIEW. IT WAS DECIDED THAT INVESTIGATOR ARNOLD WOULD CONDUCT THIS INTERVIEW WITH TOOLE WHILE THIS DETECTIVE REMAINED IN AN ADJACENT OFFICE. DURING THE INTERVIEW, TOOLE REMAINED WITH HIS PREVIOUS STATEMENT TO THIS DETECTIVE IN JUNE 1975 REGARDING NO INVOLVEMENT. PLANS WILL BE MADE AT A LATER DATE TO RE-INTERVIEW TOOLE PERSONALLY AND WILL BE ADDRESSED IN A FOLLOW-UP SUPPLEMENT REPORT.

ON 12-7-95, THIS DETECTIVE RESPONDED TO THE CITY OF FRUITLAND PARK, FL.. THE PURPOSE OF THIS RESPONSE WAS TO CONDUCT AN INVESTIGATION INTO KENNETH ADRIAN LECLAIR. LECLAIR WAS MENTIONED IN THIS DETECTIVE'S PREVIOUS SUPPLEMENT REPORT AS A SUSPECT IN A SIMILAR TYPE CASE IN BOARDMAN, OHIO IN THE EARLY 1970'S AND LATER TRACKED TO FLORIDA. A DRIVER'S LICENSE QUERY REVEALED A CURRENT LICENSE FOR LECLAIR, LISTING A RESIDENT ADDRESS OF 802 MAPLE AVE. FRUITLAND PARK. A LOCAL RECORDS CHECK WITH FRUITLAND PARK P.D. COULD NOT LOCATE ANY POLICE CONTACT WITH LECLAIR OR LIST HIM AS A RESIDENT IN THEIR CITY.

ON THIS DATE AT APPROXIMATELY 1:00P.M., THIS DETECTIVE RESPONDED TO THE MAPLE AVE. RESIDENCE WHERE THERE WAS NO RESPONSE AND NO RESPONSE FROM

EITHER NEIGHBOR. CONTACT WILL BE ATTEMPTED AGAIN AT A LATER DATE AND ADDRESSED IN A FOLLOW-UP SUPPLEMENT REPORT.

ON 12-8-95, TERRY GREEN MET WITH THIS DETECTIVE AT THE MELBOURNE PD FOR THE PURPOSE OF SUBMITTING TO THE POLYGRAPH EXAMINATION TO BE CONDUCTED BY DETECTIVE JOHN LAWSON. DETECTIVE LAWSON CONDUCTED A 45 MINUTE PRE-TEST INTERVIEW WITH GREEN AFTERWHICH HE INFORMED THIS DETECTIVE OF HIS FINDINGS. IN DETECTIVE LAWSON'S OPINION, WHICH THIS DETECTIVE CONCURRED WITH, GREEN'S STATE OF MIND REGARDING THIS CASE IS THAT WHICH WOULD NOT GIVE A CONCLUSIVE RESULT TO ANY POLYGRAPH EXAMINATION CONDUCTED. BASED ON THIS OPINION, GREEN'S OBSERVATIONS WILL NOT BE IGNORED, BUT INSTEAD WILL BE EVALUATED IN RELATION TO FACTS ALREADY KNOWN TO HAVE BEEN PUBLISHED IN THE MEDIA.

DURING THIS PART OF THE INVESTIGATION, THIS DETECTIVE RESEARCHED THE LOCAL NEWSPAPERS STORED ON MICROFILM IN THE INDIAN RIVER, ST. LUCIE, BREVARD, AND OKEECHOBEE COUNTY LIBRARIES FROM 7-27-81 THROUGH THE MONTH OF SEPTEMBER 1981. THIS INQUIRY WAS DONE IN HOPES OF LOCATING ANY INFORMATION WHICH MAY NOT HAVE BEEN CONSIDERED AT THE TIME TO BE OF VALUE IN ESTABLISHING A CONNECTION WITH THIS PART OF THE STATE AND THAT OF THE HOLLYWOOD AREA. DURING THIS INQUIRY, SEVERAL INCIDENTS WERE DOCUMENTED WITH NONE SHOWING AN OBVIOUS CONNECTION. THESE INCIDENTS WILL BE EVALUATED AS THE INVESTIGATION CONTINUES.

DURING THE REVIEW OF THIS CASE FILE, THIS DETECTIVE SPENT A CONSIDERABLE AMOUNT OF TIME REVIEWING THE HUNDREDS OF LEADS PRESENTED TO DETECTIVES DURING THE INITIAL STAGES OF THIS INVESTIGATION. AS STATED PREVIOUSLY, THERE WERE SEVERAL AREAS OF THIS INVESTIGATION WHICH NEEDED TO BE FURTHER INVESTIGATED AND/OR CLARIFIED. THE FOLLOWING WILL BE SEVERAL OF THESE AREAS BUT ARE NOT LIMITED TO.

ON 7-31-81, GREG IRIZARRY AND ANGELO ACCETTURO, WHO ARE LISTED AS WITNESSES IN THE ORIGINAL INCIDENT REPORT, CONTACTED HEADQUARTERS TO ADVISE THAT A SUBJECT AND VEHICLE (GREEN VAN) THEY HAD SEEN AT THE SEARS STORE AT THE TIME OF THE ABDUCTION WAS CURRENTLY NEAR THE CONCA D'ORO RESTAURANT NEAR YOUNG CIRCLE IN HOLLYWOOD. THIS CONTACT ALSO STATED THAT SOME PROPERTY WAS BEING TAKEN FROM THE VAN AND PLACED INTO A STATIONWAGON. THIS TIP WAS INVESTIGATED SHOWING THAT 3 W/M'S IN THE STATIONWAGON WERE CONTACTED AND INTERVIEWED BY DETECTIVES AND THE VEHICLE SEARCHED. BASED ON THIS INTERVIEW AND SEARCH, THESE INDIVIDUALS WERE ELIMINATED AS SUSPECTS. WHAT WAS NOT CLEAR IS WHETHER THE SUBJECT IN THE VAN HAD BEEN IDENTIFIED OR THE VEHICLE LOCATED. WHEN IRIZARRY CONTACTED HEADQUARTERS HE PROVIDED A LICENSE TAG NUMBER WHICH IS BELIEVED TO BE THAT OF THE GREEN VAN. THIS DETECTIVE WILL CONTACT DHSMV IN TALLAHASSEE IN REFERENCE TO THIS LICENSE TAG NUMBER, AS WELL AS ANY OTHER LICENSE TAG NUMBER OR VEHICLE WHICH IS NOT SUFFICIENTLY DOCUMENTED AND INVESTIGATED.

ON 11-14-95, THIS DETECTIVE CONTACTED IRIZARRY AT HIS RESIDENCE IN HOLLYWOOD. IRIZARRY RECALLED HIS OBSERVATIONS AT THE SEARS STORE BUT DID NOT RECALL HIS OBSERVATIONS AND ACTIONS AT THE CONCA D'ORO DUE TO THE LENGTH OF TIME SINCE THE INCIDENT. REGARDING HIS OBSERVATIONS AT SEARS, IRIZARRY STATED THAT ACCETTURO, MIKE AND SCOTT CROFT, AND HE WERE AT THE SEARS STORE NEAR THE VIDEO GAMES. IRIZARRY RECALLED AT THIS TIME THAT A YOUNG W/M HE BELIEVED TO BE ADAM WALSH WAS ALSO NEAR THIS SAME AREA. IRIZARRY STATED THAT HE RECALLED AT THE TIME SEEING A W/M HE DESCRIBED AS A "GRUNGY TYPE" INSIDE THE STORE, AND OBSERVED THIS SAME W/M IN A GREEN VAN WITH SOME TYPE OF MURAL PAINTED ON ITS EXTERIOR. IRIZARRY RECALLED THIS VEHICLE BEING PARKED OUTSIDE THE GARDEN SHOP ENTRANCE. AS STATED ABOVE, THE LICENSE TAG NUMBER WILL BE RESEARCHED VIA DHSMV AND THE RESULTS WILL BE DISCUSSED IN A FOLLOW-UP SUPPLEMENT REPORT.

IN THE INITIAL INVESTIGATION, A SUBJECT BY THE NAME OF FREDRICK CHEEK PROVIDED DETECTIVES WITH A STATEMENT REGARDING KNOWLEDGE OF THIS CASE. CHEEK INFORMED DETECTIVES THAT AN INDIVIDUAL BY THE NAME OF KIETH ALAN WARREN CONFESSED TO KILLING ADAM WALSH. THE INVESTIGATION INTO WARREN, W/M 7-15-58 REVEALED THAT HE WAS IN CUSTODY IN NEVADA FOR ATTEMPTED MURDER AND SEXUAL BATTERY OF A 15 YEAR OLD W/M AT THE TIME THIS LEAD WAS RECEIVED. WARREN WAS CONFIRMED TO HAVE BEEN IN TAMPA, FL. IN MARCH OF 1981 AND THAT HE POSSESSED A GREEN 1968-70 GREEN VAN AND STAYED AT THE MIAMI SALVATION ARMY IN MIAMI AT OR NEAR THE SAME TIME. THE SUBSEQUENT FOLLOW-UP INVESTIGATION FAILED TO IMPLICATE WARREN AT THE TIME AND IT WAS NOT CLEAR WHETHER THE VAN HE DROVE AT THE TIME WAS ELIMINATED AS BEING IN THE AREA OF THE SEARS STORE AT THE TIME OF THIS OFFENSE. AS STATED ABOVE, THIS WILL BE ADDRESSED WHEN THE RESULTS OF THE DHSMV QUERY IS COMPLETED.

ON 8-15-81, THIS AGENCY WAS CONTACTED REGARDING INFORMATION PROVIDED BY A MICHAEL PATRICK KELLY W/M 1-6-56. KELLY INFORMED INVESTIGATORS THAT AN INDIVIDUAL BY THE NAME OF KIM MORAN WAS RESPONSIBLE FOR THE DEATH OF ADAM WALSH. IT IS NOT CLEAR WHETHER MORAN, A/K/A DONALD WILLIAM MORAN W/M 8-3-56, WAS EVER CONTACTED OR SERIOUSLY INVESTIGATED. THIS DETECTIVE WILL DETERMINE WHETHER TO CONDUCT FURTHER INVESTIGATION INTO MORAN AND WILL BE ADDRESSED IN A FOLLOW-UP SUPPLEMENT REPORT.

A HANDWRITTEN LETTER AUTHORED BY A DEBORAH CASCIO WAS RECEIVED BY THIS AGENCY DURING THE INITIAL STAGES OF THIS INVESTIGATION. MS. CASCIO STATED THAT SHE BELIEVED HER EX-HUSBAND RICHARD CASCIO MAY BE RESPONSIBLE FOR THE MURDER OF ADAM WALSH. MS. CASCIO STATED IN HER LETTER THAT HER EX-HUSBAND WAS A TEQUESTA, FL. POLICE OFFICER WHOM SHE SUSPECTED TO HAVE SEXUALLY ASSAULTED HER DAUGHTER. MS. CASCIO STATED THAT HER EX-HUSBAND DROVE A BLUE VAN WHICH HE SUSPICIOUSLY TRIED TO CONCEAL AFTER PUBLICITY ABOUT A BLUE VAN POSSIBLY BEING INVOLVED IN THIS CASE SURFACED. TO ADD FURTHER SUSPICION, MS. CASCIO STATED THAT HER EX-HUSBAND HAS BEEN IN HOLLYWOOD SOME TIME PRIOR TO THE ABDUCTION TO PURCHASE POLICE EQUIPMENT WHICH SHE BELIEVED TO BE STRANGE DUE TO THE DISTANCE BETWEEN TEQUESTA AND HOLLYWOOD WITH OTHER POLICE SUPPLY STORES MUCH CLOSER. ACCORDING TO THE FILE, IT IS NOT CLEAR WHAT FOLLOW-UP INVESTIGATION HAD BEEN DONE REGARDING THIS INFORMATION. MS. CASCIO IS BELIEVED TO BE LIVING IN THE STATE OF WASHINGTON AND ATTEMPTS WILL BE MADE TO CONTACT HER FOR INTERVIEW. THE RESULTS WILL BE DISCUSSED IN A FOLLOW-UP SUPPLEMENT REPORT.

DURING THE REVIEW, THIS DETECTIVE LOCATED THE F.H.P. RADIO LOGS RECEIVED DURING THE INITIAL STAGES OF THIS INVESTIGATION. THESE RADIO LOGS COVERED THE CENTRAL FLORIDA AREA OF THE FLORIDA TURNPIKE FROM JULY 28, 1981 THROUGH JULY 31, 1981, AND THEN AUGUST 8, 1981. FOR UNKNOWN REASONS, THE FILE DID NOT INCLUDE THE RADIO LOG FOR JULY 27, 1981. AFTER THIS REVIEW, SEVERAL INCIDENTS, FIELD CONTACTS, AND TRAFFIC STOPS WERE NOTED FOR FURTHER CLARIFICATION AND/OR INVESTIGATION AND WILL BE ADDRESSED IN A FOLLOW-UP SUPPLEMENT REPORT.

ON 1-4-96, MICHAEL MONAHAN RESPONDED TO HEADQUARTERS AT THIS DETECTIVE'S REQUEST. MONAHAN HAD EARLIER BEEN REFERRED TO IN A PREVIOUS SUPPLEMENT REPORT REGARDING THE MEDIA GENERATED FURDOR OF MONAHAN'S SUSPECTED INVOLVEMENT IN THIS CASE. MONAHAN HAD EARLIER VOLUNTEERED TO SUBMIT TO A POLYGRAPH EXAMINATION IF REQUESTED, WHICH WAS REQUESTED EVEN THOUGH THERE WAS NO SIGN OF DECEPTION DURING HIS INITIAL INTERVIEW WITH THIS DETECTIVE. THE RESULTS OF THIS EXAMINATION PERFORMED BY DET. NAVARRO OF THE HOLLYWOOD POLICE DEPARTMENT WERE NON-DECEPTION SHOWN BY MONAHAN ON QUESTIONS PERTAINING TO HIS INVOLVEMENT IN THIS CASE. DET. NAVARRO WILL GENERATE A SUPPLEMENT REPORT REGARDING THIS EXAMINATION AND WILL ALSO HAVE

THE CHART REVIEWED BY ANOTHER INDEPENDENT POLYGRAPHER.

ON 12-28-95, THIS DETECTIVE MADE PHONE CONTACT WITH JAMES GEISENBERG, A RETIRED JACKSONVILLE SHERIFF'S OFFICE DETECTIVE. MR. GEISENBERG ASSISTED DETECTIVE J.W.TERRY OF THE JACKSONVILLE SHERIFF'S OFFICE IN THE INITIAL STAGES OF THE OTTIS TOOLE INVESTIGATION. GEISENBERG WAS QUESTIONED REGARDING HIS RECOLLECTION OF EVENTS REGARDING THE CARPET CUTTINGS FROM THE 1971 CADILLAC PREVIOUSLY REFERRED TO. GEISENBERG HAD NO RECOLLECTION ABOUT THE CURRENT LOCATION OF SAID CUTTINGS, AND DID NOT RECALL EVER TAKING CUSTODY OF THEM.

THE INVESTIGATION OF OTHER INFORMATION AND LEADS NOT DISCUSSED IN THIS SUPPLEMENT REPORT, AS WELL AS THE RESULTS OF THE CONTINUING INVESTIGATION INTO THE STACY WYTRVA HOMICIDE, WILL BE DISCUSSED IN A FOLLOW-UP SUPPLEMENT REPORT.
