Suspect's murder confessions start unraveling

Henry Lee Lucas tells people he is "a terrible, terrible murderer, worse than anyone in the history of the world. But now it is beginning to look as if Henry Lee is a better liar than a killer."

If the suspicions of a few disenchanted detectives are true, Henry Lee Lucas may not be the most prolific murderer in American history, but of bullock, one of America's most imaginative con artists.

In every instance, it appears, his beginning to wonder about the

victims were seasoned police investigators.

"Henry Lee walked in here and said he did a dozen or more killings," said Lt. Jim Suber, Jacksonville police Lt. Jim Suber said. "We listened to him, we walked him around, we even took him right to the spot where he said he did one of these murders. He didn't recognize just a no-account drifter with a bad glass eye. Then a Texas sheriff picked him up for killing an 80-year-old woman. There's little doubt about that one. Detectives found her burned

"In my opinion, it was all a bunch of bullcrap," Police in other places weren't so discriminating. And some are now beginning to wonder about the

terrible, terrible murderer.

New questions have recently popped up about two Dade County murders. Lucas confessed to Grand Juries in Texas and Louisiana want to know if Lucas conned police into accepting hundreds of other confessions of mayhem.


Three years ago, Henry Lucas was just a no-account drifter with a bad glass eye. Then a Texas sheriff picked him up for killing an 80-year-old woman. There's little doubt about that one. Detectives found her burned

where Lucas lived.

In a courtroom, a judge lecture Lucas. Murder is a very serious charge, he said. Lucas agreed. And suddenly right there in the courtroom, Henry Lucas began confessing to murders all over the place dozens of them. The word got out.

Detectives from everywhere have made reservations to see Henry Lee in his Texas jail cell. Before he was done, more than a thousand

policemen from 40 states, the District of Columbia and Canada came to chat.

Lucas obliged more than 600 policemen with signed or video-taped confessions. At last count, the cops had charged him with 210 murders.

The confessions are full of wondrous detail. Lucas knew things "only the killer could know."

Lucas said he and a half-wit pyromaniac named Ottis Toole, his homosexual lover, killed people wherever they found them. They were pretty creative.

They ran people down with cars, hanged them in trees, burned them and shot them, they said. "I filleted some of them like fish . . ." Lucas said. "We killed them every way but poisoning. That was just too bad."

Everyone says Toole and Lucas are indeed killers. But did they kill hundreds, as many police contend?

"There's a real question," said Jamie McLaughlin, supervisor of an investigation by the Florida Department of Law Enforcement.

In a pig's eye'

Said Jim Suber, the Jacksonville policeman: "In a pig's eye."

Ottis Toole and Henry Lucas aren't your everyday killers. Toole is a firebug with an IQ of .75 and a strong attachment to his mother. He once said he killed Adam Walsh, the young Hollywood boy. He recanted, confessed, then recanted again. Prosecutors never charged him.

Lucas was an itinerant one-eyed handyman before he took up with Toole in 1978. They met in a mission soup line in Jacksonville and worked together as house roofers. Lucas stole cars, drank beer, sold junk and traveled. Like Toole, he said he was really fond of his mother.

When he was 23, a quarter of a century ago, he stabbed her to death with a penknife. He did eight years.

Today, despite the hundreds of confessions, Lucas admits to just three murders. He "did" his 200-pound mother, Viola. He killed Toole's niece, Becky Powell, a mentally retarded 15-year-old. She

Of the hundreds of confessions, this last one is the only one where police had any hard evidence.

In all the others, investigators failed to find any physical evidence to corroborate the confessions. No ballistics, no weapons recovered, no fingerprints, no fiber identification, no loot recovered from the victims.

In a word, nothing. Only Lucas' words.

That seems to be enough for at least two murders in Dade County.

"Lucas came down here and confessed to a lot of other killings, but he didn't know what he was talking about, and we couldn't charge him," Metro-Dade homicide detective Greg Smith said. "But in the cases where we charged him, we've got good cases. We've got good confessions."

On May 28, 1981, someone found the bodies of two teen-agers in a South Dade drainage ditch. Hazel Haack and Linda Karbin had been drowned. Lucas confessed four years later.

But there's a good chance he wasn't even here when the young women died.

Records obtained by The Miami Herald show that a Jacksonville scrap-metal company paid Lucas \$14.82 on May 27 for a load of old beer cans and metal junk. That was the day before the murder. On May 29, the day after the murder, Lucas was paid \$77.35 for 560 pounds of scrap, the records of Commercial Metals Co. show.

'Didn't know that'

"I didn't know about that," George Yoss, the man assigned to prosecute Lucas, said.

A review of the metal company's records shows Lucas came in every two to three days with a load of scrap. Apparently, it took him that long to collect enough junk to make a trip to the company worthwhile.

And Lucas didn't have what might be called reliable transportation. Auto registration records show Lucas was driving a beat-up, blue-and-white Olds station wagon. The car was 8 years old and cut down in back to serve as a pickup truck. It had more than 100,000 miles on the odometer.

It's 696 miles round-trip between Jacksonville and Miami, kind of long for a one-day drive in a battered old truck.

Scrap metal

Perhaps Lucas could have pushed the truck from Jacksonville to Miami and back in a day. But the fact that he was in Jacksonville the day after the

murder with an unusually large load of scrap metal seems to cast doubt on that possibility.

Did Lucas kill Karbin and Haack, the two teen-aged girls?

It's a tough question, but a small one compared with those raised elsewhere. Besides the grand jury investigations in Louisiana and Texas, reporters from The Dallas Times-Herald have conducted an exhaustive review of Lucas' movements across the United States over the past eight years.

What they found gave police more than a few headaches.

They found traffic tickets, pay-check stubs, motel registrations, welfare checks and records from Traveler's Aid. This evidence, overwhelming in some cases, shows that Lucas was hundreds of miles away when many of the crimes occurred.

Police hadn't bothered to trace Lucas' movements before charging him.

In a remarkable one-month sequence in 1978, for instance, police placed Lucas in seven states and charged him with six murders and one attempted kidnapping. To have accomplished all that, Lucas would have had to drive more than 11,000 miles in 30 days. At the time, he was driving a rundown 13-year-old Ford.

To hear some cops tell it, Lucas was a wind-up killer, spinning like a top across the southern half of the nation, stopping only to mur-

der, and then moving on, to murder again.

The Times-Herald concluded: "To accept that Henry Lee Lucas could kill 210 people in an eight-year period, authorities had to accept that he was not just an idle drifter, but a maniacal nomad, racing at nearly impossible speeds from one side of the country to the other, careening along the interstate highways in dilapidated automobiles, compulsively driving for days without sleep and finding victims conveniently waiting at every junction."

The victims were young and old, male and female, black and white.

And there was no pattern at all. Today, the grand juries in Texas and Louisiana are scrutinizing police procedures there. In Little Rock, Ark., prosecutor Chris Piazza is trying to have one of Lucas' murder confessions thrown out of court. "I hope that nobody ever asks him if he kidnapped the Lindbergh baby," he said. "I'm sure he'd cop to it."

In Jacksonville, medical examiner Peter Lipkovic acknowledged that he was "overzealous" in accepting Lucas' confessions to eight grisly murders. Despite the confessions, Lucas has not been charged with any deaths there.

And Buddy Terry, the Jacksonville homicide detective who linked Ottis Toole and Henry Lucas, has been transferred to other duties. He got Toole to sign over the rights to any book and

movie deals. Now he works the midnight shift, handling burglary cases.

Toole is on Death Row in Florida. Two eyewitnesses said he set fire to a house where a man died.

Lucas is on Death Row in Texas. After jurors there watched him on videotape — confessing to a whole string of murders — they convicted him of killing an unidentified hitchhiker.

Now, as with the hundreds of other confessions, Lucas denies that murder. "I told what they wanted," he said.

Henry Lee Lucas, scheduled to die by injection, has an explanation for all the false confessions. "They think I'm stupid," Lucas said recently. "But before all this is over, everyone will know who's really stupid."

- Unknown Unconfirmed St. Augustine, Fla. W/F, stabbed. Occurred in second story apartment. Victim was sexually assaulted. Lucas advised he did this by himself while Toole, Becky and Frank waited in the vehicle outside. The victim was left in the bedroom. Lucas stated that the victim came outside to dump the trash in a dumpster while he and the others were sitting in their car in the parking lot. He followed the victim upstairs. Lucas stated that he had advised a St. Augustine Sheriff's officer about the details of this but would not admit to it.
- 07 - 1980 Unconfirmed St. Augustine, Fla. L & T W/F, approximately 18 YOA, brown hair, 5'02"-3", was wearing a bathing suit with pink colored shorts over the bottom portion of the bathing suit. Lucas stated he picked the female up on U.S. 1 and took her to a wooded area by the beach where he strangled her with a string from the bathing suit. She was sexually assaulted and the nude body, along with the clothes and a billfold were left between the sand dune. The vehicle driven was an Oldsmobile Vistacruiser.
- 09 - 1978 Unconfirmed Palatka, Fla. L & T W/F, approximately 40 YOA, black hair. Suburbs of Palatka. Victim was stabbed to death. The victim was sexually assaulted. Happened approximately 10 - 11 PM. Lucas stated that tools, a television, stereo, jewelry, money and electrical appliances were taken. Lucas killed the victim, stated that they were in the house for approximately 2½ hours, but that the victim was killed 10 to 15 minutes after they arrived. The victim had been left on the bed. Lucas described the house as ranch style with brick halfway up the walls and the top part of the walls would be wood with the patio and a building at the side of house which was attached but was not a garage - like a separate building. The victim had a new car which was expensive like a Cadillac. Toole reportedly may have killed a black poodle by a blow to the head at the residence. The vehicle used was a Ford station wagon.
- 12 - 1980 Unconfirmed Daytona, Fla. L & T W/F, brown hair, approximately 25-26 YOA, approximately 130 lbs. In town in a wood frame house (off-white color). Stab wounds, victim cut around the neck and stomach area. Left in an upstairs bedroom with the slip and bra pushed up on the body. The home may have been next to a school or business. The crime would have taken place during the night, the victim was sexually assaulted. Money taken from the purse, the purse scattered. Otis Toole killed the victim. The vehicle used was the Oldsmobile Vistacruiser.
- 1979 Unconfirmed Daytona, Fla. L & T W/F, long red hair, 30-35 YOA. In an apartment complex in the south part of town - maybe the Sea Land Apartment. Stabbed in a waterbed in an upstairs bedroom, the waterbed was also stabbed. Victim was sexually assaulted. Stereo and money taken from the living room area where the purse was located, also jewelry. Lucas was driving a Cadillac registered in Jacksonville.

Antiques were taken, old money, a check book was also taken and checks were cashed in Miami on a Farmer's bank. A silver tea set was taken and sold in San Antonio, Texas. Lucas advised that he and Toole cleaned the house up after they killed the resident and the body may have been left with no panties on, but the victim was not sexually assaulted. They were driving a 1965 Thunderbird which was registered to Lucas in Maryland.
March - 1980 Unconfirmed	Brevard Co., Fla. L, T & B		W/F, 18 YOA, blonde, hitchhiker, 110-115 lbs. Right off 407 in Brevard county on a back road with water on one side of the road and a field on the other. Described as turning off of a hard road onto a dirt road through a field. The field had been recently plowed and there were no weeds in it. The victim was strangled, the victim was left nude laying on top of her clothes and sand scooped on top of the body. Lucas and Toole reportedly were the only ones that had sex with the victim before death. They were driving a Pontiac Catalina registered to Toole's mother.
Nov. - 1981 Unconfirmed	West Palm Beh., Fla. L & T		Two white females - hitchhikers. The first victim was blonde, 16-17 YOA, 5'4", wearing a white pair of shorts and a tube top. The other victim had dark hair in a butch cut, 15-17 YOA, wearing a Levi's pullover white linen blouse. Out of Palm Beach about ten miles west in a wooded area off of a dirt road approximately 40' from a power transformer which had a steel fence around it located in the pine trees. Possible description was given as leaving town on a hard road (maybe 210) to a dirt road, 1 mile down a dirt road to where a power line system intersects with the transformer area. Approximately 20-25' off the power line. The blonde victim would have had her hands tied, sexually assaulted and strangled to death with the tube top. This was the victim that Lucas killed. The one Toole killed was the dark haired girl and she would have had her throat cut and sexually assaulted. Both females were not picked up together but could have both been local girls because they had no luggage with them. Their bodies would have been left nude, approximately 10-15' apart with the clothes in the same area. They were driving a green Chevrolet station wagon registered in Jacksonville to Lucas.
1981 Unconfirmed	Ft. Lauderdale, Fla. L	/	W/F, hitchhiker, brown hair, 5'06", 20's, approximately 140-145 lbs, wearing slacks which were dark colored, a mixed colored shirt. Location would have been in a room in the back of a market where construction work was going on. The victim would have been stabbed to death, left on a cardboard box, sexually assaulted and the purse would have been missing. The room was described as possibly a utility room. Lucas was driving a Dodge which he kept only a week and was registered to him in Jacksonville.

Lucas stated that he walked off of the beach area and found this female who had apparently been living in a shipping crate with bedroll inside and cans of food there. Lucas stated he strangled the victim, had sex with the victim and took all the victim's clothes off except for a blouse which would have been left open. The victim was left in the wooden shipping crate. Lucas was driving a Ford station wagon registered in Maryland to him.	
May - 1979 Unconfirmed	Ft. Lauderdale, Fla. L & T	Male - 50-60 YOA, black male with salt and pepper gray hair. Female was also black, approximately the same age with salt and pepper gray hair. Location would have been a beach house with an area going to the beach in front of the house in Ft. Lauderdale. Means of death would have been gunshot wound with .22 caliber pistol. Lucas and Toole had been in the house when the residents arrived. The man was shot in the living room as he entered the house. The woman ran and was shot as she entered the dining room from the living room. Taken from the male was a watch, rings and a wallet. The female victim's purse was taken. From the house a stereo and two to three guns were taken. The victims were reportedly driving a red and white Cadillac. Lucas and Toole were driving a Ford pickup, blue and white in color registered to Howard Toole who is Otis Toole's brother.	
1980 Unconfirmed	Hollywood, Fla. L & T	Toole said he killed Adam Walsh, but Lucas does not believe that he (Toole) did so.	
1980 Unconfirmed	Hollywood, Fla. L & T	W/M, approximately 28 YOA, with light brown hair, white slacks, pullover shirt and tennis shoes. The victim was picked up off the street in Hollywood and taken to an area on the docks around a pier where the victim was stabbed to death by Toole because he would not have sex with Toole. Lucas witnessed the death which took place about 1 - 2 in the morning. The body was left on the pier and the billfold was taken. They were driving a foreign car, station wagon type - Lucas could not recall the make.	
Late - 1981 Unconfirmed	Hollywood, Fla. L, T, & B	Young white female, approximately 13-14 YOA, with brownish blonde hair, 5' tall or less, 100 110 lbs, wearing a skirt and blouse and had on platform style shoes. The victim was taken from a shopping mall and had a bag of groceries with her. The victim was taken to a grassy area next to the beach off of the right hand side of a dirt road close to a Burger King. The victim was killed in a camper on the back of his pickup truck (possibly a Chevrolet), approximately 10-11 PM at night in a park close to where people fished. The victim was shot with a .38 caliber pistol. Lucas shot the victim and could not remember which side of the head he shot him on. He could use both of his hands to shoot with. The truck was possibly registered in another county other than Dade County. The victim's watch, several gas credit cards, probably Texaco and Exxon were taken from the victim's wallet and the wallet was left outside the truck. Lucas stated that they used the credit cards and signed the victim's name and also took some identification that the victim had other than credit cards out of his wallet. Lucas stated that the victim may have been from Mandarin. Lucas stated that the truck was close to a building of some kind. The vehicle that Lucas and Toole were driving was a Chevrolet pickup truck, green and white in color, registered to Toole's mother.
1978, late 1979 or 80	Miami, Fla. L	Cuban female, which had short brown hair, approximately 5'03", 125 lbs., wearing glasses. Location of death would be close to the convention center. The victim was stabbed, and her underclothes were left on except for the panties which had been ripped off and they were left in the area. They took the money out of the victim's purse and threw the purse in the shrubbery close by. This would have been approximately 1 or 2 days after Toole's mother's death, at approximately 9:30 - 10:00 PM at night. They were driving the Olds Vistacruiser at the time.

The victim would have been a W/F, approximately 50 YOA, well built, with long brownish hair wearing a blue nightgown and a housecoat without bra and panties. The victim would have been stabbed numerous times and sexually assaulted. The gown would have been pushed up over the victim and the housecoat left open. Lucas stated that he used the victim's knife which was left there. While Lucas was stabbing the victim the knife was wrapped in the robe. Taken from the house was jewelry and the victim's billfold. Lucas stated that he walked to this victim's house from the apartment of the above victim's apartment where he had been staying.
