REPORTED TIME APPROXIMATELY 12:30 HOURS, LOCATION 300 HOLLYWOOD MALL, CITY OF HOLLYWOOD. THIS STATEMENT IS BEING TAKEN BY DETECTIVE MARK SMITH, BADGE 1163 OF THE CITY OF HOLLYWOOD POLICE DEPARTMENT.
