Mr. Poole has information possibly relative to the homicide investigation that occurred in Hollywood, Broward County, Florida 300 Hollywood Mall on July 27, 1981. This statement is being taken by Det. Ron Hickman #0434 and Det. Jack Hoffman #0038 of the Hollywood Police Department and is being obtained on Thursday, November 3, 1983 at 10:55 A.M. This statement is being obtained at Baker Correctional Institute located at Olustee, Florida.

Q. Mr. Poole, before I take your statement, I'm going to place you under oath by virtue of my commission as a Notary Public at Large in and for the State of Florida. Would you raise your right hand? Do you solemnly swear the information you are about to give me in this statement to be the truth, the whole truth and nothing but the truth, so help you God?

A. Yes Sir.

Q. You are aware that it is a crime under Florida Statutes to knowingly, while under oath, offer false information?

A. Yes Sir.

Q. We want to go back to when you first met Ottis Toole and then just work it from there. We've been talking about five minutes now so we'll start over again.

A. Okay, I uh met uh Mr. Toole at uh uh B.T.U. which is a Transient Unit.

Q. Department of Transient Unit?

A. Yes Sir.

Q. Okay

A. And uh I met him, he was in the same dorm that I was in, I had gone over for a snake bite.

Q. What month and year was that Sir?

A. Uh, I believe it was July but I know it was for 28 days but I can't remember if it was July or August.

Q. Summer of 1983?

A. Yes Sir. Uh so while I was there I met Ottis through him coming over and asking me for uh a cigarete every now and then and that's when we started conversing, so I asked him what he was in for and he said Arson, and I said well that's what I'm in for and uh we started talking about how he was suppose to have set a fire at a warehouse, a paint warehouse or something, I don't remember exactly where it was, and uh so from that

uh you know he asked me what mine was about and I explained you know just a little bit to him and uh so we started talking from there, and uh I had thought that he was from Fort Lauderdale at first.

Q. What made you believe that?

A. Just the way he was carrying on a conversation. He said that uh he'd done a lot of traveling and the reason that came up is because my real father lives in Fort Worth, Texas, and I lived in Los Angeles for ten years, so he asked me what I did and I told him I had a record you know personal management company which is a record company in Los Angeles, which was called ? Productions, and uh so he said yeah I've been to uh Los Angeles, and I've been to Texas and he was talking about you know every place that I'd been, he'd been, so you know I just kind of shyed him off as not being very truthful.

Q. Did it sound like uh he was in the, had been in the Fort Lauderdale area, was he familiar with that area?

A. Well that's what, that's what I was going to say, he said uh, because I told him I was busted in Fort Lauderdale and he goes yeah, they were trying to bust me in Fort Lauderdale, he says, but I inherited some money, he may have said I was going to inherit some money and that everything had been taken care of so I said Oh man I said, some people have all the luck or something, you know it was just general conversation, and then I asked him what did he do for a living and he said that a partner of his and he was in business in the child repossession business or something like that

and you know I kind of chuckled at it because I thought it was kind of funny the way he said it, and uh so at that point I said, I asked him, what do you mean and he said well when a family is going through a divorce or they're not finished divorcing yet or something, we go and we pick the child up from this family, if we have to go all the way across the country to do it, we're paid to do this, and you know I looked at the guy and I just, I figured this guy is nuts, he's not being honest at all, so uh it started from there and that's when he said he'd been in Fort Lauderdale and I said, what part of Fort Lauderdale, so he said uh I was in uh, he said first he was staying down off Ives Dairy Road I believe and uh.

Q. He told you he had stayed off of Ives Dairy Road?

A. Yes Sir.

Q. Did he say what type of place he stayed in?

A. No Sir, he didn't.

Q. He just mentioned Ives Dairy Road?

A. He just said I stayed off of Ives Dairy Road, cause he asked me if I was familiar with North Miami, South Broward area and I said somewhat. I lived up in the north part of Broward so I didn't know that much about it.

Q. And he indicated South Broward area?

A. Yes Sir, he said South Broward, North Dade, and I said yeah I know where Ives Dairy Road is but I'm not familiar with the area and uh so it went on from there and uh he said that uh his partner was suppose to have met him down there, that he was out on bond or something and his partner was suppose

to meet him down there and then they were going to pick up this money from some relatives or something.

Q. Did he say who his partner was?

A. No Sir, he never, all he said was his partner all the time.

Q. This money he indicated he had to pick up, this was as a result of them abducting a child and bring him to the people that wanted the child abducted and brought back, the parent?

A. He said that, he said that his partner was going to pick up the money and that they were going to go to the other parent to get the child and take him back, uh.

Q. The partner was suppose to have met him in South Broward or North Dade?

A. Yes Sir.

Q. Did he relate what time, what year this occurred in?

A. He didn't say, he said it was just before I got arrested.

Q. Okay

A. And he said that he had gotten arrested in Broward and I said well, uh you know, I asked him about the Broward County Jail and he didn't seem to know that much about it.

Q. Did he indicate to you that he had possibly an alias when he was in jail, a different name?

A. No Sir, he didn't indicate that at all. But then I said to him, I said well what is this this child repossession, I said most of the time uh you know, private detectives do that type of thing or or somebody, child counselor you know, I didn't know what he was talking about so he said well no no he said, we we've been doing this for a long time and I said well I said I don't know anything about it and then he said the only problem was I had to go get my own son from my wife and I said Oh yeah.

Q. He had to go get his own son from his wife?

A. Yes Sir, and he said that uh uh when he went to get his own child from his wife he had to go to Hollywood and that's when it clicked on me, he had to go to Hollywood, and I said well I know Hollywood pretty well and he said she lived off of, right over by the racetrack okay, so I'm familiar..

Q. You know what type of racetrack?

A. No Sir.

Q. Did he indicate horse, dog?

A. He said it was a dog racetrack I believe, so I said well, I said I don't know that area persay but I know Hollywood Beach area and all that and he said no well it wasn't around there. So he started talking, all the conversation ended that day, and the next day I was out in the field and that's when he came up to me and we were talking and he had asked for a

cigarette and I said uh, how much time did you get, I'd never asked him, he says I got twenty years, and I said for a second degree arson you got twenty years, I said that's a second degree felony, you can only get the max. fifteen, I said man you got screwed royally, and he goes well he says I think it has something to do with they may have found this car that I had down there and found something in it and they may be holding me for that. I said they can't [?] at a time and hold you for that.

Q. Who did he mean by they?

A. No, No Sir, he talked to a friend of mine as a matter of fact, now if you have to verify how much time he spent with me, the guy that he talked to who was Frank, what was his last name, I've got it written down, I've got his address and everything written down because he went to uh, went to uh, uh, Laudie, not Laudie but went down near Ft. Myers, okay, and he slept next to me so you know he knows we spent some time together and uh.....

Q. Was he close with this guy Frank too or just you?

A. Not really, no, he wasn't close with Frank at all. I mean nobody was close with him, he was dirty and he was you know. If I have to live with a guy I ain't worried about it, you know, but uh he just uh, it was the things, when he started, when he told me about leaving his son in the car I thought that was real strange because nobody, I mean if the cop pulls you over, he's your son, but the kid's going to say it's my son, you know, and uh I asked him how old his son was because I was curious you know, because if he was an infant he'd be a fool but he said he was seven, seven or eight.

Q. Did he describe his son to you?

A. No Sir, he didn't, he just said he was seven or eight years old.
