Today's date is November 3rd 1983, the time is 12:20 p.m. the place is the Police Memorial Building, this is a recorded statement of OTIS TOOLE, by DETECTIVE J.W. TERRY, Jacksonville Sheriff's Office, Homicide Division.

Q. OTIS on yesterday's date which was November 2nd 1983 at 6:10 p.m. I came to the County Jail to talk to you because you had contacted Detective Ron Carrol and told him that you wanted me to come over and talk to you is that correct?

A. Yes sir that's correct.

Q. On the day that I talked to him the conversation was about you up here how you were doing and the reason you wanted me to come over and talk to you, what was the reason that you wanted me to come talk to you?

A. Well the detective from Miami, and I mean the lawyer I had from Miami and the lawyer I got here in Jacksonville, told me that I don't have to talk with you at all, but I still want to talk to you and the detective is trying to get me to say I ain't guilty on the Adam Walsh case

Q. The detective or the attorney?

A. I mean the attorney..and different people are coming from Sears wanting to talk to me from down there and I won't even talk to them. I really know myself that I really did kill Adam Walsh but the lawyer I got from Miami he's trying to tell me I didn't kill Adam Walsh.

Q. Are you telling me you didn't make any statements to the effect that you didn't kill Adam Walsh? That your attorney did? Or did you make any statements?

Q. At the request of your attorneys I am not going to ask you about Adam Walsh and I want you to consult with your attorneys on your cases, do you understand that?

A. Yes, I understand that..yes
