THE FOLLOWING IS THE THIRD SUPPLEMENT REPORT OF THIS CASE SUBMITTED BY DET. MARK SMITH.

DURING THE RE-INVESTIGATION OF THIS CASE, THIS DETECTIVE RECEIVED A PHONE CALL FROM A ~~JUDY CHANDLER~~. MS. CHANDLER STATED THAT HER SON, GRANT HUCKER 9-30-58, INFORMED HER UPON VIEWING THE NEWSCAST OF THE MISSING PERSON REPORT OF ADAM WALSH ON 7-27-81, THAT HE BELIEVED HE HAD SEEN THE CHILD IN THE COMPANY OF AN OLDER W/M IN A NEWER MODEL SILVER CADILLAC. MS. CHANDLER ADDED THAT SHE CALLED THE HOLLYWOOD POLICE DEPT. DIRECTLY AFTER THE 6 P.M. NEWSCAST TO INFORM THE INVESTIGATORS OF HER SON'S OBSERVATION. NOT KNOWING THE OUTCOME OF THIS CONTACT, THIS DETECTIVE MADE ARRANGEMENTS TO MEET WITH MR. HUCKER AT HIS RESIDENCE IN BOCA RATON THE FOLLOWING DATE.

MR. HUCKER STATED THAT HE BELIEVED HE OBSERVED ADAM WALSH IN THE FRONT SEAT OF THE PREVIOUSLY MENTIONED VEHICLE WITH THE 50-60 YEAR OLD DRIVER, WHO HE OBSERVED TO HAVE HIS RIGHT ARM OVER THE CHILD'S SHOULDERS AND RIGHT HAND BETWEEN HIS LEGS, WHILE THEY WERE STOPPED AT A TRAFFIC LIGHT ON FEDERAL HWY. NEAR THE POMPANO FASHION SQUARE SOMETIME BETWEEN 12 NOON AND 3 P.M.. MR. HUCKER STATED THAT THIS OBSERVATION WAS THE SAME DATE OF THE REPORTED MISSING PERSON. MR. HUCKER STATED THAT AS HE OBSERVED THIS, THE CHILD MADE EYE CONTACT WITH HIM AND RECOGNIZED IT TO BE THE SAME CHILD OBSERVED IN THE PICTURE SHOWN IN THE NEWSCAST. DUE TO THE DIFFICULTY OF THE FOLLOW-UP OF THIS TYPE OF LEAD APPROXIMATELY 14 YEARS AFTER THE FACT, THIS INFORMATION WILL REMAIN UNDER CONSIDERATION IF AND WHEN IT MAY RELATE TO ANY PERSONS OF INTEREST IN THIS RE-INVESTIGATION.

DURING THE REVIEW OF THE ORIGINAL CASE FILE, THIS DETECTIVE DETERMINED SEVERAL OF THE NUMEROUS LEADS TO BE OF INTEREST, BUT ARE NOT LIMITED TO THE FOLLOWING HOWEVER. ON 8-5-81 AN INDIVIDUAL BY THE NAME OF ~~ERRY WILBER~~ CONTACTED THE HOLLYWOOD POLICE DEPT. REGARDING THIS CASE. MR. WILBER REPORTED THAT HE BELIEVED THAT HE HAD SEEN ADAM WALSH ON FOOT NEAR A GAS STATION IN FT. PIERCE, IN THE NORTHBOUND DIRECTION OF THE FLORIDA TURNPIKE. WHAT SHOULD BE NOTED IS THAT THIS INFORMATION IS RECEIVED APPROXIMATELY 5 DAYS BEFORE THIS AGENCY IS MADE AWARE THAT THE VICTIM'S PARTIAL REMAINS ARE RECOVERED NOT FAR FROM THIS AREA. THIS DETECTIVE MADE PHONE CONTACT WITH MR. WILBER WHO RECALLED HIS OBSERVATIONS. MR. WILBER, TO HIS CURRENT RECOLLECTION, STATED THAT HE OBSERVED A W/M JUVENILE, WHO HE BELIEVED TO BE ADAM WALSH, AT A REST AREA ALONG WITH A W/M WHO HE BELIEVED TO BE OLDER THAN WHAT THE CHILD'S FATHER WOULD BE. MR. WILBER STATED THAT THE OLDER W/M WAS ENCOURAGING THE CHILD TO ENTER A BROWN VAN PARKED AT THE REST AREA, BUT THE CHILD DID NOT WANT TO GET IN. WHEN HE LATER OBSERVED THE PICTURE OF ADAM WALSH ON TELEVISION, HE BELIEVED THIS CHILD TO BE HIM. FOR THE SAME REASON MENTIONED IN THE GRANT HUCKER TIP, THIS INFORMATION WILL BE KEPT UNDER CONSIDERATION.

TWO OTHER PERSONS OF INTEREST FOR INTERVIEW ARE IDENTIFIED AS ~~HEIDI AND ARLINE MAYER~~. THE MAYERS WERE LISTED IN THE INVESTIGATION IN 1983 AS WITNESSES TO AN INCIDENT AT THE HOLLYWOOD K-MART STORE AFTER OBSERVING A PICTURE OF OTTIS TOOLE IN A LOCAL NEWSPAPER. THE MAYERS STATED THAT THEY BELIEVE THEY OBSERVED TOOLE AT THE K-MART LOCATED AT 651 S. 60 AVE., WHICH

IS WITHIN 2 MILES OF THE SEARS STORE, ONE OR TWO DAYS BEFORE THE REPORT OF THE MISSING ADAM WALSH. AT THE CURRENT TIME, THE WHEREABOUTS OF THESE TWO INDIVIDUALS IS UNKNOWN, AND ATTEMPTS TO LOCATE THEM WILL CONTINUE.

DURING THIS RE-INVESTIGATION THIS DETECTIVE HAS RECEIVED SEVERAL LEADS OF INTEREST FROM OTHER LAW ENFORCEMENT AGENCIES. THE MISSING CHILDREN INFORMATION CLEARINGHOUSE OF THE F.D.L.E. INFORMED THIS DETECTIVE OF AN ANONYMOUS CALLER WHO STATED HAD INFORMATION REGARDING THIS CASE. THE CALLER STATED THAT AN INDIVIDUAL HE KNEW CONFESSED TO KILLING ADAM WALSH AND HINTED TO HIM THAT THE REST OF THE REMAINS WERE PLACED INTO AN OIL DRUM AND BURIED ALONG S.R.70. S.R.70 WAS DISCOVERED TO BE ACCESSED VIA 441 AT THE NEXT EXIT NORTH ON THE FLORIDA TURNPIKE FROM WHERE THE REMAINS OF THE VICTIM IN THIS CASE WERE DISCOVERED. ALTHOUGH THE CALLER WAS ANONYMOUS, HE PROVIDED ENOUGH INFORMATION ABOUT HIMSELF AND THIS SUBJECT, WHOM HE STATED TO BE HIS NEIGHBOR, TO BE LOCATED AND INTERVIEWED. THIS INTERVIEW WILL BE ATTEMPTED IN THE NEAR FUTURE.

ON 8-31-75, THIS DETECTIVE RECEIVED A CALL FROM A CAPT. STEVE BALAG OF THE BOARDMAN OHIO POLICE DEPT. REGARDING A MURDER SUSPECT FROM THEIR JURISDICTION IN 1972. CAPT. BALAG STATED THAT W/M KENNETH ADRIAN LECLAIR 6-18-38 WAS THE PRIME SUSPECT IN THE MURDER OF A 10 YEAR OLD BOY IN BOARDMAN IN 1972. LECLAIR HAD BEEN IDENTIFIED AS A SUBJECT WHO HAD LURED YOUNG BOYS INTO HIS VEHICLE AND WAS SUBSEQUENTLY CHARGED IN AN UNRELATED SEX OFFENSE. ALTHOUGH LECLAIR HAD FAILED A POLYGRAPH EXAMINATION REGARDING THE HOMICIDE, HE WAS SUBSEQUENTLY RELEASED FROM CUSTODY AND TRACKED TO THE STATE OF FLORIDA. THIS DETECTIVE PERFORMED A BACKGROUND CHECK OF LECLAIR WHICH REVEALED HIS FIRST ARREST IN FLORIDA TO BE IN 1982 FOR POSSESSION OF A FIREARM AND NARCOTICS IN INDIAN RIVER COUNTY, THE COUNTY WHERE THE REMAINS OF THE VICTIM IN THIS CASE WERE RECOVERED IN 1981. LECLAIR HAS SINCE BEEN ARRESTED FOR ARMED ROBBERY IN 1983 AND AUTO THEFT IN 1985 AND, ACCORDING TO HIS CRIMINAL HISTORY, LAST RESIDED IN DAYTONA BEACH, FL. AS STATED ABOVE, THIS INFORMATION WAS RECENTLY RECEIVED AND HAS NOT BEEN FOLLOWED UP ON AS OF YET. THE DISPOSITION OF THIS INFORMATION WILL BE COVERED IN A FOLLOWING SUPPLEMENT REPORT.

AS MENTIONED IN A PREVIOUSLY SUBMITTED SUPPLEMENT REPORT, THIS DETECTIVE SOUGHT TO TRY AND ESTABLISH A CONNECTION BETWEEN THIS HOMICIDE AND THE HOMICIDE OF STACY WYTRVA. AFTER REVIEWING THE WYTRVA FILE, THIS DETECTIVE IDENTIFIED SEVERAL PERSONS OF INTEREST TO CONTACT REGARDING THEIR KNOWLEDGE OF THE CASE. BESIDES THE SUSPECT WILLIAM THIBAUT, THESE INDIVIDUALS INCLUDE W/M DARRYL BERENSON, W/M CURTIS GIBSON, W/M GEORGE RIVERA, W/M BARRY MURDOCK, W/M RONALD MAYNARD, W/M PAUL MARCHAND, AND W/M TODD LANGNECKER.

THIS DETECTIVE MADE PHONE CONTACT WITH DARRYL BERENSON AT HIS RESIDENCE IN TAMPA. MR. BERENSON RECALLED THE CRIME AND THE SUSPECT THIBAUT. IN THE ORIGINAL INVESTIGATION, BERENSON WAS LISTED AS AN INDIVIDUAL WHO ACCOMPANIED THIBAUT AND CURTIS GIBSON TO THE HILLCREST GOLF COURSE JUST PRIOR TO THIBAUT'S ARRIVAL AT HEADQUARTERS WHERE HE (THIBAUT) WAS TO BE QUESTIONED BY DETECTIVES. ACCORDING TO THIBAUT AT THE TIME, THE REASON FOR DRIVING TO THE GOLF COURSE WAS TO QUESTION A SECURITY GUARD OR EMPLOYEE IF THEY SAW ANYTHING SUSPICIOUS SO HE COULD HELP IN THE INVESTIGATION. THE TRIO EVENTUALLY ARRIVED AT HEADQUARTERS FOR THIBAUT TO BE QUESTIONED, PRIOR TO THIBAUT RETAINING AN ATTORNEY AFTER SHOWING DECEPTION ON HIS POLYGRAPH EXAMINATION.

BERENSON WAS INTERVIEWED BY THIS DETECTIVE ABOUT HIS RECOLLECTION OF THIS ACTIVITY, AS WELL AS ANY THOUGHTS HE MAY HAVE HAD ABOUT A SUSPECT. BERENSON DID NOT RECALL THE ACTIVITY AT THE GOLF COURSE WITH THIBAUT OR

EVEN RESPONDING TO HEADQUARTERS WITH HIM. BERENSON DID STATE THAT HE AND THIBAUT WERE NEIGHBORS FOR APPROXIMATELY 2 MONTHS BUT WERE NOT CLOSE FRIENDS. HE FURTHER ADDED THAT THIBAUT WAS STRANGE AND A LONER, AND BELIEVED HIM TO BE THE MURDERER OF WYTRVA. BERENSON REFERRED TO CURTIS GIBSON AND TODD LANGNECKER AS CLOSER FRIENDS OF THIBAUT THEN HE. AS OF THIS SUPPLEMENT REPORT, THIS DETECTIVE HAS BEEN UNABLE TO MAKE CONTACT WITH GIBSON OR LANGNECKER, WHO IS BELIEVED TO BE CURRENTLY RESIDING IN THE CENTRAL FLORIDA AREA.

ACCORDING TO THE ORIGINAL INVESTIGATION, BARRY MURDOCK WAS LISTED AS THE OWNER OF THE HESS GAS STATION WHERE THIBAUT WAS EMPLOYED AT THE TIME. MR. MURDOCK IS ALSO THE INDIVIDUAL THAT PETER GENOVESE, MENTIONED IN A PREVIOUSLY SUBMITTED SUPPLEMENT REPORT, CONVERSED WITH WITHIN THE PASSED YEAR ABOUT THIBAUT. MR. MURDOCK WAS INTERVIEWED AT THAT TIME AND STATED THAT HE HAD KNOWN THIBAUT FOR APPROXIMATELY 17 YEARS AND THAT THIBAUT WAS STAYING AT HIS HOME FOR 3 MONTHS. ACCORDING TO MR. GENOVESE, WHEN HE SPOKE WITH MR. MURDOCK WITHIN THE PASSED YEAR, MURDOCK TOLD HIM THAT HE ALWAYS BELIEVED THAT THIBAUT WAS INVOLVED IN THE MURDER OF WYTRVA. FOR THIS REASON, AS WELL AS THE LENGTH OF TIME HE HAD KNOWN THIBAUT, MR. MURDOCK WAS OF INTEREST FOR INTERVIEW BY THIS DETECTIVE.

A BACKGROUND INVESTIGATION OF MURDOCK INDICATED THAT HE WAS A RESPECTABLE BUSINESS OWNER AND FAMILY MAN, AND THE CONTACT AND THE INTERVIEW WITH HIM WOULD BE DONE DISCRETELY. THIS DETECTIVE HAS ATTEMPTED ON NUMEROUS OCCASIONS TO ARRANGE FOR MR. GENOVESE TO HAVE A COVERTLY MONITORED CONVERSATION WITH MR. MURDOCK. HOWEVER, DUE TO SCHEDULING PROBLEMS ON THE PART OF GENOVESE, AS WELL AS THIS DETECTIVE, THIS HAS NOT BEEN DONE AS OF THE TIME OF THIS SUPPLEMENT REPORT. IT IS BELIEVED THAT THIS WILL STILL BE ACCOMPLISHED AND IS PREFERRED PRIOR TO ACTUAL CONTACT WITH MR. MURDOCK BY THIS DETECTIVE. THE OTHER INDIVIDUALS LISTED APPEARED PERIPHERAL AT THAT TIME, BUT DID INDICATE THEY MAY POSSESS, OR ARE ABLE TO OBTAIN, SOME USEFUL INFORMATION. AS OF THIS SUPPLEMENT REPORT, THESE INDIVIDUALS HAVE BEEN DIFFICULT TO LOCATE AND THIS DETECTIVE WILL CONTINUE TO ATTEMPT TO DO SO.

AS NOTED IN A PREVIOUSLY SUBMITTED SUPPLEMENT REPORT BY THIS DETECTIVE, INFORMATION ABOUT THIS CASE WAS RECEIVED FROM A DET. HARROP OF THE COOPER CITY POLICE DEPT. DET. HARROP INFORMED THIS DETECTIVE THAT INFORMATION OF THE ADAM WALSH MURDER WAS UNCOVERED IN THEIR INVESTIGATION OF AN ATTEMPTED MURDER AND SUICIDE CASE. DET. HARROP STATED THAT W/F JEANETTE GARRETT ATTEMPTED TO MURDER HER 10 YEAR OLD DAUGHTER AND THEN COMMITTED SUICIDE. DURING THEIR INVESTIGATION, A CASSETTE TAPE INTERVIEW WAS DISCOVERED BETWEEN JEANETTE GARRETT AND A REPORTED PSYCHIC, WHEREIN SHE DISCUSSED THE ADAM WALSH MURDER. ~~THIS DETECTIVE REVIEWED THIS TAPE~~
~~REGARDING WHEREIN MRS. GARRETT STATED THAT HER EX-HUSBAND DONALD GARRETT~~
~~KILLED ADAM WALSH, AS WELL AS A YOUNG GIRL NAMED STACY. THE STACY WYTRVA~~
~~INVESTIGATION REVEALED THE PRIME SUSPECT IN THAT CASE TO BE WILLIAM~~
~~THIBAUT WHO AT THE TIME WAS STAYING WITH BARRY MURDOCK WHO LIVED IN COOPER~~
~~CITY. THE SIGNIFICANCE OF THIS INFORMATION IS UNDETERMINED AT THIS TIME BUT~~
~~WORTHY OF FOLLOW-UP INVESTIGATION. AS STATED PREVIOUSLY REGARDING THIBAUT,~~
~~ALL ATTEMPTS WILL BE MADE TO CONTACT PERIPHERAL WITNESSES PRIOR TO~~
~~CONTACTING DONALD GARRETT, AND THE BACKGROUND INVESTIGATION OF HIM REVEALED~~
~~NOTHING OF SIGNIFICANCE AT THIS TIME.~~

DET. HARROP PROVIDED THIS DETECTIVE THE NAMES OF TWO PSYCHICS, ONE OF WHICH WAS BELIEVED TO HAVE CONDUCTED THE PREVIOUSLY MENTIONED TAPE RECORDED INTERVIEW. THIS DETECTIVE MADE CONTACT WITH ONE ROSE GUARATO WHO DID NOT RECALL SUCH INTERVIEW OR RECALL THE NAME JEANETTE GARRETT. BARBARA SNEIDER

STATED THAT SHE DID NOT RECALL THE INTERVIEW BUT DID LOCATE THE NAME IN HER RECORDS AS A PASSED CLIENT. ~~THE DEATH OF JEANETTE GARRETT HAPPENS THIS~~ HOWEVER ATTEMPTS WILL BE MADE TO CONTACT FRIENDS AND/OR NEIGHBORS WHO SHE MAY HAVE REVEALED THIS INFORMATION TO AND MAY BE ABLE TO PROVIDE SOME INSIGHT.

ON 2-20-85 THIS DETECTIVE MET WITH CHEMIST GLEN ADAMS AND SEROLOGIST JAMES POLLACK AT THE F.D.L.E. JACKSONVILLE REGIONAL LABORATORY FOR A PRE-ARRANGED REVIEW OF THEIR FILES REGARDING THIS CASE. THE PURPOSE OF THIS REVIEW WAS TO DETERMINE FIRSTHAND IF THE BLOODSTAINED CARPET EVIDENCE COLLECTED AND TESTED BY THAT AGENCY IN 1983, WAS IN FACT UNOBTAINABLE AT THIS TIME. ACCORDING TO THE F.D.L.E. CASE FILE, THE BLOODSTAINED CARPET SAMPLES (F.D.L.E. ITEM NUMBERS 7-14) WERE RECEIVED BY SEROLOGIST POLLACK FOR EXAMINATION ON 11-7-83. ~~THE FILE REVEALED THAT THESE CUTTINGS HAD~~ ~~NEGATIVE RESULTS ON PRESUMPTIVE BLOOD TESTS AND HAD INCONCLUSIVE RESULTS AS~~ ~~TO WHETHER IT WAS BLOOD.~~ THE RECORDS REFLECT THAT AFTER TESTING, ~~THESE ITEMS~~ WERE STUNG INTO THE CUSTODY OF DEBRA HARRIS OF THE F.D.L.E. ON 1-17-84. ON 2-23-85 DEBRA HARRIS SIGNED OVER ITEMS 7-14 ALONG WITH THE FBI REAGANVILLE CADILLAC INTO THE CUSTODY OF AN INDIVIDUAL FROM THE JACKSONVILLE POLICE DEPT. WITH THE INITIALS BEGINNING IN "T". IT IS BELIEVED THAT THIS INDIVIDUAL IS EITHER DET. J.W. TERRY OR DET. JAMES GEISENBERG OF THE JACKSONVILLE P.D. AS COVERED IN A PREVIOUSLY SUBMITTED SUPPLEMENT REPORT BY THIS DETECTIVE, DET. TERRY HAD NO INDEPENDENT RECOLLECTION OF TAKING CUSTODY OF THESE ITEMS AND THERE IS NO DOCUMENTATION TO DATE TO CONFIRM THIS ON THE PART OF THE JACKSONVILLE P.D. OR THE HOLLYWOOD POLICE DEPT.. EFFORTS WILL BE MADE BY THIS DETECTIVE TO INTERVIEW RETIRED DET. GEISENBERG ABOUT HIS RECOLLECTION OF THESE EVENTS.

~~NEGATIVE PRESUMPTIVE BLOOD TESTS WERE ALSO CONDUCTED IN A MACHETE AND~~ ~~GREEN CANVAS SHEATH RECOVERED THE SAME TIME AS THE PREVIOUSLY MENTIONED~~ ~~VEHICLE. THE FILE INDICATED THAT DET. JACK HERRMAN OF THE HOLLYWOOD POLICE~~ ~~DEPT. SIGNED FOR THE MACHETE AND SHEATH ON 11-10-83 AND ARE CURRENTLY IN~~ ~~THE CUSTODY OF THE HOLLYWOOD POLICE DEPT. THESE TWO ITEMS ARE TWO OF THE~~ ~~ITEMS FURNISHED BY THIS DETECTIVE TO THE GENETIC REGION LABORATORY IN~~ ~~GREENSBORO, N.C. AND REFERRED TO IN A PREVIOUSLY SUBMITTED SUPPLEMENT~~ ~~REPORT.~~

THE F.D.L.E. FILE INDICATED THAT ITEMS 1-4 (HOLLYWOOD POLICE CARPET SAMPLES AND DEBRIS FROM THE MACHETE AND SHEATH ALONG WITH ITEMS 13A AND 13B) (MACHETE AND SHEATH) WERE SENT TO THE TALLAHASSEE REGIONAL LABORATORY OF THE F.D.L.E. LABORATORY UNIT FOR EXAMINATION BETWEEN 11-23-83 AND 11-27-83. THIS ANALYSIS YIELDED NEGATIVE RESULTS OF A COMPARISON WITH STANDARD HAIR SAMPLES FROM THE VICTIM IN THIS CASE AND WERE LATER SENT TO THE HOLLYWOOD POLICE DEPT. ON 2-7-84 WHERE THEY ARE CURRENTLY IN THE CUSTODY OF.

ON 9-21-95 THIS DETECTIVE RESPONDED TO THE TALLAHASSEE REGIONAL LABORATORY FOR A PRE-ARRANGED REVIEW OF THEIR FILE REGARDING THIS CASE. THEIR FILE CONFIRMED THE ABOVE INFORMATION OF EVIDENCE TRACKING AND REVEALED TESTING OF EVIDENCE RECEIVED IN THE EDWARD JAMES INVESTIGATION REGARDING THIS HOMICIDE. THE EVIDENCE TESTED IN THAT INVESTIGATION YIELDED NEGATIVE RESULTS FOR A COMPARISON WITH HAIR SAMPLES OF THE VICTIM IN THIS CASE AND WERE LATER SENT TO THE SUBMITTING AGENCY (HOLLYWOOD POLICE DEPT.) THIS EVIDENCE IS BELIEVED TO BE CURRENTLY IN THE CUSTODY OF THE HOLLYWOOD POLICE DEPT.

ON 9-19-95 THIS DETECTIVE MET WITH A BENITO CONCEPCION, 10-9-65 AT THE FLORIDA STATE PRISON IN STARKE, FL. FOR A PRE-ARRANGED INTERVIEW. CONCEPCION, AN INMATE AT THE F.S.P. SERVING A LIFE SENTENCE FOR FIRST

DEGREE MURDER, HAD WRITTEN TO THIS DETECTIVE REGARDING KNOWLEDGE OF THIS HOMICIDE. CONCEPCION STATED THAT APPROXIMATELY 6 MONTHS PREVIOUS, HE AND OTTIS TOOLE HAD A CONVERSATION REGARDING SUPPOSED INVOLVEMENT IN THIS HOMICIDE. CONCEPCION STATED THAT HE AND TOOLE BECAME FRIENDS WHEN TOOLE BEGAN DISCUSSING THE HOMICIDE, STATING THAT HE FELT DEPRESSED AND CRIED WHEN HE SPOKE TO HIM ABOUT IT. TO HIS RECOLLECTION, TOOLE STATED THAT HENRY LEE LUCAS AND HE ABDUCTED THE VICTIM FROM THE SEARS STORE, HAD SEX WITH HIM AND THEN KILLED AND DISMEMBERED HIM. TOOLE STATED THAT THE HEAD AND THE FEET OF THE BODY PARTS WERE DEPOSITED INTO THE WATERWAY. CONCEPCION FURTHER STATED THAT TOOLE WAS IN THE MIAMI AREA AT THE TIME AND COMMITTED A DRUG RELATED KILLING OF A L/M WHERE HE RECALLED TO BE NEAR 56 ST. AND N.W. 17 AVE.

CONCEPCION WAS ASKED AFTER THIS STATEMENT IF HE WAS FAMILIAR WITH A FELLOW INMATE BY THE NAME OF _____ WHO HAS BEEN MENTIONED IN A PREVIOUSLY SUBMITTED SUPPLEMENT REPORT. CONCEPCION STATED THAT HE DID KNOW _____ BUT DID NOT DISCUSS THIS INFORMATION WITH HIM. AFTER THIS INTERVIEW, IT WAS NOT CLEAR IF IN FACT THIS WERE TRUE OR HE IN FACT IS RELATING THIS INFORMATION THROUGH _____ OR VICE VERSA.

AFTER THIS INTERVIEW WAS TERMINATED, _____ WAS RE-INTERVIEWED REGARDING HIS PREVIOUSLY MENTIONED STATEMENT. _____ DENIED WHETHER TRUTHFULLY OR NOT, THAT HE HAD MORE INFORMATION THAN HE WAS WILLING TO DIVULGE AT THIS TIME. THE INTERVIEW WAS TERMINATED WITH THE UNDERSTANDING THAT RE-CONTACT CAN BE MADE AND THAT HE SHOULD BE RECEPTIVE TO TOOLE IF AND WHEN HE WISHED TO DISCUSS THE MATTER WITH HIM, TRUTHFULLY OR NOT.

ON 7-21-95 THIS DETECTIVE RE-INTERVIEWED GERARD SCHAEFER, AN INMATE AT THE F.S.P., AND MENTIONED IN A PREVIOUSLY SUBMITTED SUPPLEMENT REPORT. SINCE THE PREVIOUS INTERVIEW ON 6-27-95, SCHAEFER STATED THAT TOOLE HAD AGAIN CONFESSED TO HIM AND OFFERED OVERZEALOUS ASSISTANCE TO THIS DETECTIVE. SCHAEFER WAS INFORMED THAT THIS ASSISTANCE IS APPRECIATED, BUT WITHIN LIMITS. SCHAEFER WAS INFORMED THAT IF TOOLE WISHED TO DISCUSS THE CASE WITH HIM IN GREATER DETAIL, BE RECEPTIVE AND INFORM THIS DETECTIVE DIRECTLY IF HE SO WISHED. THE INTERVIEW WITH SCHAEFER WAS TERMINATED WITH THE UNDERSTANDING THAT RE-CONTACT MAY BE MADE AT A LATER DATE.

ON 9-21-95 AT 8:15 P.M., THIS DETECTIVE MET WITH KATHRYN SHAFFER IN THE CITY OF LANGLAND, FL. MS. SHAFFER WAS PREVIOUSLY IDENTIFIED IN THE INITIAL INVESTIGATION AS AN EMPLOYEE OF THE SEARS DEPT. STORE IN HOLLYWOOD IN JULY 1981. MS. SHAFFER WAS EMPLOYED AS A SECURITY GUARD AT THAT TIME AND WAS SO EMPLOYED IN A NON-UNIFORM CAPACITY ON JULY 27, 1981, THE DATE OF THE ABDUCTION OF ADAM WALSH. MS. SHAFFER WAS INITIALLY HESITANT ON DISCUSSING THE MATTER WITH THIS DETECTIVE, REMINDING THAT SOME PEOPLE ATTEMPTED TO PLACE BLAME ON HER FOR HER ACTIONS WHICH MAY HAVE LED TO THE DEMISE OF THE VICTIM. DURING THE INTERVIEW, MS. SHAFFER DID REASONABLY RECALL THE EVENTS OCCURRING ON SAID DATE AFTER SHE STARTED WORK AT 12 NOON. MS. SHAFFER RECALLS DISCOVERING A DISTURBANCE AT THE VIDEO GAMES NEAR THE CATALOG DEPT. SHORTLY AFTER SHE PUNCHED IN AT 12 NOON, WITH THE PARTICIPANTS BEING 2 B/M JUVENILES AND 2 W/M JUVENILES. MS. SHAFFER STATED THAT SHE MOTIONED FOR THE B/M JUVENILES TO EXIT THE STORE THROUGH THE CATALOG (NORTH) EXIT AFTER THEY INFORMED HER THAT THEIR PARENTS WERE NOT IN THE STORE.

MS. SHAFFER THEN RECALLS THAT SHE ASKED THE 2 W/M JUVENILES IF THEIR PARENTS WERE INSIDE THE STORE AND ONLY GETTING A NEGATIVE RESPONSE FROM THE OLDER W/M, AND NO RESPONSE FROM THE YOUNGER W/M. BELIEVING THESE 2 W/M'S TO BE ASSOCIATED WITH EACH OTHER, SHE ORDERED THEM BOTH TO EXIT THE GARDEN SHOP (WEST) EXIT WHICH THEY DID. MS. SHAFFER ESTIMATES THAT APPROXIMATELY 30 MINUTES LATER SHE RECEIVED A PAGE TO RESPOND TO THE CATALOG DEPT. TO A

REPORT OF A MISSING CHILD. WHILE ENROUTE THERE, MS. SHAFFER RECALLS SEEING REVE WALSH IN THE LAMP DEPT. WHERE SHE IS SHOWN A PHOTOGRAPH OF THE VICTIM. MS. SHAFFER BELIEVED AFTER SEEING THIS PHOTOGRAPH THAT SHE HAD NOT SEEN THE VICTIM PREVIOUSLY, BASED ON THE FACIAL FEATURES OF THE CHILD IN THE PHOTOGRAPH. AFTER HEARING MORE DETAILS, MS. SHAFFER STATED TO HER BOSS AT THE TIME, WHOSE NAME SHE COULD NOT REMEMBER, THAT SHE INTERRUPTED A DISPUTE AT THE VIDEO GAMES AT THE APPROXIMATE TIME THAT THE VICTIM WOULD HAVE BEEN THERE, AS REPORTED BY REVE WALSH. MS. SHAFFER STATED TO HER BOSS THAT SHE ESCORTED THE PARTICIPANTS OF THIS DISPUTE FROM THE STORE AND BELIEVED ONE OF THEM MAY HAVE BEEN ADAM WALSH. WHEN ASKED BY THIS DETECTIVE DURING THIS INTERVIEW IF SHE BELIEVED AT THIS TIME IF THE YOUNGER W/M SHE ESCORTED OUT THE GARDEN SHOP EXIT WAS ADAM WALSH, MS. SHAFFER STATED THAT SHE WAS 85% SURE THAT IT WAS.

THIS DETECTIVE IDENTIFIED SEVERAL OTHER SEARS EMPLOYEES OF INTEREST FOR RE-INTERVIEW OR INTERVIEW FOR THE FIRST TIME REGARDING THIS CASE. ANGELOTTI GANAS WAS IDENTIFIED AS THE EMPLOYEE AT THE LAMP DEPT. WHO SPoke WITH REVE WALSH ABOUT THE PURCHASE OF A LAMP. MS. GANAS STARTED WORK ON JULY 27, 1981 AT 12 NOON AND OBSERVED REVE WALSH SHORTLY THEREAFTER. AFTER SPEAKING WITH MRS. WALSH ABOUT A PARTICULAR LAMP, SHE WAS GIVEN A NOTE TO PASS ON TO A CO-WORKER REGARDING IT. MS. GANAS STATED THAT MRS. WALSH REMAINED IN THE LAMP DEPT. FOR APPROXIMATELY 10-15 MINUTES BEFORE DEPARTING. MS. GANAS STATED THAT MRS. WALSH RETURNED APPROXIMATELY 5 MINUTES LATER ASKING HER IF SHE HAD SEEN HER SON. EVERYTHING STATED BY MS. GANAS IS CONSISTENT WITH REVE WALSH'S VERSION OF EVENTS, INCLUDING TIME.

MIANNA BRAUN, WHO WORKED AT THE CATALOG DEPT., STATED THAT SHE OBSERVED MRS. WALSH ENTER THE SEARS STORE VIA THE CATALOG ENTRANCE WITH A YOUNG CHILD BESIDE HER. MRS. BRAUN WAS NOT SURE WHETHER THE CHILD WAS ADAM WALSH AND ESTIMATED THE TIME TO BE AROUND 11 A.M.. JOHN D. KING, WHO ALSO WORKED AT THE CATALOG DEPT., STATED THAT HE OBSERVED REVE WALSH AND A YOUNG CHILD ENTER THROUGH THE CATALOG ENTRANCE SHORTLY AFTER HE BEGAN WORK THAT DATE AT 12 NOON. KING OBSERVED BOTH AT THE VIDEO GAMES DISPLAY AREA AT ONE TIME, AND LATER OBSERVED SEVERAL OTHER JUVENILES THERE. KING RECALLS HEARING THE INTERCOM PAGE FOR ADAM WALSH AT APPROXIMATELY 12:30 P.M. AND MRS. WALSH'S HYSTERIA.

ON 7-29-75 THIS DETECTIVE MADE CONTACT WITH KING AT HIS RESIDENCE. MR. KING RECALLED THE ABDUCTION/HOMICIDE INVESTIGATION, AS WELL AS HIS OBSERVATIONS. MR. KING STATED THAT HE WAS ABSOLUTELY CERTAIN THAT HE OBSERVED REVE WALSH ENTER THE SEARS STORE VIA THE CATALOG ENTRANCE WITH A SMALL CHILD ABOUT THE REPORTED AGE OF ADAM WALSH. MR. KING FURTHER RECALLED OVERHEARING THE YOUNG CHILD COAXING MRS. WALSH INTO ALLOWING HIM TO REMAIN AT THE VIDEO GAMES ADJACENT TO THE CATALOG DEPT.. MR. KING WAS ALSO CERTAIN THAT THE FEMALE HE LATER LEARNED TO BE REVE WALSH, LEFT THE CHILD AT THE VIDEO GAMES AND PROCEEDED IN THE DIRECTION CONSISTENT WITH THE LAMP DEPT.. WHAT IS IMPORTANT TO NOTE AT THIS TIME IS THAT PERSONS WHO RECALLED SEEING REVE WALSH INSIDE THE SEARS STORE SHORTLY AFTER 12 NOON, AS SHE STATED SHE WAS, WERE PERSONS WHO BEGAN WORK AT 12 NOON AND COULD NOT POSSIBLY HAVE SEEN HER PRIOR TO THAT. THE PERSONS WHO ESTIMATE THE TIME TO BE ANYTIME PRIOR TO 12 NOON WERE WORKING PRIOR TO AND AFTER THAT TIME AND THEREFORE LESS CERTAIN. SEVERAL OTHER EMPLOYEES OF INTEREST HAVE BEEN IDENTIFIED AND ATTEMPTS WILL BE MADE TO PHYSICALLY CONTACT THEM.

ON 10-20-75, THIS DETECTIVE AND DET. DON DUNBAR WILL BE PRESENTING THIS CASE TO THE BEHAVIORAL SCIENCES UNIT OF THE FBI IN CHARLOTTESVILLE, VA. THIS AND OTHER RELEVANT INFORMATION WILL BE COVERED IN SUBSEQUENT SURVEILLANCE REPORTS.
