On the above date, I had a conversation with a Dr. Mark Reisner, one of the three psychologists employed by the Los Angeles Police Department. Reisner offered the following psychological profile of the type of person capable of abducting, murdering and decapitating Adam Walsh. Reisner stated that a profile could only be of a general nature due to a lack of physical evidence.

SEX:

19-35 years of age, probably in his

early to late twenties

RACE:

Caucasion or Latin. Expressed the opinion that this type of conduct

not generally inter-racial.

MENTAL STATUS: Borderline psychopathic/psychotic personality with a tremendous

homosexual conflict expressed in

violence and rage. Probably a "loner" and not liked by many people. Individual unlikely to brag or talk about this act. Unlikely that he will exhibit any remorse

or guilt over act or confess to the

abduction or murder.

EDUCATIONAL BACKGROUND: Little formal education. Lower socio-

economic background.

OCCUPATIONAL

SKILLS:

Probably has held many unskilled or minimally skilled laboring jobs.

SOCIAL RELATIONS:

Identifies with and is attracted to children. May sometimes work with children. Poor relationships with

both females and males.

CRIMINAL HISTORY:

Almost certainly has abducted or attempted to abduct a child in the past. Almost certainly has sexually assaulted a child in the past. Very likely that he has been arrested and imprisoned for such acts.

Reisner stated that the decapitation indicated that there had been sexual conduct with the boy.

Further, that after the abduction, the individual would seek an isolated environment, and that the individual would maintain control over the boy by employing both deception and physical force.

RONALD WRIGHT, Broward County Medical Examiner, advised that his investigation indicates that the head was severed by either a Machete or a meat cleaver with a blade length of at least five (5) inches or more.

On Wednesday, August, 19th,1981 Madison Jounty Sheriff Departmen arrested a W/M, MICHAEL PATRICK KELLY for DUI, and in his possession he had t attached Machete. KELLY had advised he had information that this Machete was possibly involved in this investigation.




