IN REGARD TO ADAM WAISH MURDER, I KNOW FOR A FACT, THAT HE WAS NOT KILLED IN A CAR, HIS HEAD WAS IN THE BACK FIRST. AND HE HAD A NOTE IN HIS POCKET FROM HIS MOTHER. AND HE HAD A CAP. NOW, I HELPED IN ANOTHER MURDER CASE BUT WAS USED,
AND I ACCUSE THEM AND MADE STATEMENTS SO MY
TESTIMONY WOULD NOT BE ANY GOOD, AND SO C.
OFFICIAL LIE, AND SAID I WAS NOT OFFERED A TRANSFER.
AND SAID I WAS MANIPULATING A TRANSFER BY SAYING
MY LIFE IS IN DANGER. AND THEY PUT ME ON C/M.
SO THEIR WORD STOOD OVER MINE NO MATTER HOW
THEY LIE. AND I TELL YOU NOW IF YOU GOING TO
PLAY GAMES THEN I WILL PLAY WITH YOU. I WILL BE
STRAIGHT IF YOU BE STRAIGHT.

ADAM BONE AND FLESH COULD BE SEEN FROM THE BOTTOM
OF HIS NECK, THE NOTE, AND OTIS MAKING A CALL
FROM A ~~DOUGHNUT~~ DOUGHNUT PLACE OR BAKERY AT A SHOPPING
CENTER. NOW IF I CAN TELL YOU WHERE THE BODY
IS, IF YOU WILL DO IT MY WAY, I CAN FIND
OUT. "BELIEVE IT OR NOT." BUT ALL I ASK IS TO
SPEAK WITH A JUDGE "FIRST", ME AND BRADLY UNDERWOOD
IF YOU GOING TO MAKE PRISON OFFICIALS HERE AWARE OF
THIS 'BEFORE' WE SEE A 'JUDGE' THEN I TELL YOU THAT YOU
CAN FORGET IT RIGHT NOW, BECAUSE YOU WILL NEVER FIND OUT
I AM ALREADY IN DANGER OF SNIKEY (INFORMING.)

WOULD TAKE ONE THING FOR GRANDMA, OTOOLE, TO
TELL ME AGAIN WHAT HE DID, I REMEMBER HE WENT THE
WRONG DIRECTION AND CAME TO THE SPACE CENTER SOME
KIND OF A WAY, BUT I CAN'T RECALL IT, BUT I
REMEMBER ALL OF IT AS ONE WHOLE MESS FROM
HIS FRIEND IN TEXAS AND A GIRL IN PENNSYLVANIA
WOODS COUNTRY TOWN, AND DEAD PEOPLE THEY ARE
BUT I KNOW I CAN GET HIM TO TELL ME WHERE
THE BODY IS, BUT HE GETS IT MIXED UP WITH
ANOTHER KID, BUT THEN SAY WALSH PRETTY LITTLE BOX
BUT MY POINT IS: I CAN IN MY OWN WAY
FIND OUT WHAT THE COPS HAVE NOT BEEN
ABLE TO DO, IF I CAN DO IT MY WAY
WITH THE FRIENDS I NAMED, OR WITH
TWO OTHERS I CAN'T REMEMBER, YOU ALL HAVE
FORGOT THAT GRANDMA IS A DEVIL WORSHIPPER
AND A REAL REAL SEX FIEND, HE IS CRAZY BUT
NOT STUPID CRAZY. AND THE POLICE WON'T CHANGE
