Between the dates of March 18 and March 28, 1985, Special Agent (SA) Joe Mitchell and SA Jim Skipper interviewed OTTIS ELWOOD TOOLE, inmate at the state prison, State of Florida on charges of first degree murder reference to homicides he allegedly had committed in various areas of the State of Florida. These interviews were conducted in the office of the Florida Department of Law Enforcement (FDLE) and was continuing on a daily basis with the cooperation of Toole after he had previously waived his rights in earlier interviews pertaining to homicides allegedly committed in the Jacksonville, Florida area. The information reference to the Jacksonville, Florida area was prepared earlier by SA Skipper for dissemination to the Duval County Sheriff's Office.

The original notes, by SA Mitchell, reference interviews with Ottis Toole will be maintained in the 1A section of this case file.

1972 Exact Date Unknown Unconfirmed	St. Augustine T	The victim was a white male, approximate age 18 to 20, height 5'10", weight approximately 140 pounds, dark brown hair, victim was dressed in white colored pants with a short sleeve shirt. Toole advised he met the victim at a lower class type bar and he observed the victim sitting at the opposite end of the bar. Toole had the bartender serve him a drink. Afterwards the victim came up to Toole, at the bar, and talked about hustling. Toole advised him he had sent him a drink without hustling. The victim made a comment about Toole's watch and Toole informed him that it was a cheap one. They continued to drink and the victim commented that he liked Toole and made reference that he knew Toole was a hustler.
Late 50's Exact Date Unknown Unconfirmed	St. Augustine, Florida T	After a short while, Toole advised they departed the bar in Toole's vehicle. Upon entering the car, Toole indicated that he placed his .38 caliber pistol under his leg. After a short drive, the victim commented to Toole that they could pull off and talk, and they did, at an isolated area. Toole committed oral sex on the victim and afterwards they got back in the car and the subject paid Toole \$20.00. Toole then recalled that he got out of the vehicle and went to the trunk. The subject threatened Toole advising him that he wanted all his money. The victim pulled a switch blade knife on Toole and, at that time, Toole shot the victim. Toole then dragged the victim out of the isolated road area and left him in the bushes off US-90A towards the beach. Toole indicated the weather was hot and he was operating a Cadillac grey and white in color registered to him with a Daytona Beach address.
1982 (summer) Unconfirmed	Near I-95 & US-1, Between Daytona & St. Augustine on a dirt road, suburbs of St. Augustine T	The victim was a white male in his late 40's or early 50's identified as a station attendant, operating an independent gas station on the Daytona Beach side of St. Augustine. The victim was shot with a .38 caliber pistol. The time of year was late fall at approximately 8:00 to 10:00 p.m. and Toole advised he was operating a Chevy Impala and he drove off without paying for the gas.
1982 Exact Date Unknown Unconfirmed	St. Augustine, Florida T	The victim was a white male, approximate age 20, height 5'6", weight stocky build, hair brown and long, wet appearing, dressed in Levi pants and Levi jacket with a grey plastic raincoat. Toole shot him in the neckline and left the body in the woods beside a dirt road. At the time, Toole indicated that he was operating a 1967 white Cadillac which was later impounded by the Jacksonville authorities. Toole indicated that after the incident, he took the victim's bag and gave a lot of his personal items away. Toole indicated prior to shooting the victim, he rolled a joint of marijuana and smoked it with the victim.
		The victim was a white male, approximately 40 YOA, weight 170 pound, 5'11", claimed to be homosexual. Toole indicated he met him at a local bar (fancy type bar). The victim lived approximately ten minutes from the bar in a wood constructed Jim Walter type house with a carport. Toole accompanied the victim to his house and drank a Budweiser beer with him. Toole killed him by beating him with a statue which he picked up in the bedroom. The victim was left tied up with a telephone cord on the bed and his head covered with a pillow. Toole advised he took antiques, pictures, candle holders, various "what-nots", silver items and \$100.00 cash from the victim's house.

 The victim was a white male, approximate age mid 30's, height 6'0", weight 150 pounds, thin build, hair reddish tint balding, dressed in a bathing suit, mixed colors. Toole advised he met the victim on the beach and ask him for a light which he refused and Toole beat the victim with a board. At the time, the victim appeared intoxicated and he left the body laying on the beach. Toole indicated that he noted the victim had a beer cooler and lounge chair with him and that Toole also noted survey stakes with orange flags on them, on the beach, at the scene.

 The victim was identified as a white male, early 20's, light blond hair, height 5'5", weight 120 pounds, wearing blue jeans with a mixed colored short sleeve shirt. Toole took the victim to a cheap hotel room and had oral and anal sex and choked the victim. At the time of the incident the victim had no clothes on. The victim was left laying face down and the location of the motel was back from the beach area and was in the run down area of town adjacent a group of big buildings.

 The victim was identified as a white male, age 30, approximately 5'8", 140 pounds, dark brown hair described as country looking type individual, dressed in dark pants, white baggy shirt. Toole advised he took him to the woods, stabbed him several times and the victim had his penis out with his clothes on. At the time, Toole indicated they were on a blanket and Toole dumped the victim's body off the blanket into the bushes and was left on the southside of Crescent Beach.

 The victim was described as a white male, age 20's, short brown hair, height 5'10", weight approximately 140 to 150 pounds. The victim, according to Toole, was a hitchhiker that he contacted on Highway A1A south of Marine Land, Florida. The victim was shot with a .22 caliber. The body was left by a wire fence along side Hwy A1A. At the time the body was left, the victim was dressed in a light colored shirt with black pants.

1965 Flagler Beach, Florida

 The victim was reported to be a white male, approximate age between 30 and 40, height 5'9", weight approximately 180 to 190, hair gray, the victim was shot several times with a .38 caliber pistol in the front part of his body. The victim was left clothed with khaki pants and a multi-colored shirt. The victim was left in a field area near the beach with woods in the background near Flagler Beach. Toole advised that he met the victim at a motel restaurant, at Flagler Beach and they drove in the victim's car out to the wooded area along Flagler Beach. They parked the vehicle and the victim started putting his hands over Toole's body and feeling his privates. They proceeded to get out of the vehicle and Toole proceeded to use the bathroom and the victim informed Toole that if he did not cooperate with him, he could walk back to town. Toole indicated, at that point, he shot the subject and departed the scene in the victim's old model raggedy vehicle and left it at an unknown location in Flagler Beach.

The victim was reported to be a white male, approximate age 40, hair curly black mixture gray, weight 120 to 130 pounds, height 5'5" to 5'6" reported employed as a seaman in the Navy. Toole advised he met the victim at a bar on the beach, at Flagler Beach. After talking for a while, the victim bought Toole drinks and later took Toole to his motel room.

Upon arriving at the victim's motel room, the victim informed Toole that he did not want to have oral sex with him but he informed Toole that he wanted to have sex in the shower of the room. Toole indicated that they took their clothes off and while taking a shower together, Toole got out to use the bathroom and reportedly stabbed the victim in the shower with a switch blade. He left the body in the tub. Toole reported he left the motel in a yellow and white 1973 Dodge automobile.

Toole advised that the victim was a white male hitchhiker and indicated that he ran over him at an intersection on a side street where Toole did not stop at a stop sign when the victim was walking across the street. Toole emphasized he ran over the victim in a 1971 black and white Cadillac. Toole indicated that upon hitting the victim with the automobile, the victim rolled under the car on the passenger side and Toole continued without reporting the incident.

The victim was described as a white male, late 30's, early 40's, approximately 140 pounds, height 5'7", medium brown hair, regular cut. Toole met the victim on the beach. At the time, the victim had a bonfire and Toole knocked the victim into the fire then pulled wood on top of him and burned him to death. Toole indicated the victim screamed while in the fire and Toole described the fire to be about two feet deep and he took the victim's wallet and beer from him. Toole indicated that they were barefooted at the scene and the victim was dressed in a black bathing suit and had a white beach towel with a design on it. Toole indicated that he drank some of the victim's Budwiser beer and they left cans and cool cigarette butts at the scene. Also, Toole noted that he left a chaise lounge and a light at the scene.

The victim was described as a white male, approximate age early 50's, weight 155 to 160 pounds, height 5'8" to 5'9", graying dark hair who indicated that he was retired. Toole reported that he met the individual at a nice bar in downtown Ormond Beach. After drinking for a while, Toole went to the victim's house and the victim undressed from wearing a business suit. Toole undressed except for his pants and shoes. The victim layed on the bed and Toole claimed he stabbed him with a buck switch blade knife.

While Toole was ransacking the house, he noticed that the victim had got up off the bed and was attempting to reach into a dresser drawer. Toole attacked the victim and cut his throat and left him by the bed. Toole described that the victim owned a white Cadillac and that the victim's

house was estimated to be an approximate ten minute drive from the bar where they met in Ormond Beach. Also Toole described the house as being constructed with half brick and half exterior walls. He recalled a boat, approximately 36', was parked in the yard by the house. Further, Toole explained that he took a .357 magnum pistol from the nightstand of the victim's bedroom and also took jewelry, gold coins, table model color TV set with remote control and a video recorder attached to the TV, and several thousand dollars in cash. Also, Toole took credit cards identified from Sears, Maycohn's, and American Express. Later Toole obtained a drivers license to match the victim's credit cards.

At the time, Toole advised that he was operating a 1971 cadillac which he departed the scene in. Toole also vaguely recalled that the first name of the victim was JOE (LNU).

Toole advised that the victim was a white female, approximate age early 20's, of which Lucas had picked up at a local bar. He described the victim as having long dark brown hair and, to the best of his recollection, they were all three drinking and were in Lucas' car (described as a Vista Cruiser Oldsmobile). The three of them rode out into the rural area to drink a couple of six packs of beer. Toole indicated that Lucas and the victim walked into the woods and Lucas had sex with the victim, while Toole watched. Lucas stabbed the victim with Toole watching.

Toole picked up the victim's clothes and stabbed the victim in the front part of her body. The body was left stretched out on the ground with all stab wounds in the front part of her body.

The victim was described as a white female hitchhiker, shoulder length hair, approximate age late 20's, height 5'6", weight approximately 120 pounds which they picked up on I-95 by one of the Daytona Beach exits. They rode around several roads until they felt like they had to do something with her. Toole indicated that Lucas winked at him and they pulled off on a side road, contrary to the victim's wanting to return to the interstate to continue to Miami. Lucas told the victim that she belonged to him. After parking, Toole got out of the car and heard the victim hollering then a gunshot went off and he helped Lucas take the body out of the car and placed it in the woods.

The victim was described as a white female, age 30's, approximately 5'7", 130 pounds, dark brown hair, with a noticeable body figure. After the above described incident, Lucas and Toole proceeded out into a rural area and committed a burglary to a residence by forcing their entry through a sliding door.

While on the premises, they were caught by the victim who ask them why they were there. They told her that they were burglarizing the house. Toole indicated they had looked all around through the windows to determine if anyone was on the premises prior to their entry, but had not noticed the victim.

Upon being approached by the victim, Lucas asked her when she had last had good sex which upset her. Lucas grabbed the victim and took off her clothes which provoked a scuffle which led them into the front bedroom. Lucas ask Toole to hold the victim while he loosened his pants. Lucas proceeded to have sex with the victim.

Lucas then beat and stabbed the victim and tied her up with a telephone cord. He left the body on the bed face down with her hands tied in front of her body. Toole emphasized that they ransacked the house and took money and jewelry. Toole indicated that he was not wearing gloves but thought that Lucas was and that he thought that they left the victim's night clothes in the bedroom and living room floor. Toole emphasized that Lucas bit the victim's breast while having sex with her and the victim had big breasts.

The victim was a white male, approximate age 40, weight 140 pounds, height 5'7", hair dark in color. Toole left Lucas at the Truck Stop and departed with the victim and went to a wooded area. Upon arrival, Toole allowed the victim to have oral sex with him and upon finishing the act, Toole shot the victim in the head with a .22 caliber revolver, more than once. Toole emphasized he left the body in the woods by the side of the road with his clothes on. At the time, he was wearing a bright shirt, long sleeved with dark pants. Toole recalled the victim owned a white Lincoln which was left at the Truck Stop where they met. Toole reportedly took \$300.00 cash, 2 diamond rings, and a gold chain from the victim upon departure. Toole also pointed out that the victim's vehicle may have been scratched from being in the woods at the scene.

The victim was described as a white female, young looking, approximate age 20's or early 30's, nice looking, dark hair and lived in a nice house, in a very nice neighborhood. Toole advised he took the screens off the windows and when he removed the screen from the bathroom window various toilet articles fell out on the ground. He indicated that he threw the washer hose over the phone line and attempted to pull the line loose from the residence but was unsuccessful. Toole entered the residence and pulled the victim out of bed and threw her on the floor and shot her with a .22 caliber rifle in the head late at night. Toole described the house as having hedges around the exterior and was decorated with foreign decor. At the time of his entry, a night light was on in the bathroom and he left a door open upon entry and the victim's dog exited the house. Toole was not sure, but he thought Henry Lucas was with him and they were traveling in the Oldsmobile Vista Cruiser which they had bought from a service man at Jacksonville Beach, Florida.

1979 Exact Date Unknown Unconfirmed	Port Orange, Florida T & L	Toole emphasized the victim was a white male, approximate age 30, dark brown hair, height 5'11", weight 175 pounds, and was described as a hitchhiker which they picked up on US-90A, outside of Port Orange, Florida. They drank beer together and Toole had sex with the victim and shot him in the head with a .38 caliber pistol. The body was left in the wooded area just off 90A on a muddy road where it appeared high water may have been recently. Also the weather was cool and he believed the time of year was fall. At the time, Toole and Lucas were occupying a brown and white 1969 2-door cadillac and he recalled that the victim was bundled up in a lot of clothes.
1976 (summer, at night) Unconfirmed	New Smyrna Beach, Florida T & L	Toole reported the victim was a white female, approximately middle 20's, height 5'6", weight 130 pounds, blond hair, which he claimed they met at a bar while riding on the beach area. Lucas had talked with the victim at the bar and they departed together and frequented several bars in a 1978 green Ford stationwagon bearing Maryland license plates. Toole indicated Lucas and the victim was having sex at the beach and Lucas stabbed her. He left her on the beach partially clothed.
1976 (summer month) Exact Date Unknown Unconfirmed	New Smyrna Beach, Florida L & T	The victim was described as a white male, approximately 5'6" to 5'11", 135 to 150 pounds, light blond hair, 18 to 20 YOA, dressed in light colored shirt with dark pants. Toole emphasized they met the victim walking on a side street at New Smyrna Beach. Upon contacting him, they ask the victim when he had last had oral sex committed on him. The victim responded in the negative and commented that he wasn't going through that. At the time, Toole exited their car and stabbed the victim with a knife in the back. They left the victim on a back dirt street and they believed he lived in the nearby area.
1975 Exact Date Unknown Unconfirmed	Mims, Florida T	The victim was identified as a white female, 20-25 YOA, long dark hair, 5'6", 130 pounds, dressed in a light colored dress. Toole advised he picked up the victim at a beer tavern in Mims, Florida and had sex with her in the car. During that time, Toole took her clothes off and as he was completing the sex act, he choked her to death. He then dragged the body out into the woods at the scene. Toole indicated he kept the victim's dress and he departed the area operating a 1970 Buick, green with white vinyl top.
1981 Exact Date Unknown Unconfirmed	Mims, Florida T	The victim was described as a white male, late 20's, approximately 5'7", 135-140 pounds, brown hair. Toole advised he met and joined the victim at the beach and they swam together. While swimming Toole claimed he kidded the victim about women and homosexuals. They had sex in the water and afterwards Toole claimed he led the victim into deeper water and choked and drowned him. Toole indicated that the time was near dark and he left the victim in the water. Upon departing, Toole picked up the victim's clothes from the beach. Toole left the scene in a 1971 cadillac, black and white in color.

1980 Exact Date Unknown Unconfirmed	Titusville, Florida T & L	The victim was described as white female, early 20's, dark hair, 5'6" - 5'7", approximately 140 pounds, who was hitchhiking at the time contact was made with her. Toole advised Lucas and he picked up the victim and proceeded to a field where Lucas had sex with the victim. Lucas reportedly beat, choked and stabbed the victim and left her nude laying on her back at the scene. Toole described that the victim was wearing slacks, blouse, bra, panties, sandal type shoes and light colored socks at the time they met her. Toole claimed he masturbated, at the scene, on the victim. They departed in Lucas' vehicle described as a 1973 green Chevrolet stationwagon.
1974 Exact Date Unknown Unconfirmed	Merritt Island, Florida T	The victims were described as a male and female couple observed through the window of the house in bed. Toole advised that he set fire to a small white house located in a rural area, off highway US A1A. Further, he described that he cut the window screens and poured gasoline in the house and set fire in several areas around the house. Toole advised after the fire started good, he left the house traveling in a 1979 white Chrysler vehicle.
1981 Exact Date Unknown Unconfirmed	Merritt Island, Florida T & L	The victim was identified as a white male, approximate age 40, wearing coveralls. The victim was attacked while working in his garden, out in a rural area off highway US A1A. Toole indicated he ask the victim for a job and the victim told him to come back the following day. Toole indicated he became mad and attacked the victim with a shovel and left him laying in a cornfield. Toole explained that the victim was wearing a straw hat and was hoeing in the garden at the time which was a short distance from any residence.
1982 Exact Date Known Unconfirmed	Indian Harbor, Florida T	The victim was identified as a white male hitchhiker, approximately age 35-40, 5'8" - 5'9", wearing jeans, short sleeve shirt (pullover dirty type), brown hair. Toole indicated he approached the hitchhiker along US A1A outside of Indian Harbor Beach and ask him if he wanted a ride. The victim would not answer him and Toole shot the victim from the vehicle with a .22 caliber pistol. Toole then rolled the victim into the ditch and recalled that the time of day was nearing dark. Toole further indicated that he was driving a 1967 white Cadillac registered to Ottis Toole. He recalled that the time of year was summer and on that particular day, it was raining.
1981 Exact Date Unknown Unconfirmed	Melbourne Beach, Florida T	The victim was identified as a white female, approximate age 40, medium height, dark brown hair, long length, noted to have large breast and the victim was dressed in a nice white dress and described to be nice looking. The victim was picked up at a bar by Toole. She was believed to be a prostitute. They proceeded to the victim's apartment located in an apartment complex (apartment located on the ground floor). Toole described that upon arriving, they sat on the couch and begin "making out". They started sex on the couch and both of them stripped off their clothes in the living room and proceeded to the bedroom where they lay for a while and smoked in bed. After a while, they continued their sex act and Toole claimed he choked the victim and left her on the bed. Toole advised he took the victim's money, estimated less than \$100.00, and some jewelry. He departed the scene in a 1971 black and white Cadillac that he

claimed he had purchased from a Ms. McNatt who was identified as the aunt of Toole's friend, John Reeves (NFD).

The victim was identified as a white male homosexual (NFD). Toole advised he met the victim at a bar, next to a motel in Melbourne, Florida. They departed the bar late in the evening, just before dark, and proceeded to the homosexual's residence which was located a short distance from the bar. Toole claimed he followed the victim to the victim's residence and described the residence as a ranch style house furnished with antiques. Upon arrival, Toole advised the victim prepared Toole a drink from his liquor bar and the victim began making advances to Toole by unbuttoning Toole's shirt and taking Toole's pants off. Toole indicated the victim began handling Toole's penis. The victim also undressed and committed oral sex to Toole and ask to have sex with Toole afterwards. Toole advised the victim went into the bathroom to wash out his mouth and Toole proceeded to use the bathroom. The subject ask Toole to urinate on him. Toole indicated the victim put KY jelly on his rectum and Toole committed anal sex with the victim and during that act, the subject ask Toole about the cost for the activity and offered Toole a hundred dollars which he refused. Toole then went to take a shower and the victim remained naked and they continued the conversation about the hundred dollar offer which Toole claimed was not enough payment. The victim started for his bedroom and Toole stabbed him and left the victim laying in the floor. Toole claimed he took the victim's money, wallet antiques, pictures, "what-nots", and a silver dollar belt buckle and departed the scene.

The victim was described as a white male, approximate age 25-30, 6'0", skinny build, dark brown hair, small mustache. Toole advised he met the victim at a beer tavern and Toole was followed into the bathroom by the victim. Upon being propositioned, Toole told him they could not do anything on the premises. They departed the premises in separate cars. Toole followed the victim out into a wooded area and, upon arriving in the woods, Toole placed a .38 pistol in his pants. The victim got out of his vehicle and joined Toole in Toole's vehicle. Toole described that they got out of the vehicle and began an argument. The victim approached Toole by rubbing his penis and Toole lit a cigarette and told the victim that he could commit oral sex to him while he smoked the cigarette. Toole described that when the victim went down to commit the sex act on him, Toole shot him with a .38 pistol in the top of the head. Toole then dragged the body by the feet out into the bushes, along side the road. Toole also explained that he left the victim's vehicle, described as an old model Chevrolet, along side the road at the scene.

The victim was identified as a white male, approximately 30 YOA, 125-130 pounds, 5'8", dark brown hair, identified as a hitchhiker. Toole advised that he picked up the victim along US A1A and took him to a wooded area off I-95 and shot him in the chest with a .22 caliber pistol.
