1. **Provenance:** The City of Hollywood, FL, Police Department Case File # 81-56073, opened July 27, 1981 and was made public February 16, 1996. This case file embodies ten volumes of records, or 6,792 documents, and three volumes of photographs relating to the case. This is equivalent to approximately four cubic feet of records.

Each document in the case has been paginated in sequence order. Each document has a corresponding page number in the lower, right corner of the document. The page sequence begins at one (1) and ends at 6,792. This case file has been filmed on three microfilm reels comprising a set; two reels of case documentation and one reel of photographs. All photographs have been filmed together on a single roll of this set. Prints of any of the microfilmed photographs may be obtained by indicating the number in the lower, right corner of the photograph to the Hollywood Police Department - Identification Division.
