



UN THE SAID DATE THIS DETECTIVE CONTACTED RAY GRANDON W/M 3-21-61 AT HIS RESIDENCE. RAY STATES THAT HE WA A RUNAWAY AND WAS PICKED UP BY A SUBJECT WHILE WALKING DOWN DRANGE BLOSSOM TRAIL IN DRLANDO. THIS WAS DECEMBER 1981. THE W/M TOOK HIM TO AN AFT. WHERE OTIS TOOLE AND HENRY LUCAS WERE AT. LUCAS AND TOOLE WERE TALKING ABOUT WOMAN THEY KILLED. TOOLE SAID HE PICKED UP A BOY IN HALLANDALE OR HOLLYWOOD. TOOLE SAID THE KID WAS SCREAMING AND LUCAS CUT HIS HEAD OFF.

GRANDON SAID HE WAS DRUNK WITH TOOLE AND LUCAS. TOOLE GAVE GRANDON A GUN AND TOLD GRANDON TO SHOOT HIM.

GRANDON SAID HE HAS SEEN SHOWS ON THE WALSH CASE, ON T.V. GRANDON SAID HE CALLED AMERICA'S MOST WANTED BEFORE AND TOLD THEM THAT HE REPORTED THIS INCIDENT AS OCCURRING IN 1979. AFTER SEEING SHOWS WITH THE DATE OF THE ABDUCTION OCCURRING IN 1981, HE CALLED AGAIN AND SAID HIS ENCOUNTER WAS IN 1981.

GRANDON HAD ATTEMPTED SUICIDE BY JUMPING OFF A SIX STORY BUILDING IN 1984. GRANDON IS ON DISABILITY FOR MENTAL INCOMPETENCE.
