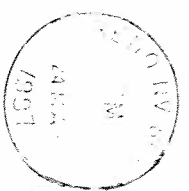

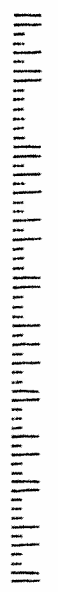

Colorado wants to return money to killing suspect

MONTROSE DAILY PRESS

The state of Colorado wants to give Truckee Meadows murder suspect David S. Middleton some money.

Middleton, a former Montrose resident, is on the most recent state treasurer's "Great Colorado Payback" list, which contains nearly 30,000 names of owners of unclaimed checking and savings accounts, safe-deposit boxes, insurance benefits, stock and other funds, wages, refunds, deposits and overpayments.

Middleton and his girlfriend, Evonne Haley, are prime suspects in the disappearance and murder of Montrose native Buffy Rice Donahue.

According to Colorado Treasurer Bill Owens, Middleton is entitled to \$60,144, a utility deposit he did not claim before moving from Montrose to Reno, where he now faces kidnapping and murder charges.

Middleton is in Washoe County Jail accused of killing two women.

"If he were in a Colorado prison, we would attempt to attach the deposit to help defray the costs of his incarceration,"

Owens said.

"All the justers of Nevada paying to him to just think it would nice to have money, but them."

If Nevada allows the state make a claim "everything it to the state said."

deposit. "We found that in some cases, people are in a hurry to leave a community or they are too busy thinking about other things and they just don't remember to get their utility deposits back," he said. "That's part of what the Great Colorado Payback program is all about."

"In this particular case, I guess I can understand why Mr. Middleton was a little distracted."

The Great Colorado Payback has been successful in returning \$60 million dollars to more than 180,000 Coloradans after the Unclaimed Property Law was
