### Monday 11-24-86

This Detective received a telephone call from Sergeant Tom Carney of the Broward County Sheriff's Department. Sergeant Carney informed this Detective that his department received a letter from an individual identified as FREDRICK L. CHEEK. MR. CHEEK is presently incarcerated in the Clark County Jail, Las Vegas, Nevada.

Sergeant Carney stated that the contents of MR. CHEEK's letter pertain to the ADAM WALSH homicide. Sergeant Carney stated that he would forward this letter to this Detective.

### Thursday, 11-27-86

This Detective received the aforementioned letter from the Broward County Sheriff's Department. The contents of this letter revealed that FREDRICK L. CHEEK has been in the Clark County Detention Center since June 13, 1986.

In August or September 1986, FREDRICK CHEEK was placed into module 3-F.

It was in this module that inmate CHEEK met his cellmate, KEITH WARREN.

As FREDERICK CHEEK became acquainted with KEITH WARREN, MR. WARREN spoke of various kidnappings, sexual assaults, and murders of young boys he had committed. These crimes occurring in New Hampshire, Texas, and Florida. The kidnapping and murder in Florida that KEITH WARREN spoke of quite frequently, was the ADAM WALSH case. According to FREDERICK CHEEK, KEITH WARREN told him about the kidnapping, what he did to the child, how he killed him, and where he disposed of the body. MR. CHEEK would not go into

After returning from Las Vegas, this Detective contacted Detective Owens of the Monroe County Sheriff's Department. An inquiry was made about any unsolved homicides involving a white male teenager in the Isalamorada area. After checking his records, Detective Owens indicated that they did not have any open homicide cases involving a white male teenager. This Detective did a background check on KEITH ALLEN WARREN; on 3-2-81 KEITH was arrested in Tampa, Florida; 3-27-81 KEITH stayed at the Salvation Army in Miami for one or two nights; 5-1-81 KEITH WARREN obtained a Florida Drivers license in Monroe County; 12-25-82 KEITH WARREN received a speeding KEITH WARREN did work at the Coral Grill in ticket in Monroe County.

Islamorada periodically between 1979 and 1982 as a dishwasher and a cook. This Detective was unable to place KEITH WARREN in any specific area on July 27, 1981, the day of the abduction of ADAM WALSH.

# Wednesday 12-3-86 at 1245 Hours

This Detective and Sergeant Wynn met with FREDERICK LEROY CHEEK, W/M, 1-12-47 at the Clark County Detention Center in Las Vegas, Nevada.

A taped interview with MR. CHEEK commenced at 12:47 p.m. In this interview MR. CHEEK explained how KEITH WARREN spoke to him about all life sentences he was facing in the Nevada case. KEITH WARREN informed FREDRICK CHEEK that he would much rather go to a state that had the death penalty then go to prison with no chance for parole.

what case he was referring to, at which time he stated ADAM WALSH.

KEITH WARREN informed FREDRICK CHEEK that he kidnapped a young boy from a shopping center and then took the child to a house in Fort Lauderdale. The house belonged to a woman named DENISE. KEITH stated that he kept the child there for a few days and during that time period, he had sex with the boy. While having sex with the child, KEITH stated he was about to reach a climax when he slit the child's throat.

KEITH told FREDERICK CHEEK that he put the child's body in a bag and drove it to a wooded area off of State Road #80 in Fort Lauderdale. At this location he buried the body. KEITH stated that DENISE knew about this murder. KEITH WARREN did not go into any specifics about the murder, he just related the aforementioned circumstances.

FREDRICK CHEEK was asked if he thought KEITH WARREN was looking for publicity or just bragging to his cellmates about doing other murders.

MR. CHEEK felt that KEITH WARREN is definitely capable of this type of crime but could not be sure if KEITH WARREN was just making up this story.

This was the reason that FREDRICK CHEEK wrote the letter to the authorities. (see interview for additional information).

MR. CHEEK was questioned if KEITH WARREN was close with any other inmates. MR. CHEEK provided us with the names of two other inmates; JIM HEIMEL, and LARRY STACK.

12-30-53. MR. HEIMEL was born in Boston, Massachusetts and raised in Huntington Beach, California. MR. HEIMEL is presently incarcerated for sexual assault, and he was arrested on May 29, 1986.

JIM HEIMEL informed these Detectives that he met KEITH WARREN in June 1986. During the time they were in the same module, KEITH WARREN never spoke of other murder cases or ADAM WALSH to JIM HEIMEL. JIM HEIMEL states that he never got along with KEITH WARREN and he thinks that KEITH is "crazy".

These Detectives were informed that inmate LARRY STACK was transferred to Indian Springs, Correction facility and would have to make arrangements to see him tomorrow.

These Detectives then proceeded to see KEITH WARREN. MR. WARREN was removed from his cell and brought to the interview room. MR. WARREN, upon seing these Detectives refused to speak with us. MR. WARREN requested the officer to take him back to his cell immediately. There was no interview conducted with KEITH WARREN.

# Thursday 12-4-86

This Detective and Sergeant Wynn drove to the Indian Springs Correction facility to meet with LARRY STACK.

At 0910 hours this Detective and Sergeant Wynn interviewed LARRY DEAN STACK, W/M, DOB: 4-17-61. MR. STACK was arrested in August 1986 and sent to the Clark County Jail. There he met KEITH WARREN and lived in the same module. KEITH WARREN informed LARRY STACK that he was in Florida when ADAM WALSH

MISS JURZYK informed these Detectives that she will continue to correspond with KEITH WARREN and attempt to ascertain why he had told other inmates that he was responsible for the kidnapping and murder of ADAM WALSH. It is MISS JURZYK's opinion that KEITH WARREN is just trying to seek publicity for something he didn't do.
