DURING THE WEEK OF JULY 1ST, 1981, THIS DETECTIVE WAS CONTACTED BY A SUBJECT IDENTIFIED AS WILLIAM CARL MISTLER, W/M, 11/05/47. MR. MISTLER ADVISED THIS DETECTIVE THAT HE HAD CERTAIN KNOWLEDGE PERTAINING TO THE ABDUCTION OF ADAM WALSH. MR. MISTLER ADVISED THIS DETECTIVE THAT HE HAD READ A CURRENT NEWSPAPER ARTICLE FROM THE MIAMI HERALD REGARDING MAJOR J. B. SMITH OF THE HOLLYWOOD POLICE DEPARTMENT RETIRING. IN THIS ARTICLE, MAJOR SMITH EXPRESSED THAT THE HOLLYWOOD POLICE DEPARTMENT DID THE MOST THOROUGH INVESTIGATION ELIMINATING SUSPECT OTIS COOLE FROM THE ADAM WALSH HOMICIDE.

ACCORDING TO MR. MISTLER, AFTER READING THIS ARTICLE, HE WAS APPALLED TO FIND OUT THAT OTIS COOLE HAD NEVER BEEN CHARGED IN THIS CASE. THIS DETECTIVE THEN QUESTIONED MR. MISTLER AS TO WHY HE WAS EXTREMELY UPSET WITH THIS NEWSPAPER ARTICLE. MR. MISTLER WENT ON TO INFORM THIS DETECTIVE THAT HE WAS AT THE HOLLYWOOD MALL ON JULY 27, 1981, WHEN HE WAS IN THE WEST PARKING LOT OF THE SEARS MALL AND HE HAD OBSERVED THE SUSPECT OTIS COOLE TAKE THE CHILD FROM THE WEST SIDEWALK NEAR THE GARDEN DEPARTMENT OF SEARS AND PLACE HIM INTO A BLACK OVER WHITE CADILLAC AND THEN DRIVE OFF.

MR. MISTLER ADVISED THIS DETECTIVE THAT AT THE TIME THAT HE WITNESSED THIS INCIDENT, HE DID NOT REALIZE THAT A KIDNAPPING WAS OCCURRING. MR. MISTLER

SUPPLEMENT

STATED THAT THE CHILD DID NOT APPEAR TO BE FRIGHTENED OR RESISTING THE SUBJECT THAT WAS TAKING HIM INTO THE VEHICLE. AT THAT TIME, MR. MISTLER THOUGHT THAT IT WAS A FAMILY MEMBER TAKING THE CHILD FROM THE SIDEWALK AND PLACING HIM INTO HIS VEHICLE.

MR. MISTLER INFORMED THIS DETECTIVE THAT ON THAT DAY HE WAS OVER AT THE SEARS MALL FOR THE PURPOSE OF PURCHASING SOME EQUIPMENT TO GO CAMPING WITH HIS FAMILY THAT WEEK. AFTER MAKING THIS PURCHASE, MR. MISTLER RETURNED TO HIS RESIDENCE. A SHORT TIME THEREAFTER, MR. MISTLER ADVISED THAT HE NEEDED ADDITIONAL ITEMS AND BOTH HE AND HIS WIFE RETURNED TO THE SEARS MALL. IT WAS AT THAT TIME THAT MR. MISTLER RECALLS HEARING PAGING WITHIN THE SEARS STORE FOR ADAM WALSH. AFTER MAKING THIS ADDITIONAL PURCHASE, BOTH MR. AND MRS. MISTLER LEFT SEARS AND PROCEEDED ON THEIR VACATION.

WHEN MR. MISTLER RETURNED FROM THEIR VACATION, HE RECALLED THAT HIS NEIGHBOR'S SON IDENTIFIED AS CHRIS CLUM CAME UP TO THEIR RESIDENCE AND STARTED TO TELL HIS SON THAT ADAM WALSH HAD BEEN KIDNAPPED. WHEN MR. MISTLER BEGAN TO READ NEWSPAPER AND MEDIA ACCOUNTS OF THIS ABDUCTION, THEY DESCRIBED A BLUE VAN BEING INVOLVED IN THE ABDUCTION OF ADAM WALSH. BASED ON THAT INFORMATION, MR. MISTLER STATED THAT HE DID NOT PUT TWO (2) AND TWO (2) TOGETHER RELATING THE INCIDENT THAT HE HAD WITNESSED HAD NOTHING TO DO WITH THE ADAM WALSH ABDUCTION.

IN 1983 WHEN OTIS TOOLE BECAME THE FOCUS OF THE HOLLYWOOD POLICE DEPARTMENT'S INVESTIGATION, MR. MISTLER STATED THAT HE BELIEVED THAT THERE WERE OTHER WITNESSES TO THIS AND AT THAT TIME THOUGHT THAT OTIS TOOLE HAD BEEN ARRESTED AND CHARGED IN THE ADAM WALSH MURDER. FROM THAT TIME UNTIL THE PRESENT TIME WHEN MR. MISTLER HAD READ THE NEWSPAPER ARTICLE CONCERNING MAJOR J. B. SMITH, HE STATES THAT HE NEVER KNEW THAT OTIS TOOLE HAD NEVER BEEN CHARGED WITH THE MURDER OF ADAM WALSH. THESE WERE THE REASONS THAT CAUSED MR. MISTLER TO COME FORWARD AT THIS TIME.

THIS DETECTIVE THEN MADE AN APPOINTMENT WITH WILLIAM CARL MISTLER TO COME INTO HOLLYWOOD POLICE HEADQUARTERS AND FURNISH THIS DETECTIVE WITH A FREE AND VOLUNTARY SWORN STATEMENT CONCERNING THIS MATTER. ON JULY 29TH, 1991, AT 1240 HOURS, THIS DETECTIVE TOOK A FREE AND VOLUNTARY SWORN STATEMENT FROM WILLIAM CARL MISTLER. MR. MISTLER ADVISED THAT HE IS MARRIED SEVENTEEN (17) YEARS AND HAS BEEN LIVING IN SOUTH FLORIDA SINCE 1970. PRIOR TO 1970, HE WAS LIVING IN ERLINGER, KENTUCKY. MR. MISTLER FURNISHED THIS DETECTIVE WITH THE ADDRESS OF 2936 F STIRLING ROAD, HOLLYWOOD, TELEPHONE NUMBER: 920-6591 WHICH IS HIS EXTERMINATING BUSINESS. MR. MISTLER WAS VERY APPREHENSIVE ABOUT FURNISHING THIS DETECTIVE WITH HIS RESIDENCE ADDRESS DUE TO THE FACT THAT HE BELIEVED THAT THERE WOULD BE TREMENDOUS MEDIA COVERAGE SHOULD HIS NAME BE LEAKED TO THE PRESS REGARDING THIS HOMICIDE INVESTIGATION.

DURING THE TAKING OF MR. MISTLER'S STATEMENT, HE BECAME EXTREMELY EMOTIONALLY UPSET ON TWO (2) OCCASIONS DURING THE TAKING OF THIS STATEMENT. IT APPEARED THAT MR. MISTLER HAS A TREMENDOUS GUILT FEELING DUE TO THE FACT THAT THE INCIDENT THAT HE BELIEVES HE WITNESSED, MAY HAVE PREVENTED THE DEATH OF ADAM WALSH IF MR. MISTLER REACTED DIFFERENTLY TO THIS INCIDENT.

WILLIAM MISTLER WAS EMPATHIC ABOUT THE IDENTIFICATION OF THE WHITE MALE THAT HE SAW EXITING THE BLACK OVER WHITE CADILLAC AS BEING OTIS TOOLE. MR. MISTLER HAD SEEN BOTH TELEVISION AND NEWSPAPER PHOTOGRAPHS OF OTIS TOOLE AND IS 100% CERTAIN THAT THE PERSON THAT HE WITNESSED ON THAT DAY WAS IN FACT OTIS TOOLE.

THIS DETECTIVE THEN MADE AN APPOINTMENT WITH WILLIAM MISTLER TO TAKE A POLYGRAPH EXAMINATION ON TUESDAY, 07/30/91.

TUESDAY, 07/30/91, AT 1500 HOURS, WILLIAM MISTLER ARRIVED AT HOLLYWOOD POLICE HEADQUARTERS AND WAS INTRODUCED TO DETECTIVE DIECIOUE WHO WOULD BE CONDUCTING THE POLYGRAPH EXAMINATION. UPON COMPLETION OF THE POLYGRAPH

EXAMINATION BY DETECTIVE DICEDEU, HE INFORMED THIS DETECTIVE THAT THE RESULTS OF THIS POLYGRAPH WERE INCONCLUSIVE.

THIS DETECTIVE THEN SPOKE WITH WILLIAM MISTLER AND ASKED HIM IF HE WOULD BE WILLING TO UNDERGO HYPNOSIS IN AN ATTEMPT TO HEIGHTEN HIS RECALL OF THIS INCIDENT FROM TEN (10) YEARS AGO. MR. MISTLER STATED THAT HE WOULD UNDERGO HYPNOSIS TO ASSIST THIS AGENCY IN THIS INVESTIGATION.

THIS DETECTIVE THEN CONTACTED THE B.S.O. PSYCHOLOGICAL SERVICES UNIT, COMMANDER MARIE STEMPKOWSKI, AND INFORMED HER OF THIS AGENCY'S INVESTIGATION. COMMANDER STEMPKOWSKI ADVISED THAT SHE WOULD MAKE THE NECESSARY ARRANGEMENTS IN ORDER TO HAVE SUBJECT WILLIAM MISTLER INFNOTIZED BY DOCTOR HARLEY STOCK, P.H.D., WITH THE B.S.O. PSYCHOLOGICAL SERVICES UNIT. AN APPOINTMENT WAS SET FOR FRIDAY, 08/02/91, AT 9 A.M.

FRIDAY, 08/02/91, AT APPROXIMATELY 0830 HOURS, WILLIAM MISTLER MET WITH THE UNDERSIGNED DETECTIVE AT HOLLYWOOD POLICE HEADQUARTERS. AT THAT TIME, THIS DETECTIVE AND WILLIAM MISTLER PROCEEDED TO THE B.S.O. PSYCHOLOGICAL SERVICES UNIT IN PLANTATION. AT APPROXIMATELY 0900 HOURS, WILLIAM MISTLER WAS INTRODUCED TO COMMANDER STEMPKOWSKI, DOCTOR HARLEY STOCK, AND SERGEANT PHIL AMAVILLE OF B.S.O. PSYCHOLOGICAL SERVICES UNIT.

AFTER BEING INTRODUCED TO THE AFOREMENTIONED SUBJECTS, WILLIAM MISTLER THEN UNDERWENT A PREHYPNOSIS INTERVIEW. DURING THIS PREHYPNOSIS INTERVIEW, WILLIAM MISTLER BECAME EMOTIONALLY UPSET TO THE POINT THAT DOCTOR HARLEY STOCK INDICATED THAT THEY COULD NOT DO THE HYPNOSIS AT THIS TIME. A DECISION WAS MADE THAT A COGNITIVE INTERVIEW BE CONDUCTED WITH WILLIAM MISTLER AT THE SEARS MALL.

THIS DETECTIVE ALONG WITH WILLIAM MISTLER THEN RETURNED TO THE CITY OF HOLLYWOOD AND DROVE TO THE WEST PARKING LOT OF THE SEARS MALL. COMMANDER STEMPKOWSKI, DOCTOR HARLEY STOCK, AND SERGEANT PHIL AMAVILLE ALSO ARRIVED AT

THIS LOCATION. AT APPROXIMATELY 1030 HOURS, A COGNITIVE INTERVIEW WITH WILLIAM MISTLER WAS CONDUCTED BY DOCTOR HARLEY STOCK. DURING THE COGNITIVE INTERVIEW, MR. MISTLER REITERATED THE SAME INFORMATION THAT HE HAD FURNISHED THIS DETECTIVE WITH IN HIS VOLUNTARY SWEORN STATEMENT; AS TO HOW OTIS TOOLED DROVE UP IN A BLACK OVER WHITE 4DR CADILLAC, EXITED HIS VEHICLE, AND APPROACHED A WHITE MALE CHILD APPROXIMATELY FIVE (5) TO SIX (6) YEARS OF AGE. MR. MISTLER COULD NOT RECALL THE DESCRIPTION OF THE CLOTHING THAT THE CHILD WAS WEARING AT THAT TIME. UPON THE COMPLETION OF THE COGNITIVE INTERVIEW, THIS DETECTIVE AND COMMANDER STEMPKOWSKI SPOKE WITH MR. MISTLER WHO ADVISED THAT HE WOULD ATTEMPT TO UNDERGO THE HYPNOSIS AT A LATER TIME.

FRIDAY, 09/20/91, AT APPROXIMATELY 1305 HOURS, THIS DETECTIVE AND WILLIAM MISTLER ARRIVED AT B.S.O. PSYCHOLOGICAL SERVICES UNIT LOCATED AT 1204 NORTH UNIVERSITY DRIVE, PLANTATION. AT THAT TIME, THIS DETECTIVE MET WITH COMMANDER STEMPKOWSKI, DOCTOR HARLEY STOCK, AND DETECTIVE CHUCK EDELL WHO WOULD BE CONDUCTING THE HYPNOSIS SESSION.

IT SHOULD BE NOTED THAT THIS PREHYPNOSIS INTERVIEW AND ALSO THE HYPNOSIS SESSION WAS VIDEO TAPE FOR THIS AGENCY. A PREHYPNOSIS INTERVIEW WAS CONDUCTED BY DOCTOR HARLEY STOCK WITH WILLIAM MISTLER. MR. MISTLER BASICALLY WENT OVER THE SAME INFORMATION THAT HE HAD FURNISHED THIS DETECTIVE WITH EARLIER IN THIS INVESTIGATION AND ALSO AT THE COGNITIVE INTERVIEW CONDUCTED ON 08/02/91.

FOLLOWING THE PREHYPNOSIS INTERVIEW, THE HYPNOSIS SESSION BEGAN AT 1422 HOURS BY DOCTOR HARLEY STOCK. DURING THE HYPNOSIS SESSION, WILLIAM MISTLER RELATED THAT THE VEHICLE THAT OTIS TOOLED WAS OPERATING, THAT BEING A BLACK OVER WHITE CADILLAC, WAS RUSTY ALONG THE HOOD OF THE VEHICLE. HE DESCRIBED OTIS TOOLED AS HAVING REDDISH BROWN HAIR, A TWO (2) WEEK OLD BEARD, WEIRD EYES, GREENISH TEETH, YELLOW STAINED SHIRT, DARK PANTS, AND BROWN SHOES. MR. MISTLER STATES THAT OTIS TOOLED THEN EXITED HIS VEHICLE AND WALKED OVER TO THE CURB

WHERE THE LITTLE BOY WAS STANDING. STANDING NEXT TO THIS CHILD WAS AN OLDER WOMAN AND A FOURTEEN (14) YEAR OLD BOY. MR. MISTLER DESCRIBES THE OLDER WOMAN STANDING THERE GOING THROUGH HER POCKETBOOK LOOKING FOR SOMETHING AS OTIS TOOLED EXITED HIS VEHICLE AND WALKED UP TO THE CHILD. THE CHILD, ACCORDING TO WILLIAM MISTLER, WAS WEARING A BALL CAP AND WHITE SHOES. THE CHILD DID NOT APPEAR TO BE FRIGHTENED OR DID NOT RESIST IN ANY WAY. MR. MISTLER REMEMBERS OTIS TOOLED KNEELING DOWN AND SPEAKING WITH THE CHILD AND THEN EVENTUALLY TAKING HIM BY HIS HAND AND WALKING HIM BACK TO THE DRIVER'S SIDE OF HIS VEHICLE AND PLACING THE CHILD INTO SAID VEHICLE. AS MR. MISTLER MOVES HIS VEHICLE PASSED OTIS TOOLES VEHICLE, HE RECALLS A LICENSE PLATE BUT HE IS NOT SURE IF IT IS OUT OF STATE OR FLORIDA. HE DESCRIBES IT AS BEING GREEN AND WHITE AND POSSIBLY THE NUMBERS 508.

DURING THE HYPNOSIS SESSION, MR. MISTLER DID NOT RECALL ANY ADDITIONAL INFORMATION THAT HE HAD PROVIDED THIS AGENCY WITH PREVIOUSLY TO BEING HYPNOTIZED. UPON COMPLETION OF THIS HYPNOSIS SESSION, MR. MISTLER AND THE UNDERSIGNED DETECTIVE RETURNED BACK TO HOLLYWOOD POLICE DEPARTMENT.

SINCE THE HYPNOSIS SESSION, THIS DETECTIVE HAD SPOKEN WITH WILLIAM MISTLER ON A COUPLE OF OCCASIONS REGARDING WHY HE DID NOT FURNISH THIS INFORMATION TO THE HOLLYWOOD POLICE DEPARTMENT OR ANY AGENCY WHEN ADAM WALSH'S PICTURE WAS IN EVERY NEWSPAPER AND TELEVISION NEWSCAST. MR. MISTLER CONTINUED TO INSIST THAT THE INFORMATION THAT THE NEWS MEDIA WAS GIVING OUT WAS THAT OF A BLUE VAN BEING INVOLVED IN THIS ABDUCTION. ONCE MR. MISTLER BELIEVED THAT A BLUE VAN WAS INVOLVED, THE INCIDENT THAT HE WITNESSED HE FELT HAD NOTHING TO DO WITH THE ABDUCTION OF ADAM WALSH. THIS DETECTIVE THEN ASKED MR. MISTLER AS TO WHY HE BELIEVED OTIS TOOLED HAD BEEN CHARGED IN THE ADAM WALSH CASE WITH HIS MURDER. MR. MISTLER STATED THAT HE SAW A PRESS CONFERENCE THAT WAS GIVEN BY THE ASSISTANT POLICE CHIEF AND POLICE CHIEF OF THE HOLLYWOOD POLICE DEPARTMENT REGARDING OTIS TOOLED AND HE THOUGHT THAT OTIS TOOLED HAD BEEN CHARGED WITH ADAM

WALSH'S MURDER. AFTER THAT, MR. MISTLER STATED THAT HE DID NOT FOLLOW THE CASE ANY FURTHER BY READING NEWSPAPER ACCOUNTS OR SEEING THE TELEVISION NEWS ACCOUNTS OF THIS MURDER.

THIS DETECTIVE THEN INFORMED SERGEANT CASTIGLIONE OF THE HOLLYWOOD POLICE DEPARTMENT HOMICIDE DIVISION OF THIS INVESTIGATOR'S ONGOING INVESTIGATION. IT WAS THEN DECIDED THAT IT WOULD BE NECESSARY FOR THIS DETECTIVE TO REINTERVIEW OTIS TOOLE WHO WAS CURRENTLY INCARCERATED AT FLORIDA STATE PRISON IN STARK, FLORIDA. THIS DETECTIVE THEN MADE TELEPHONE CONTACT WITH FORMER F.B.I. AGENT WILLIAM HAGGERTY WHO HAD ALSO PREVIOUSLY INTERVIEWED OTIS TOOLE REGARDING THIS AGENCY'S HOMICIDE AND OTHER UNSOLVED HOMICIDES. WILLIAM HAGGERTY INFORMED THIS DETECTIVE THAT HE WOULD BE WILLING TO GO TO FLORIDA STATE PRISON WITH THE UNDERSIGNED DETECTIVE AND REINTERVIEW OTIS TOOLE.

THURSDAY, 10/17/91, THIS DETECTIVE FLEW TO TALLAHASSEE, FLORIDA, AND MET WITH FORMER F.B.I. AGENT WILLIAM HAGGERTY. AT THAT TIME, THIS DETECTIVE AND WILLIAM HAGGERTY DROVE TO FLORIDA STATE PRISON IN STARK, FLORIDA.

THURSDAY, 10/17/91, AT 1325 HOURS, THIS DETECTIVE ALONG WITH WILLIAM HAGGERTY MET WITH OTIS TOOLE. AT THAT TIME, AN INTERVIEW WAS CONDUCTED WITH SUBJECT OTIS TOOLE. DURING THIS INTERVIEW, OTIS TOOLE HAD INFORMED THIS DETECTIVE THAT HE IS FRESENTLY SERVING FOUR (4) CONSECUTIVE LIFE SENTENCES FOR OTHER UNRELATED HOMICIDES COMMITTED IN THE STATE OF FLORIDA. OTIS TOOLE INFORMED THIS DETECTIVE AND WILLIAM HAGGERTY THAT HE WAS NOT INVOLVED IN THE ADAM WALSH KIDNAPPING/HOMICIDE BACK IN JULY, 1981. OTIS TOOLE STATED THAT HE RETURNED TO THE JACKSONVILLE AREA FROM VIRGINIA IN JULY, 1981, AND NEVER LEFT THE CITY OF JACKSONVILLE FROM THAT DATE FORWARD. OTIS TOOLE STATED THAT WHEN HE FIRST ADMITTED TO HIS INVOLVEMENT IN THE ADAM WALSH CASE BACK IN 1983, THE PURPOSE FOR HIM LYING TO LAW ENFORCEMENT AGENCIES THROUGHOUT THE STATE AND COUNTY WAS FOR HIS OWN PERSONAL GAIN, THAT WAS BEING ABLE TO BE TAKEN OUT

ON LOCATIONS, BEING FEED, AND GIVEN CIGARETTES BY ALL OFFICERS THAT HAD INTERVIEWED HIM.

OTIS TOOLE FURTHER STATED THAT WHILE HE WAS BEING HOUSED IN JACKSONVILLE, DETECTIVE TERRY OF THE JACKSONVILLE SHERIFF'S DEPARTMENT GAVE TOOLE INFORMATION FROM OTHER AGENCIES' CASE FOLDERS PRIOR TO THESE DETECTIVES' INTERVIEWS WITH OTIS TOOLE. BASED ON THE INFORMATION THAT DETECTIVE TERRY FURNISHED OTIS TOOLE WITH, TOOLE WAS ABLE TO GIVE INVESTIGATORS INFORMATION PERTAINING TO THEIR HOMICIDES THAT WOULD LEAD THEM TO BELIEVE THAT TOOLE MAY BE INVOLVED IN THEIR CASES.

OTIS TOOLE THEN INFORMED THIS DETECTIVE THAT HE WAS APPROACHED BY ANOTHER INMATE IDENTIFIED AS GERALD SCHAFER WHO IS CURRENTLY SERVING LIFE SENTENCES FOR MURDER IN THE STATE OF FLORIDA. MR. SCHAFER ASKED OTIS TOOLE IF HE WOULD BE INTERESTED IN WRITING A BOOK ABOUT THE MURDERS THAT OTIS AND HENRY LUCAS WERE INVOLVED IN AND ALSO INCLUDING THE ADAM WALSH CASE. GERALD SCHAFER TOLD OTIS TOOLE THAT HE KNEW THIS AUTHOR SON德拉 LONDON, AKA MEDIA QUEEN, WHO WOULD GIVE TOOLE MONTHLY SUMS OF MONEY IF TOOLE GAVE BOTH SCHAFER AND SON德拉 LONDON THE RIGHTS TO HIS BOOK. OTIS TOOLE STATED THAT HE TOLD GERALD SCHAFER THAT HE DID NOT COMMIT THE ADAM WALSH MURDER, BUT SCHAFER TOLD HIM TO CONFESS TO THE MURDER ANYWAY BECAUSE IT WOULD SELL MORE BOOKS. SINCE THAT TIME, OTIS TOOLE HAS NOT HAD ANY MORE CONTACT WITH GERALD SCHAFER. UPON CONCLUDING THE INTERVIEW WITH OTIS TOOLE, THIS DETECTIVE THEN MET WITH ASSISTANT SUPERINTENDENT PAUL DECKER. MR. DECKER HAD INFORMED THIS DETECTIVE THAT THE SUBJECT GERALD SCHAFER HAS BEEN WORKING WITH AN AUTHOR IDENTIFIED AS SON德拉 LONDON, AKA MEDIA QUEEN, WHO IS OUT OF ATLANTA, GEORGIA.
