THE FOLLOWING IS THE SECOND SUPPLEMENT REPORT SUBMITTED BY DETECTIVE MARK SMITH.

AS PREVIOUSLY STATED IN THIS DETECTIVE'S INITIAL SUPPLEMENT REPORT, A RE-INTERVIEW WAS TO BE ATTEMPTED WITH OTTIS TOOLE WHEN ALL ATTEMPTS TO LOCATE PHYSICAL EVIDENCE REGARDING THE INVESTIGATION INTO HIS POSSIBLE INVOLVEMENT HAD BEEN EXHAUSTED. BELIEVING THIS TO BE THE CASE AT LEAST AS OF THE DATE OF 6-23-95, THIS DETECTIVE MADE ARRANGEMENTS WITH THE UNION CORRECTIONAL INSTITUTE IN STARKE, FLORIDA TO INTERVIEW TOOLE ON 7-27-95.

THIS DETECTIVE, ACCOMPANIED BY DET. NAVARRO, RESPONDED TO THE U.C.I. FOR THE PURPOSE OF THIS INTERVIEW AT APPROXIMATELY 8:15A.M. ON SAID DATE. THESE DETECTIVES MADE CONTACT WITH INMATE COUNSELOR GENE SLOCUMB WHO MADE ARRANGEMENTS FOR TOOLE TO BE DELIVERED TO AN INTERVIEW ROOM LOCATED ADJACENT TO THE ADMINISTRATION BUILDING. THESE DETECTIVES WERE INFORMED BY PERSONNEL THAT TOOLE IS BELIEVED TO BE SUFFERING FROM ACTIVE HEPATITIS B AND C AND CAUTION SHOULD BE USED DURING THE INTERVIEW. TOOLE WAS BROUGHT TO THE INTERVIEW ROOM AT APPROXIMATELY 8:45A.M. FASHIONED WITH A SURGICAL MASK AS A PRECAUTION AGAINST TRANSMITTING HIS SUSPECTED DISEASE. THESE DETECTIVES ENTERED THE INTERVIEW ROOM WITH SIMILAR MASKS FOR PRECAUTIONARY REASONS AND MADE AN INTRODUCTION WITH TOOLE. TOOLE HAD NO INITIAL RESPONSE TO THE INTRODUCTION UNTIL HE WAS INFORMED OF THE PURPOSE OF THE INTERVIEW. ~~TOOLE'S INITIAL REACTION APPEARED THAT HE WAS DISTURBED AND STATED THAT HE HAD NO INVOLVEMENT~~ IN THIS CASE OR ANY OTHER CASE, INCLUDING THE ONE WHICH HE WAS CONVICTED OF. TOOLE, WHO APPEARS SOFT-SPOKEN BY NATURE, NEVER RAISED HIS VOICE BUT DID APPEAR TO BE SOMEWHAT DISTURBED INITIALLY. AFTER APPROXIMATELY 30 MINUTES OF GENERAL CONVERSATION, TOOLE AGREED TO BE INTERVIEWED AND TAPE RECORDED BY THESE DETECTIVES. BEFORE TOOLE WAS ASKED ANY SPECIFIC QUESTIONS REGARDING THIS CASE, THIS DETECTIVE INFORMED TOOLE OF HIS CONSTITUTIONAL RIGHTS WHICH HE STATED HE UNDERSTOOD AND PROCEEDED WITH THE TAPE RECORDED INTERVIEW.

DURING THE INTERVIEW, TOOLE WAS SPOKEN TO IN GENERAL, AS WELL AS ABOUT SPECIFICS ABOUT THIS CASE. WHEN SPEAKING ABOUT THIS CASE, ~~TOOLE DENIED ANY INVOLVEMENT AND STATED THAT HE WOULD DRIVE THE VEHICLE HE HAD RECENTLY~~ ADMITTED TO DRIVING TO HOLLYWOOD WHERE HE STATED HE ABDUCTED THE VICTIM IN THIS CASE AND SUBSEQUENTLY TRAVELLING WITH HIM NORTH ON THE TURNPIKE. THIS TAPED STATEMENT MAY OR MAY NOT BE TRANSCRIBED DUE TO THE VOLUME AND MANNER OF TOOLE'S SPEECH WHICH WOULD MAKE TRANSCRIPTION DIFFICULT. THE TAPE HOWEVER WILL BE MAINTAINED AS EVIDENCE IN THIS CASE. TOOLE APPEARED TO TIRE AND/OR BECOME DISTRACTED NEAR THE END OF THE TAPED STATEMENT AND AGREED TO SPEAK WITH THESE DETECTIVES THE FOLLOWING DATE. THIS INTERVIEW WAS TERMINATED WITH THE UNDERSTANDING THAT RE-CONTACT WOULD BE MADE AND TOOLE WAS RETURNED TO THE MEDICAL UNIT AT THE U.C.I. BECAUSE OF HIS SUSPECTED CONDITION. WHAT SHOULD BE NOTED IS THAT, ALTHOUGH TOOLE WAS SUSPECTED TO HAVE THE HEPATITIS VIRUS, HE APPEARED COHERENT AND PHYSICALLY ABLE TO FUNCTION WITHOUT ANY ASSISTANCE.

THESE DETECTIVES NEXT RESPONDED TO THE FLORIDA STATE PRISON LOCATED NEXT TO THE U.C.I. FOR THE PURPOSE OF INTERVIEWING TWO ACQUAINTANCES AND FORMER CELLMATES OF TOOLE AT THE STATE PRISON. TOOLE HAS BEEN INCARCERATED

AT THE FLORIDA STATE PRISON SINCE HIS CONVICTION ON FIRST DEGREE MURDER CHARGES AND WAS RECENTLY TRANSFERRED TO THE MEDICAL FACILITY AT THE U.C.I. ON 6-22-95 BECAUSE OF HIS ILLNESS.

[REDACTED], WERE SUBSEQUENTLY INTERVIEWED SEPERATELY IN AN INTERVIEW ROOM AT THE F.S.P.. [REDACTED] WHO HAS BEEN INCARCERATED IN THE F.S.P. SINCE JUNE 1990 FOR SEXUAL BATTERY, TRAFFICKING IN COCAINE, AND ESCAPE, MADE AN IMMEDIATE RESPONSE THAT THESE DETECTIVES WERE THERE TO SPEAK WITH HIM REGARDING THE ADAM WALSH CASE AFTER THESE DETECTIVES MADE AN INTRODUCTION. [REDACTED] MADE THIS DEDUCTION AFTER THE WORDS HOLLYWOOD POLICE DEPT. WERE UTTERED. [REDACTED] ALSO DEDUCED THAT THESE DETECTIVES WERE TO INTERVIEW HIM REGARDING HIS ASSOCIATION WITH OTTIS TOOLE. [REDACTED] AGREED TO PROVIDE THESE DETECTIVES WITH A SWORN TAPED STATEMENT REGARDING HIS ASSOCIATION AND HIS CONVERSATION WITH TOOLE ABOUT THIS CASE. [REDACTED] WAS INITIALLY HESITANT ABOUT TAPE RECORDING THE CONVERSATION BUT LATER AGREED TO DO SO.

[REDACTED] BECAME EMOTIONAL AND BEGAN TO CRY WHEN [REDACTED] THAT HE HAD ENOUGH INFORMATION TO PUT TOOLE IN THE [REDACTED] DESPITE REPEATED REQUESTS BY BOTH DETECTIVES. [REDACTED] [REDACTED] BASED ON THIS INTERVIEW WITH [REDACTED] THESE DETECTIVES WERE OF THE OPINION THAT TOOLE DID AT LEAST HAVE CONVERSATION WITH [REDACTED] AND THAT HIS KNOWLEDGE OF TOOLE'S POSSIBLE INVOLVEMENT IN THIS CASE MAY BE VALUABLE IF IN FACT HE WAS. EFFORTS WILL BE MADE TO RE-APPROACH [REDACTED]

IN THE NEAR FUTURE FOR A VOLUNTARY STATEMENT REGARDING THIS UNDETERMINED KNOWLEDGE OF THIS CASE. WHAT SHOULD BE NOTED IS THAT [REDACTED] PROVIDED THIS STATEMENT VOLUNTARILY WITHOUT ANY THREAT OR PROMISE BY EITHER DETECTIVE. IN FACT, THE INTERVIEW WAS PREFACED WITH THE FACT THAT NEITHER COULD ASSIS [REDACTED] IN ANY WAY. [REDACTED] TAPED STATEMENT WILL BE SUBMITTED FOR TRANSCRIPTION AND WILL BE MAINTAINED AS PERMANENT RECORD IN THIS CASE.

THESE DETECTIVES THEN INTERVIEWED GERARD SCHAEFER. MR. SCHAEFER HAS BEEN INCARCERATED IN THE STATE PRISON SINCE 1973 FOR FIRST DEGREE MURDER. SCHAEFER HAD SURFACED IN THE ORIGINAL INVESTIGATION IN 1988 WHEN HE AUTHORED A LETTER TO THE BROWARD SHERIFF'S OFFICE REGARDING THE ADAM WALSH CASE. SCHAEFER'S LETTER WAS FOLLOWED BY AN INTERVIEW WITH HIM BY DETECTIVES FANTIGRASSI AND SCHEFF FROM THE B.S.O. AT THE STATE PRISON. SCHAEFER STATED THEN THAT HE WOULD ASSIST THE B.S.O. DETECTIVES WITH OTTIS TOOLE REGARDING HIS ADMISSIONS TO HIM PREVIOUSLY. IN THIS INTERVIEW IN 1988, SCHAEFER ENCOURAGED TOOLE AND ACTED AS THE MIDDLE MAN OF SORTS.

THE PURPOSE FOR THE RE-INTERVIEW WITH SCHAEFER BY THESE DETECTIVES WAS TO DETERMINE IF SCHAEFER REMAINED WITH HIS ORIGINAL STATEMENT TO THE B.S.O. DETECTIVES REGARDING TOOLE'S STATEMENTS TO HIM, OR IF THERE WERE ANY FURTHER STATEMENTS MADE TO HIM SINCE THAT TIME. SCHAEFER REMEMBERED THE INTERVIEW WITH THE B.S.O. DETECTIVES AND HIS MEMORY WAS FAIRLY CLEAR REGARDING ITS CONTENT. [REDACTED] THAT TOOLE ANSWERED TO HIM ANY [REDACTED]

AGAIN TO THESE DETECTIVES AND STATED THAT HE COULD BE USED TO CONVINCE TOOLE TO SPEAK TRUTHFULLY AND AGAIN ADMIT TO THIS CRIME. SCHAEFER'S SINCERITY WILL BE EVALUATED AND HE MAY BE APPROACHED AGAIN.

ON 6-21-95 THIS DETECTIVE RECEIVED A VOLUNTARY SWORN TAPED STATEMENT

FROM [REDACTED] W/M 5-24-68 WHICH WAS CONDUCTED AT THE OFFICE OF FEDERAL PROBATION OFFICER TERRY GRAVES, ON 6-20-95, THIS DETECTIVE RECEIVED A PHONE CALL FROM MR. GRAVES REGARDING MONAHAN WHO IS HIS PROBATIONER. MR. GRAVES INFORMED THIS DETECTIVE THAT HE HAD RECEIVED A PHONE CALL FROM MONAHAN REGARDING RECENT NEWSPAPER ARTICLES ABOUT HIS POSSIBLE INVOLVEMENT IN THE ADAM WALSH MURDER. MR. GRAVES WAS CONCERNED WITH THE ACCUSATION BECAUSE MONAHAN WAS HIS PROBATIONER AND WANTED TO KNOW IF THERE WAS ANY CREDENCE TO IT. MR. GRAVES ADDED THAT MONAHAN WAS NOTIFYING HIM AS REQUIRED WHEN HE IS INVOLVED IN A CRIMINAL INVESTIGATION. MR. GRAVES WAS INFORMED THAT, DUE ONLY TO THE RECENT NEWSPAPER ARTICLES, IT WOULD BE NECESSARY FOR THIS DETECTIVE TO SPEAK WITH MONAHAN AND TO ARRANGE FOR A SWORN TAPED STATEMENT TO BE OBTAINED.

[REDACTED] IT IS BELIEVED THAT [REDACTED] IN THE MEDIA AS A RESULT OF AN [REDACTED] THIS DETECTIVE, ALONG WITH DET. SGT. DUNBAR, HAD EARLIER CONDUCTED AN INTERVIEW WITH THIS REPORTER, [REDACTED] MONAHAN COMMITTED THE MURDER OF ADAM WALSH AS A FRIEND FOR JAMES CAMPBELL AN ACQUAINTANCE OF THE WALSH FAMILY. MR. GRELEN WAS PROVIDED NO FEEDBACK BY EITHER DETECTIVE AND THE INTERVIEW WAS TERMINATED. THIS ALLEGATION WAS NOT GIVEN MUCH CREDENCE, AS THE WEAPON USED BY MONAHAN IN AN UNRELATED CASE AFTER THIS HOMICIDE, HAD BEEN EXAMINED WITH NEGATIVE RESULTS OF MAKING A CONNECTION WITH THIS HOMICIDE. IT SHOULD BE NOTED THAT THE FACT MONAHAN POSSESSED SUCH A WEAPON WAS NOT SUSPICIOUS IN NATURE, DUE TO HIS PROFESSION AT THE TIME. FURTHERMORE, THE MOTIVATION PROVIDED BY MR. GRELEN THAT MONAHAN COMMITTED THE MURDER AS A FRIEND FOR CAMPBELL, WAS BASED ON INFERENCES AND THE UNRELATED CRIME HE REFERRED TO WAS A FAR LEAP FROM [REDACTED] REGARDLESS, THIS DETECTIVE FELT IT TO BE WORTHWHILE TO CONDUCT AN INTERVIEW WITH MONAHAN BECAUSE OF THE FUROR CREATED BY THE NEWSPAPER ARTICLES. ON 6-20-95, MONAHAN PHONED THIS DETECTIVE AND STATED THAT HE WAS WILLING TO PROVIDE THIS DETECTIVE WITH A SWORN TAPED STATEMENT AND A POLYGRAPH IF REQUESTED ON 6-21-95.

THE INTERVIEW WAS CONDUCTED AT MR. GRAVES' OFFICE AS SCHEDULED WHEREIN MONAHAN WAS ASKED TO RECALL HIS ACTIONS ON AND AFTER THE DATES IN QUESTION. TO MONAHAN'S RECOLLECTION, HE WAS DRIVING WITH HIS GIRLFRIEND AT THE TIME, CHRIS FEHLHABER, NEAR HER FATHER'S HOME IN FT. LAUDERDALE WHEN HEARING OF THE ABDUCTION ON THE CAR RADIO SOMETIME IN THE LATE AFTERNOON. MONAHAN RECALLS RESPONDING TO THE WALSH RESIDENCE WITH MISS FEHLHABER TO ASSIST, AND RECALLS AT SOME POINT PASSING OUT FLIERS AS WELL AS SEARCHING THE NEIGHBORHOOD LOOKING FOR THE CHILD WITH HER. [REDACTED] MONAHAN STATED THAT HE WAS CLOSE TO ADAM AND THE WALSH FAMILY AND ASSOCIATED WITH THEM AT HIS FATHER'S RESIDENCE AS WELL AS THE BEACH. MONAHAN REFERRED TO JAMES CAMPBELL AS CLOSER TO ADAM AND THE WALSHES THAN HE AND BABY SAT HIM FREQUENTLY. REGARDING HIS ASSOCIATION WITH CAMPBELL, MONAHAN STATED THAT HE AND CAMPBELL WERE FRIENDS, BUT CAMPBELL WAS OLDER AND ASSOCIATED MORE WITH HIS OLDER BROTHER. MONAHAN DID STATE THAT HE STAYED AT CAMPBELL'S APARTMENT IN DAVIE FOR TWO NIGHTS, BUT DID NOT EVER CONSIDER THEMSELVES ROOMMATES. THE INTERVIEW WITH MONAHAN WAS TERMINATED USING THE FORMAT FOR A POSSIBLE VOICE STRESS ANALYSIS ALTHOUGH THERE WAS NOTHING TO INDICATE DECEPTION IN MONAHAN'S STATEMENT. A DETERMINATION WILL BE MADE AT A LATER DATE WHETHER TO SUBMIT THE STATEMENT FOR AN ANALYSIS AFTER THIS DETECTIVE ATTEMPTS TO ESTABLISH CORROBORATION IN MONAHAN'S STATEMENT. THIS WILL INCLUDE BUT NOT BE LIMITED TO A STATEMENT

FROM CHRIS FEHLHABER.

ON 6-22-95 THIS DETECTIVE MADE CONTACT WITH MISS FEHLHABER'S MOTHER MARJORIE SHAW AT THE RESIDENCE OF ANOTHER DAUGHTER IN FT. LAUDERDALE. MRS. SHAW STATED THAT HER DAUGHTER CHRISTIANA IS CURRENTLY MARRIED AND LIVING IN ST. LUCIE COUNTY. MRS. SHAW WAS INFORMED OF THE PURPOSE OF THIS CONTACT AND STATED THAT SHE WAS FAMILIAR WITH HER DAUGHTER'S AND MONAHAN'S ASSOCIATION DURING THE TIME OF THE ABDUCTION AND SUBSEQUENT DISCOVERY OF THE PARTIAL REMAINS OF THE VICTIM. MRS. SHAW STATED THAT MONAHAN AND HER DAUGHTER WERE IN FACT DATING DURING THAT TIME AND RECALLED THAT SHE WAS HOME WHEN HER DAUGHTER ACCOMPANIED MONAHAN WHEN THEY WENT TO LOOK FOR THE VICTIM AND PASS OUT FLIERS SHORTLY AFTER THE ABDUCTION. MRS. SHAW ALSO RECALLS BEING AT HOME WHEN IT WAS ANNOUNCED THAT ADAM WALSH'S PARTIAL REMAINS WERE IDENTIFIED, AND THAT MONAHAN AND HER DAUGHTER WERE AT THE BEACH AT THE TIME. WHEN THE TWO RETURNED HOME, MRS. SHAW STATED THAT SHE INFORMED THEM OF THE DISCOVERY AND ALL THREE BECAME EXTREMELY EMOTIONAL. MRS. SHAW ADDED THAT MONAHAN'S REACTION APPEARED SINCERE. AFTER THIS INTERVIEW, THIS DETECTIVE MADE ARRANGEMENTS TO INTERVIEW CHRISTIANA AT HER RESIDENCE ON 6-23-95.

ON THIS DATE, THIS DETECTIVE ARRIVED AT CHRISTIANA'S RESIDENCE AT APPROXIMATELY 10:45A.M. AND RECEIVED A SWORN TAPED STATEMENT FROM HER. CHRISTIANA STATED THAT SHE AND MONAHAN BEGAN DATING IN 1978 WHILE ATTENDING ST. THOMAS AQUINAS HIGH SCHOOL THROUGH 1981, EVEN AFTER SHE LEFT FOR COLLEGE IN THE FALL OF 1979. CHRISTIANA STATED THAT SHE WOULD RETURN HOME DURING THE SUMMERS AND THE TWO WERE STILL CONSIDERED BOYFRIEND/GIRLFRIEND. IN THE SUMMER OF 1981, CHRISTIANA RECALLS LEARNING OF THE ABDUCTION OF ADAM WALSH THROUGH MONAHAN EITHER THE SAME DAY OR THE DAY AFTER WHEN MONAHAN CAME TO HER FATHER'S HOME IN FT. LAUDERDALE. WHEN TOLD THAT MONAHAN'S RECOLLECTION WAS THAT THE TWO OF THEM WERE DRIVING IN HER GREEN CAMARO AND HEARD OF THE ABDUCTION OVER THE CAR RADIO, CHRISTIANA STATED THAT IT IS POSSIBLE BUT NOT CERTAIN DUE TO THE NUMBER OF YEARS PASSED. CHRISTIANA RECALLS GOING TO THE WALSH HOME, DRIVING AROUND A HOLLYWOOD NEIGHBORHOOD LOOKING FOR ADAM, AND RESPONDING TO THE HOLLYWOOD POLICE DEPT. IN ORDER TO PASS OUT FLIERS, ALL IN THE COMPANY OF MONAHAN. CHRISTIANA ALSO RECALLED THAT FROM THE POINT OF THE ABDUCTION TO THE TIME THE PARTIAL REMAINS WERE DISCOVERED, SHE AND MONAHAN WERE IN CONSTANT CONTACT EITHER IN PERSON OR BY PHONE. CHRISTIANA REMEMBERS MONAHAN'S ASSOCIATION WITH JAMES CAMPBELL AND CONSIDERED THEM FRIENDS BUT NOT CLOSE FRIENDS. SHE ALSO STATED THAT SHE ACCOMPANIED MONAHAN TO THE DIPLOMAT HOTEL POOL WHERE CAMPBELL WORKED AND SAW HIM THERE WITH ADAM ON NUMEROUS OCCASIONS. ~~CHRISTIANA DOES NOT BELIEVE THAT MONAHAN IS INVOLVED IN THE ABDUCTION/MURDER OF ADAM WALSH~~ BASING HER OPINION ON HER OBSERVATIONS OF HIS RELATIONSHIP WITH ADAM, AS WELL AS HER RELATIONSHIP WITH MONAHAN.

ON 7-3-95, THIS DETECTIVE OBTAINED A SWORN TAPED STATEMENT FROM PETER GENOVESE. GENOVESE WAS MENTIONED IN THIS DETECTIVE'S INITIAL SUPPLEMENT REPORT REGARDING CONVERSATION WITH THIS DETECTIVE ABOUT THIS INVESTIGATION, AS WELL AS ANOTHER HOMICIDE INVESTIGATION OCCURRING IN 1980. ~~GENOVESE HAS EARLIER STATED TO THIS DETECTIVE THAT HE CONTACTED AMERICA'S MOST WANTED IN CONNECTION WITH ANY POSSIBLE KNOWLEDGE HE MAY HAVE REGARDING THE ADAM WALSH MURDER.~~ GENOVESE RECALLED AN INDIVIDUAL WHO WAS EMPLOYED AT THE HESS GAS STATION LOCATED EAST OF 441 ON GRIFFIN RD. IN 1980 WHO HE FELT MAY HAVE BEEN INVOLVED IN THE ABDUCTION/MURDER. GENOVESE STATED THAT HE WAS 15 YEARS OLD AT THE TIME HE HEARD ABOUT THE ADAM WALSH ABDUCTION/MURDER, RECALLING THAT A POSSIBLE SUSPECT VEHICLE WAS A BLUE VAN. GENOVESE STATED THAT THE INDIVIDUAL HE WAS REFERRING TO DID IN FACT OWN AND OPERATE A LIGHT BLUE VAN

AT THE TIME A YOUNG W/F WAS FOUND MURDERED ON A HOLLYWOOD GOLF COURSE SHORTLY BEFORE THE ADAM WALSH MURDER. GENOVESE ADDED THAT THE MURDERED W/F WAS APPROXIMATELY 12 YEARS OF AGE AND WAS POSSIBLY DATING THE W/M OPERATOR OF THE BLUE VAN.

THIS DETECTIVE RESEARCHED WHAT GENOVESE REFERRED TO REGARDING THE MURDER OF THE YOUNG W/F AND DISCOVERED IT TO BE THAT OF STACY WYTRVA (80-46482) WHO HAD BEEN FOUND MURDERED ON 6-17-80 AT THE HILLCREST COUNTRY CLUB. WYTRVA HAD BEEN STANGLED AND THE INVESTIGATION CENTERED ON A RELATIONSHIP SHE HAD HAD WITH 30 YEAR OLD W/M ALZEMORE WILLIAM THIBAUT WHO WORKED AT THE PREVIOUSLY MENTIONED HESS GAS STATION. ACCORDING TO THAT INVESTIGATION, THIBAUT WAS THE PRIME AND ONLY FEASIBLE SUSPECT IN THAT CASE. THIBAUT RETAINED AN ATTORNEY DURING THE INVESTIGATION AND WAS NOT FURTHER IMPLICATED AT THAT TIME.

GENOVESE STATED THAT HE RECALLED THIS INDIVIDUAL'S BIZARRE BEHAVIOR AT THE GAS STATION FOLLOWING THE MURDER WHEN HE OBSERVED HIM TALKING ABOUT THE VICTIM, REFERRING TO HER AS HIS GIRLFRIEND. GENOVESE STATED THAT HE AND HIS FRIENDS WOULD PLAY IN THE WOODS ADJACENT TO THE GAS STATION VIRTUALLY EVERYDAY, AND WOULD OBSERVE THIBAUT AND HIS VAN AT THE GAS STATION. GENOVESE STATED THAT THIBAUT WOULD NORMALLY SIT IN HIS VAN WHICH HE STATED WAS EQUIPPED WITH A BED AND A STOVE. GENOVESE STATED THAT HE RECALLED SEEING A MACHETE WITH A BLACK HANDLE WHICH HE HAD A SHIRT WRAPPED AROUND. GENOVESE REMEMBERS THAT THIBAUT HAD A LARGE AMOUNT OF NEWSPAPERS STREWN ABOUT THE INSIDE OF HIS VAN AND COMMENTED ABOUT THE MURDER OF HIS GIRLFRIEND ON THE GOLF COUSE. GENOVESE RECALLS LATER THAT HE OBSERVED A NEWSCAST ABOUT THE MURDER WHERE IT WAS DISCUSSED THAT THE VICTIM RECEIVED ANT BITES AND/OR FINGERNAIL MARKS ON HER SKIN. UPON REVIEW OF THE FILE, THIS STATEMENT BY GENOVESE WAS IN FACT ACCURATE. GENOVESE REMEMBERS GOING TO THE GAS STATION THE FOLLOWING DAY, AND OBSERVED THIBAUT CLIPPING HIS UNUSUALLY LONG FINGERNAILS. GENOVESE RECALLS HIS FATHER ATTEMPTING TO, OR ACTUALLY CONTACTING A B.S.O. DEPUTY FRIEND OF HIS REGARDING HIS OBSERVATIONS. ATTEMPTS WILL BE MADE TO CORROBORATE THIS THROUGH HIS FATHER AND/OR FURTHER REVIEW OF THE FILE. A COMPUTER QUERY WAS CONDUCTED ON THIBAUT REVEALING A CRIMINAL HISTORY FOR BURGLARY AND NARCOTICS OFFENSES BOTH IN FT. LAUDERDALE AND FT. PIERCE. A DRIVER'S LICENSE QUERY REVEALED THAT THIBAUT IS CURRENTLY RESIDING IN FT. PIERCE. THIS DETECTIVE WILL CONTINUE TO INVESTIGATE THIS CASE REGARDING A POSSIBLE CONNECTION WITH THE ADAM WALSH CASE. THIS WILL INCLUDE DETERMINING IF THERE WAS A CONNECTION BETWEEN THIBAUT AND THE FT. PIERCE AREA IN 1980 OR 1981 THAT THERE IS IN 1995.

THIS INVESTIGATION WILL CONTINUE WITH A FOLLOW-UP INVESTIGATION REGARDING AN INTERVIEW WITH A THIBAUT ASSOCIATE AND ROOMMATE AT THE TIME OF THE WYTRVA MURDER. ATTEMPTS WILL BE MADE TO DETERMINE IF THE INFORMATION PROVIDED BY GENOVESE AND THE INVESTIGATION OF THE WYTRVA MURDER IS CONNECTED IN ANYWAY WITH INFORMATION THIS DETECTIVE RECEIVED FROM DET. HARROP OF THE COOPER CITY POLICE DEPT. REGARDING THE SAME TWO HOMICIDES. THE RESULTS WILL BE COVERED IN A FOLLOW-UP SUPPLEMENT REPORT.
