SYNOPSIS OF SUBJECTS INVOLVED IN ADAM WALSH HOMICIDE:

**** ALBERTS, RAYMOND-** TIP RECEIVED FROM CARROL, RONNIE THAT ALBERTS WAS RESPONSIBLE FOR THE MURDER OF ADAM WALSH. STATEMENT WAS TAKEN AND SUBJECT DENIED ANY INVOLVEMENT.

BAILEY, VERNON- FISHERMAN WHO DISCOVERED ADAM'S HEAD IN CANAL, INDIAN RIVER COUNTY

**** BENNETT, SPENCER-** OWNED A CAR DEALERSHIP IN JACKSONVILLE. SOLD SEVERAL VEHICLES OVER THE YEARS TO OTTIS TOOLE AND HIS FAMILY. WAS QUESTIONED ABOUT ANY KNOWLEDGE HE HAD REGARDING TOOLE.

****** GAVE STATEMENT REGARDING HER MARRIAGE TO WILLIAM HAROLD COLLINS. SHE ADVISED COLLINS HAD MOLESTED HER SMALL SON. COLLINS WAS A PERSONAL FRIEND OF THE WALSH FAMILY AND USE TO BABYSIT ADAM. SHE GAVE STATEMENT REGARDING HER SUSPICION OF COLLINS INVOLVMENT IN THE ABDUCTION/HOMICIDE.

**** CAULDER, MACK-** EMPLOYED AT SOUTHEAST COLOR COAT AT THE SAME TIME OTTIS TOOLE WAS. INTERVIEWED RE: WHAT TYPE OF TOOLS, TOOLE HAD ACCESS TO WHILE EMPLOYED THERE.

**** CAMPBELL, JAMES-** LONGTIME FAMILY FRIEND WHO LIVED WITH THE WALSHES FOR SEVERAL YEARS. CAMPBELL MOVED OUT OF THE WALSH RESIDENCE APPROXIMATELY ONE WEEK BEFORE ADAM WALSH WAS ABDUCTED. IT WAS LATER DISCOVERED THAT JAMES CAMPBELL AND REVE WALSH WERE HAVING AN AFFAIR. JAMES CAMPBELL WAS AT ONE POINT CONSIDERED A SUSPECT IN THIS INVESTIGATION, BUT SUBJECT WAS CLEARED AFTER SUBMITTING TO AND PASSING TWO SEPERATE POLYGRAPH EXAMINATIONS.

**** CARROLL, RONNIE-** CALLED HPD RE: INFORMATION HE OBTAINED RE: RAYMOND ALBERTS BRAGGING ABOUT THE MURDER OF ADAM WALSH. CARROLL ALSO ADVISED DETECTIVES THAT ALBERTS HAD 8X10 PICTURES OF ADAMS HEAD ON A MARBLE STICK. LATER RECANTED HIS STORY. ADVISED HE WAS INVOLVED IN A HIT & RUN ACCIDENT AND WAS HOPING THAT DETECTIVES WOULD BE LENIENT ON HIM IF HE WAS PROVIDING INFORMATION RE: THIS HOMICIDE.

CARTER, JAMES- WORKS FOR ST LUCIE CO SHERIFF'S OFFICE AND OWNED THE PROPERTY WHERE OTTIS TOOLE CLAIMED HE BURIED ADAM WALSHES BODY. STATEMENT WAS TAKEN REGARDING SGT CARTER GIVING PERMISSION TO EXCAVATE THE AREA.

CASEY, DIANNA- SAW POSSIBLE SUSPECTS IN ADAM WALSH ABDUCTION, MET W/ POLICE TO GIVE DESCRIPTION FOR COMPOSITE SKETCHES.

**** CHANDLER, MRS.-** EMPLOYEE OF THE SALVATION ARMY IN NEWPORT NEWS, VIRGINIA. MADE ARRANGEMENTS FOR TOOLE TO GET A BUS TICKET TO JACKSONVILLE DAYS PRIOR TO THE DISAPPEARANCE OF ADAM WALSH.

**** CHEEK, FREDRICK-** INCARCERATED WITH KEITH WARREN IN 1986. WROTE LETTER TO AUTHORITIES WHICH INDICATED HIS SUSPICION OF KEITH WARREN BEING INVOLVED IN THE ABDUCTION/HOMICIDE OF ADAM WALSH.

**** COLLINS, JAMES-** FORMER CO-WORKER OF TOOLE WHO WAS INTERVIEWED REGARDING ANY KNOWLEDGE HE MAY HAVE ABOUT OTTIS TOOLE DURING THE TIME ADAM WALSH WAS ABDUCTED. SAID WARREN BRAGGED ABOUT HIS ABDUCTION/MURDER OF ADAM WALSH.

**** COLLINS, RONALD D.-** SUBJECT WAS INCARCERATED WITH TOOLE AND WAS AT ONE TIME TOOLE'S CELLMATE. SUBJECT WAS INTERVIEWED REGARDING ANY DISCUSSIONS HE MAY HAVE HAD WITH OTTIS RE: THE ADAM WALSH HOMICIDE.

**** COLLINS, WILLIAM H.-** PERSONAL FRIEND OF THE WALSH FAMILY WHO OFTEN BABYSAT FOR ADAM. FORMER WIFE CARA BLUMBERG EXPRESSED CONCERN THAT HE MIGHT BE INVOLVED IN THE ABDUCTION/HOMICIDE.

COPP, SHARON MARIE- VICTIM OF A HOMICIDE IN COLORADO WHERE COPP'S BODY WAS DISMEMBERED. FILE WAS SENT IN HOPES OF POSSIBLE CONNECTION BETWEEN CASES.

**** DAHMER, JEFFREY-** SERIAL KILLER WHO LIVED IN THE MIAMI AREA AT THE TIME ADAM WALSH WAS ABDUCTED.

**** DEATLEY, EDWARD-** SUBJECT WAS ARRESTED BY FORT PIERCE PD FOR LEWD & LASCIVIOUS. AT TIME OF ARREST HE HAD A SCRAP BOOK IN HIS POSSESSION WITH CLIPPINGS PERTAINING TO ADAM WALSH. STATEMENT WAS TAKEN AND HE ADVISED HE LOVED CHILDREN AND WAS JUST INTERESTED IN THE CASE.

DOBBS, EUGENE- SUBJECT WAS AN ALLEGED HOMOSEXUAL WHO WAS FRIENDS WITH JAMES CAMPBELL. SUBJECT GIVEN A POLYGRAPH REGARDING AN KNOWLEDGE HE MAY HAVE HAD ABOUT THE ADAM WALSH ABDUCTION/HOMICIDE.

**** DOVER, JAMES-** WORKED AT A GAS STATION IN HOLLYWOOD. SAID HE SAW TOOLE IN HIS GAS STATION ABOUT 1-2 YEARS AGO. COULDN'T PINPOINT TIME FRAME.

DOWLING, ROBERT INTERVIEW WAS CONDUCTED BY THE FBI OF DOWLING. ADVISED HE WORKED AT COLOR KING WHILE LIVING IN HOLLYWOOD AND SAID HE PROCESSED THE PHOTOS OF THE RECOVERED REMAINS OF ADAM WALSH. ALSO WAS FIXING A HOUSE ACROSS THE STREET FROM WHERE ADAM LIVED.

GIBBONS, RICHARD- PAST SEXUAL OFFENDER IN THE CITY OF HOLLYWOOD.

**** GILBERT, BOYD EARL-** SUBJECT WAS A CELLMATE OF TOOLE, RECALLS TOOLE CONFESSING TO KILLING A KID WHO LATER TURNED OUT TO BE A POLICE OFFICER'S SON. SUBJECT SAID TOOLE TALKED ABOUT HIM AND LUCAS TRAVELLING ACROSS THE COUNTRY KILLING PEOPLE.

**** GILLYARD, DAVID-** SUBJECT IS SALES MANAGER AT WELLS BROTHERS USED CARS. SOLD THE 71' CADILLAC TO RONALD WILLIAMS IN DECEMBER OF 1982. QUESTIONED REGARDING THE CONDITION OF THE VEHICLE AT THE TIME HE SOLD IT TO WILLIAMS.

**** GOODYEAR, BETTY-** INTERVIEW WAS CONDUCTED TO DETERMINE WHETHER OR NOT TOOLE WAS LIVING AT HER BOARDING HOUSE IN JACKSONVILLE AT THE TIME OF THE ABDUCTION.

**** GORDON, PEGGY-** SUBJECT CALLED HPD AFTER ABDUCTION AND ADVISED SHE WAS GETTING DIFFERENT VIBRATIONS REGARDING ADAM WALSH. SHE SPOKE WITH JAMES CAMPBELL AND LATER GAVE A STATEMENT REGARDING HER FEELINGS ABOUT CAMPBELL POSSIBLY BEING INVOLVED.

GREEN, MARY- INFORMATION WAS RECEIVED BY THE ST LUCIE CO SHERIFF'S OFFICE RE: SUBJECT MARY GREEN BEING INVOLVED IN THE ABDUCTION/HOMICIDE OF ADAM WALSH. SUBJECT WILLINGLY SUBMITTED TO A PRE-TEST INTERVIEW AND POLYGRAPH AND WAS FOUND TO BE TRUTHFUL.

**** HAMMOND, ROBERT-** OWNED GROCERY STORE NEXT TO TOOLE'S MOTHERS HOUSE. QUESTIONED REGARDING OTTIS TOOLE'S WHEREABOUTS WHEN HE CAME BACK FROM DELWARE AND ABOUT TOOLE BURYING AND BURNING THINGS IN HIS MOTHER'S YARD.

**** HAMMOND, SARA-** SUBJECT'S SON OWNED A GROCERY STORE NEXT TO TOOLE'S MOTHERS PLACE. QUESTIONED ABOUT OTTIS TOOLE'S WHEREABOUTS AFTER HIS MOTHER DIED AND AFTER HE CAME BACK FROM DELEWARE. ALSO QUESTIONED ABOUT OTTIS DIGGING, BURYING AND BURNING THINGS NEXT TO HIS MOTHERS HOUSE.

**** HARDAMAN, CHARLES-** SUBJECT USE TO WORK WITH TOOLE & WITNESSED HIM BURNING JUNK IN AN OLD REFRIDGERATOR NEXT TO HIS MOTHER'S HOUSE.

**** HARLEY, ROBERT LEE-** MARRIED TO OTTIS TOOLE'S MOTHER. QUESTIONED ABOUT ANY KNOWLEDGE HE HAD REGARDING OTTIS TOOLE'S TRAVELS AFTER HIS WIFE DIED.

HAYSLIP, THEODORE- SUBJECT WAS GIVEN A POLYGRAPH REGARDING ANY INVOLVMENT HE MAY HAVE HAD IN THE DISAPPEARANCE OF ADAM WALSH. SUBJECT SHOWED NO SIGNS OF DECEPTION.

**** HODGES, LEE DALE-** SUBJECT WAS INCARCERATED WITH TOOLE. SUBJECT WAS INTERVIEWED REGARDING ANY DISCUSSIONS HE MAY HAVE HAD WITH OTTIS RE: THE ADAM WALSH HOMICIDE.

HUGHES, ROBERT- FISHERMAN WHO DISCOVERED ADAM'S HEAD IN CANAL, INDIAN RIVER COUNTY

JAMES, EDWARD- SUBJECT WAS ARRESTED BY POMPANO PD FOR ABDUCTING A SMALL CHILD. OTHER WITNESSES THEN CAME FORWARD WITH INFORMATION REGARDING JAMES POSSIBLY BEING INVOLVED THE THE ABDUCTION/MURDER OF ADAM WALSH.

**** MAYER, HEIDI-** HEIDI WAS SHOPPING IN KMART WITH HER MOTHER THE SAME WEEK ADAM WALSH WAS ABDUCTED. SHE ADVISED A MAN FOLLOWED HER IN THE STORE AND ATTEMPTED TO ABDUCT HER. SHE IDENTIFIED OTTIS TOOLE AS BEING THIS MAN DURING A PHOTOGRAPHIC LINEUP.

**** MEDINA, RALPH-** GAVE A STATEMENT TO DETECTIVES REGARDING ALEJANDRO MARCOS BEING INVOLVED IN THE ABDUCTION/MURDER OF ADAM WALSH. ADVISED MARCOS SEXUALLY ASSAULTS LITTLE CHILDREN AND HAS ALSO BRAGGED ABOUT MURDERING ADAM WALSH.

MILLER, ERNEST- MEDICAL DOCTOR WITH THE UNIVERSITY HOSPITAL OF JACKSONVILLE. DR. MILLER EXAMINED/STUDIED TOOLE AND LUCAS AND REPORTED HIS FINDINGS TO HONORABLE JUDGE LAWRENCE HADDOCK.

MONAHAN, JOHN- CLOSE FRIEND OF WALSH FAMILY, MADE IDENTIFICATION OF ADAM'S REMAINS.

**** MONAHAN, MICHAEL-** JOHN MONAHAN'S SON, EMERGED AS A SUSPECT THROUGH MEDIA ATTENTION, STATEMENT TAKEN, GAVE ALIBI WHICH WAS VERIFIED BY EX-GIRLFRIEND.

PALMER, JAMES- INMATE INCARCERATED WITH LARRY BURNETT. SAID BURNETT ADVISED HE HAD BEEN IN FLORIDA, POSSIBLY SOUTH FLORIDA DURING THE TIME OF THE WALSH HOMICIDE AND THAT BURNETT LOOKED LIKE THE COMPOSITE SKETCH.

**** POWELL, FRANK-** NEPHEW OF OTTIS TOOLE WHO WAS INTERVIEWED REGARDING THE TRIP HE TOOK WITH TOOLE AND LUCAS, JUST PRIOR TO THE ABDUCTION OF ADAM WALSH AND ANY KNOWLEDGE HE HAD REGARDING WEAPONS & VEHICLES HIS UNCLE OTTIS TOOLE OWNED.

**** POOLE, JAMES MICHAEL-** SUBJECT WAS INCARCERATED WITH TOOLE AND TOOLE TOLD HIM HE WAS IN THE REPOSSESSION OF KIDS BUSINESS. SAID HE ABDUCTED HIS OWN SON FROM HIS WIFE IN SOUTH BROWARD AND HAD TO STOP THE CAR AND LET HIM OUT BECAUSE THE POLICE WERE FOLLOWING HIM. TOOLE SAID HE HAD TO GET RID OFF THE CAR BECAUSE HE HAD SOME EVIDENCE, CLOTHING, THAT HE DIDN'T WANT THE POLICE TO FIND. SAID THE CAR AND THE CLOTHING WAS UNDERWATER.

**** REAVES, JOHN-** REAVES EMPLOYED TOOLE AT HIS ROOFING COMPANY IN JACKSONVILLE. INTERVIEWS CONDUCTED FOR JOHN REAVES SR & JOHN REAVES JR, IN AN ATTEMPT TO ESTABLISH WHETHER OR NOT TOOLE WAS WORKING FOR THEM AT THE TIME ADAM WALSH WAS ABDUCTED.

ROSEN, WILLIAM- ANONYMOUS LETTER WAS RECEIVED RE: A SUBJECT "TOBY" POSSIBLY BEING INVOLVED IN THE ABDUCTION OF ADAM WALSH. AFTER FOLLOWING UP ON THE LEAD, "TOBY" WAS IDENTIFIED AS POSSIBLY BEING SUBJECT ROZEN. SUBJECT ROZEN ATTENDS MEETINGS FOR HOMOSEXUALS ALCOHOLICS. NO INFORMATION COULD COOPERATE ROZEN BEING INVOLVED IN THIS HOMICIDE.

SCHAEFFER, GERALD- INMATE WHO IS INCARCERATED WITH OTTIS TOOLE AND IS ACTING AS TOOLE'S AGENT/LAWYER. ADVISED OTTIS TOOLE HAD ADMITTED EVERYTHING REGARDING THE HOMICIDE TO HIM AND THAT HE WOULD PROVIDE POLICE WITH THIS INFORMATION IF HIS DEMANDS WERE MET.

**** SCHOPPAUL, DAVID-** SUBJECT GAVE STATEMENT REGARDING A POSSIBLE SUSPECT HE SAW AT THE SEARS STORE ON THE DAY OF THE ABDUCTION.

SIMMONS, DELORES- WITNESS WHO BELIEVES SHE SAW ADAM WALSH ALIVE APPROXIMATELY 5 DAYS BEFORE HIS HEAD WAS FOUND.

**** TERRY, JESSE W.-** DETECTIVE IN THE HOMICIDE UNIT OF THE JACKSONVILLE SHERIFF'S OFFICE. DET. TERRY ASSISTED THE HOLLYWOOD POLICE DEPT. DURING THE INTIAL STAGES OF THE INVESTIGATION OF OTTIS TOOLE AND HIS INVOLVEMENT IN THE WALSH HOMICIDE.

**** TERRY, JOHN-** SUBJECT WAS AN INMATE AT BROWARD COUNTY JAIL WITH JAMES, EDWARD. HE ADVISED JAMES TOLD HIM HE WAS RESPONSIBLE FOR THE MURDER OF ADAM WALSH.

**** TOOLE, GEORIGA-** SISTER-IN-LAW OF OTTIS TOOLE. INTERVIEWED REGARDING ANY KNOWLEDGE SHE MAY HAVE CONCERNING WHEREABOUTS OF TOOLE AT TIME OF ABDUCTION.

**** TOOLE, HOWELL-** BROTHER OF OTTIS TOOLE. INTERVIEW CONDUCTED TO DETERMINE ANY KNOWLEDGE HE MAY HAVE REGARDING THE WHEREABOUTS OF HIS BROTHER OTTIS DURING THE TIME OF THE ABDUCTION OF ADAM WALSH.

**** TOOLE, NORVELLA-** WIFE OF OTTIS TOOLE. INTERVIEW CONDUCTED TO DETERMINE ANY KNOWLEDGE SHE MAY HAVE REGARDING THE WHEREABOUTS OF OTTIS DURING THE TIME OF THE ABDUCTION OF ADAM WALSH.

**** TOOLE, OTTIS ELWOOD-** SUBJECT IS A CONVICTED MURDERER WHO HAS CONFESSED & RECANED HIS CONFESSIONS SEVERAL TIMES REGARDING HIS INVOLVMENT IN THE ABDUCTION/MURDER OF ADAM WALSH.

**** TOOLE, VERNON-** BROTHER OF OTTIS TOOLE, INTERVIEWED REGARDING ANY KNOWLEDGE HE MIGHT HAVE ABOUT HIS BROTHER OTTIS' INVOLVEMENT IN THE ABDUCTION OF ADAM WALSH.

VIA, JAY- SGT WITH THE OUACHITA PARISH SHERIFF'S DEPT. SGT VIA WAS INERVIEWING TOOLE RE: HOMICIDES IN THEIR JURISDICTION WHEN TOOLE MADE MENTION OF HOW HE KILLED ADAM WALSH.

WAGNER, MICHAEL- SUBJECT WAS CONVICTED OF SODOMY OF A 3 YEAR OLD GIRL AND BRUTAL STABBING OF A 12 YEAR OLD BOY IN BINGHAMTON NEW YORK. WAGNER HAD TRAVELED TO SOUTH FLORIDA IN THE PAST. FILE SENT FOR INTELLIGENCE/LEAD PURPOSES.

**** WALDO, LARRY LEON-** WALDO LIVED AT BETTY GOODYEAR'S BOARDING HOUSE AT THE SAME TIME TOOLE DID. SUBJECT WAS INTERVIEW ABOUT ANYTHING TOOLE MAY HAVE TOLD HIM ABOUT HIS INVOLVEMENT IN THE WALSH CASE.

WALSH, JOHN- FATHER OF ADAM WALSH

**** WALSH, REVE-** MOTHER OF ADAM WALSH

**** WARREN, KEITH-** WARREN WAS CONVICTED OF ABDUCTING A TEENAGE BOY IN LAS VEGAS. WARREN ATTEMPTED TO CUT THE BOYS HEAD OFF AND LEFT HIM FOR DEAD. WARREN WAS IN THE KEYS AREA DURING THE TIME OF THE ABDUCUTION/HOMICIDE OF ADAM WALSH.

**** WINDHURST, WILLIAM-** GAVE A STATEMENT REGARDING HIS SUSPICION OF JAMES, EDWARD WHO WAS HIS NEIGHBOR.

WOLFF, ADA- BEFRIENDED THE WALSHES AFTER THE ABDUCTION/HOMICIDE AND TOLD THEM SHE WAS GOING TO COLLECT DONATIONS FOR A BENEFIT TO BE HELD FOR ADAM. LATER ADVISED SHE HAD MADE THE WHOLE THING UP AND NO PRIZES/DONATIONS WERE EVER COLLECTED. SUBJECT WAS BAKER ACTED BY FT LAUDERDALE PD ON 04/13/81.
