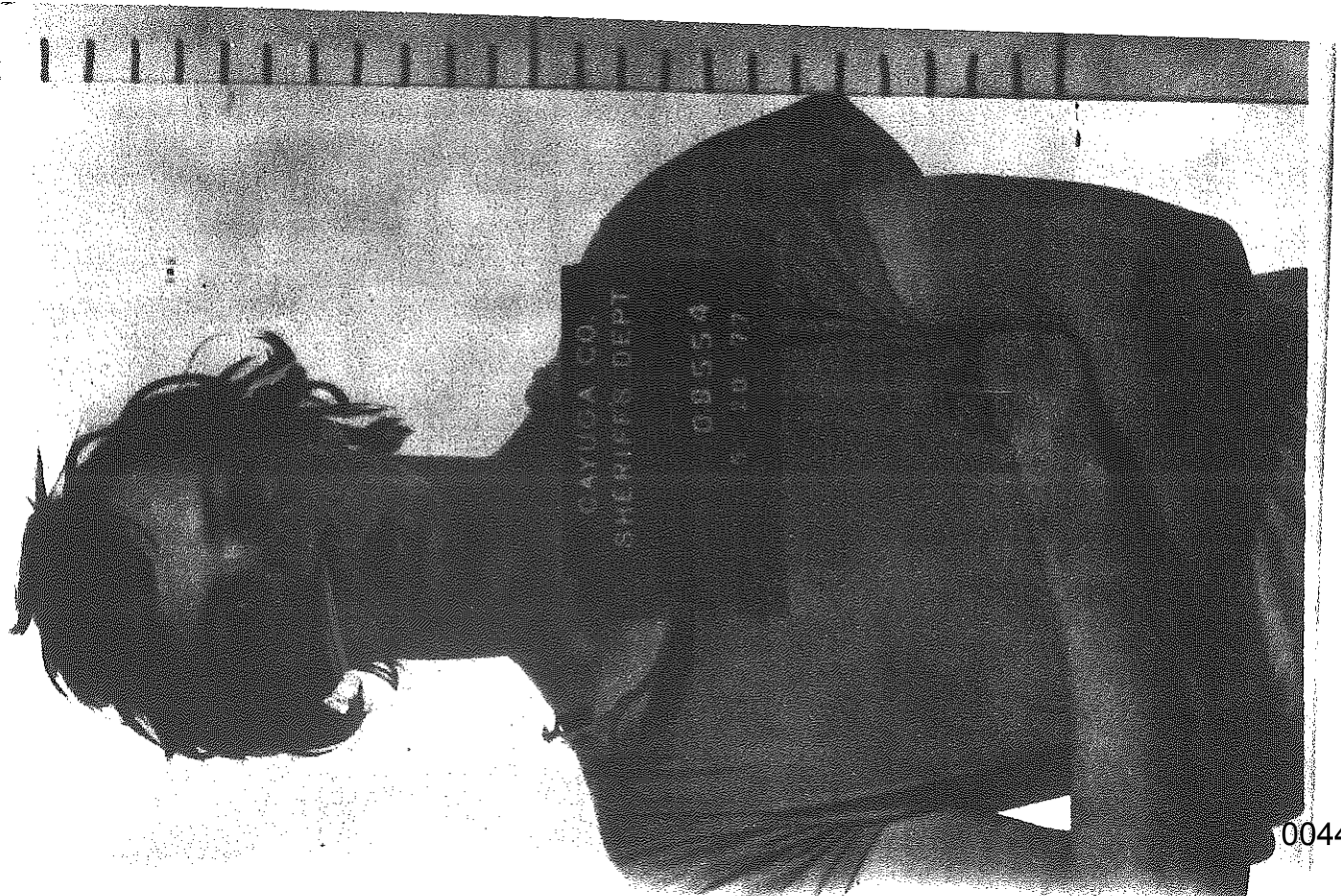

On Wednesday 8-19-81 at 2015 hrs, Officer Schoenthal received a telephone call from Deputy Respress of Madison County Sheriffs Department. Deputy Respress informed Officer Schoenthal that they had an individual in custody who possessed information regarding the person who killed Adam Walsh.

The subject in custody in Madison County is identified as W/M Kelly, Michael Patrick DOB 1-6-56. Subject Kelly informed Deputy Respress that he wanted to speak to Hollywood investigators in regarding the Adam Walsh Homicide.

Deputy Respress informed Officer Schoenthal that the subject Kelly was arrested by Florida Highway Patrol for DUI and had in his possession a machete which had traces of blood on it. Subject Kelly was operating a Ford Pinto when he was arrested.

Officer Schoenthal then spoke to subject Kelly over the telephone in which he related the following information: Subject Kelly knows an individual identified as Moran, Donald William AKA Kim, DOB 8-3-56. Subject Moran resides in Titusville, Fl. and resembles the composite drawing. Subject Kelly knows Moran ten years and stated that Moran is into cults and rituals. Kelly stated that Moran resided in the Hollywood area for a period of time. Kelly further stated that Moran has operated a blue Ford Van.

During this conversation Kelly never stated that he participated in the actual kidnapping or murder of Adam Walsh. Kelly appeared evasive to any questions that may have implicated him in the murder or kidnapping.

On 8-15-81 Kelly telephoned the Hollywood Police and spoke to Officer Schoenthal and stated that he knew who killed Adam Walsh. In this telephone conversation Kelly mentioned Kim Moran.

When checking NCIC/FCIC on Moran, Donald it revealed three active felony warrants.

On Monday 7-27-81 at approximately 1230 hrs. Adam Walsh was Kidnaped from the Sears Mall located in the city of Hollywood. From the time the child was kidnaped the family or the police department did not receive any demands for a ransom.

On Monday 8-10-81 the severed head of Adam Walsh was discovered by two fishermen at mile marker #131 on the Florida Turnpike, Indian River County.

DR. RONALD WRIGHT, Broward County Medical Examiner, advised that his investigation indicates that the head was severed by either a Machete or a meat cleaver with a blade length of at least five (5) inches or more.

On Wednesday, August, 19th, 1981 Madison County Sheriff Department arrested a W/M, MICHAEL PATRICK KELLY for DUI, and in his possession he had the attached Machete. KELLY had advised he had information that this Machete was possibly involved in this investigation.

Request that you attempt to determine if this blade has human blood on it or rust.

Also examine the accompanying blue denim trousers for human blood.
