

Statement - CHRISTIANA McGUIRE

THE FOLLOWING WILL BE A VOLUNTARY TAPED STATEMENT TAKEN FROM CHRISTIANA MCGUIRE, W/F, DOB 12-26-60. STATEMENT IS BEING TAKEN IN REGARD TO CERTAIN KNOWLEDGE MRS. MCGUIRE HAS CONCERNING AN INCIDENT THIS POLICE DEPARTMENT IS CURRENTLY INVESTIGATING IN REFERENCE TO THE HOMICIDE/ABDUCTION OF ADAM WALSH WHICH OCCURRED IN THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA ON JULY 27TH, 1981, LOCATION 300 HOLLYWOOD MALL. THIS STATEMENT IS BEING TAKEN BY DETECTIVE MARK SMITH, BADGE #1163, COMMENCING ON 6-23-95 AT APPROXIMATELY 10:55 HOURS.

Q. MRS. MCGUIRE, AT THIS TIME I'D LIKE TO PLACE YOU UNDER OATH BY VIRTUE OF MY COMMISSION AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA. FIRST OFF, ARE YOU AWARE IT IS A CRIME TO LIE UNDER OATH?

A. YES.

Q. WOULD YOU RAISE YOUR RIGHT HAND PLEASE? LET THE RECORD REFLECT SHE'S DOING SO. DO YOU SOLEMNLY SWEAR TO TELL THE TRUTH, THE WHOLE TRUTH, AND NOTHING BUT THE TRUTH SO HELP YOU GOD?

A. YES.

Q. CHRISTIANA MCGUIRE, HAVING APPEARED BEFORE ME AS A POLICE OFFICER FOR THE CITY OF HOLLYWOOD, COUNTY OF BROWARD, STATE OF FLORIDA, HAVING BEEN DULY SWORN DEPOSES AND STATES. FOR THE RECORD WOULD YOU JUST STATE YOUR NAME AND BIRTH DATE FOR ME PLEASE?

A. MY NAME IS CHRISTIANA MCGUIRE AND MY BIRTH DATE IS 12-26-60.

Q. CHRISTIANA, I SPOKE TO YOU FOR THE FIRST TIME YESTERDAY ON THE PHONE FROM YOUR SISTER'S HOUSE IN FORT LAUDERDALE, CORRECT?

A. YES.

Q. AND I MENTIONED TO YOU, WELL WHEN I FIRST GOT ON THE PHONE I THINK IT WAS BROUGHT TO MY ATTENTION THAT YOU HAD READ AN ARTICLE OR SOMEONE READ AN ARTICLE TO YOU ABOUT UH, ABOUT THE ADAM WALSH CASE BEING INVESTIGATED AND THAT THE FAMILY, THE MONAHANS WERE MENTIONED IN THE ARTICLE, IS THAT CORRECT?

A. THAT'S CORRECT.

Q. AND I SPOKE TO YOU ON THE PHONE AND I ASKED IF I COULD GET A STATEMENT FROM YOU IN REGARDS TO YOUR ASSOCIATION WITH A FAMILY MEMBER OF THE MONAHANS BY THE NAME OF MICHAEL MONAHAN, CORRECT?

A. YES.

Q. WHEN I SPOKE TO YOU, I TOLD YOU THAT UM, I WAS OF INTEREST TO FIND OUT UH, IF YOU CAN RECALL TO THE BEST OF YOUR RECOLLECTION THE EVENTS THAT LED UP TO UM, THE ADAM WALSH ABDUCTION AND EVENTUAL

HOMICIDE AND YOUR RELATIONSHIP WITH MICHAEL MONAHAN AT THAT TIME. IS THAT CORRECT?

A. YES.

Q. TO THE BEST OF YOUR RECOLLECTION, CAN YOU TELL ME WHEN YOU AND MICHAEL BEGAN DATING OR WERE EVEN FRIENDS OR WHEN YOU FIRST MET HIM? WHAT YEAR?

A. I, TO THE BEST OF MY RECOLLECTION IT WOULD BE 1978.

Q. IN HIGH SCHOOL?

A. IN HIGH SCHOOL, YES.

Q. AT ST. THOMAS AQUANIS?

A. YES.

Q. CAN YOU RECALL WHEN YOU AND HE I GUESS WOULD HAVE BEEN CONSIDERED BOYFRIEND/GIRLFRIEND OR IF IT WAS EVEN CONSIDERED THAT? FROM THAT DATE THAT WE'RE TALKING ABOUT?

A. (PAUSE) UH I..I WOULD SAY (PAUSE) IN THE..I GUESS IN THE SPRING OF 78 OR..

Q. OK.

A. 7..I..78. UM..

Q. FROM THE SPRING OF 78...THROUGH THAT SCHOOL YEAR, THROUGH THE SUMMER, INTO 79, YOU WERE CONSIDERED, YOU WERE DATING?

A. YES.

Q. AND WAS THERE A TIME WHEN YOU WENT OFF TO COLLEGE, AROUND THAT TIME?

A. YES, I WENT OFF TO COLLEGE IN THE FALL OF 79.

Q. THE FALL OF 79?

A. YES.

Q. YOU WENT OFF TO COLLEGE?

A. YES.

Q. WHEN DID YOU, DO YOU KNOW WHAT YEAR YOU GRADUATED HIGH SCHOOL?

A. 79.

Q. OK SO THE FALL OF 79 YOU WENT AWAY.

A. YES.

Q. WAS YOUR RELATIONSHIP STILL BOYFRIEND/GIRLFRIEND WHEN YOU WENT AWAY?

A. UM, HE KEPT IN TOUCH A LOT BY TELEPHONE WHILE I WAS AWAY AT SCHOOL.

Q. OK. NOW, THE SUMMER OF 1981.

A. UH HUH.

Q. BEFORE THAT THOUGH, YOU...SPRING OF 1981 YOU WERE UP IN COLLEGE.

A. YES.

Q. AND SUMMER CAME IN 1981, YOU CAME BACK HOME?

A. YES.

Q. TO FLORIDA AND SPENT THE SUMMER?

A. YES.

Q. IT'S THAT TIME WE'LL CONCENTRATE ON NOW IN REGARDS TO THE EVENTS THAT LED UP THE HOMICIDE, THE ABDUCTION. SO YOU WERE ACTUALLY BACK HOME HERE UH, DO YOU REMEMBER WHAT MONTH YOU CAME BACK HOME?

A. PROBABLY IN MAY.

Q. SO MAY OF 81 YOU CAME HOME AND..

A. YES.

Q. YOU AND MIKE STILL DATED?

A. YES.

Q. CAN YOU TELL ME UH, IF YOU CAN RECALL...WHEN YOU FIRST HEARD OF..FIRST HEARD THAT ADAM WALSH WAS FIRST MISSING...DO YOU RECALL WHEN THAT WAS AND WHERE YOU WERE? I KNOW IT'S A LONG TIME AGO.

A. I THOUGHT THAT I WAS AT MY FATHER'S HOUSE AND MIKE HAD COME OVER THERE AND TOLD ME THAT HE WAS ABDUCTED.

Q. OK. DO YOU REMEMBER IN RELATION TO WHEN, FROM WHEN HE WAS ACTUALLY ABDUCTED TO THE TIME MIKE TOLD YOU? DO YOU KNOW IF IT WAS THE SAME DAY OR THE DAY AFTER?

A. I DON'T RECALL IF IT WAS THE SAME DAY OR THE DAY AFTER.

Q. COULD IT HAVE BEEN ONE OR THE OTHER?

A. YES.

Q. DO YOU REMEMBER WHAT TIME OF DAY IT WAS WHEN HE CAME OVER AND TOLD YOU?

A. I REMEMBER IT WAS DAY TIME, IT WAS NOT EVENING. BUT I DON'T REMEMBER WHAT TIME OF DAY.

Q. SO CHANCES ARE IT MAY HAVE BEEN THE FOLLOWING DAY IF THE ABDUCTION HAPPENED ABOUT NOON ON UH, THE DATE IN QUESTION IS JUNE, OR JULY 27TH.

A. UH HUH.

Q. A MONDAY. WOULD IT HAVE BEEN POSSIBLE THAT HE WOULD HAVE BEEN ABLE..COME OVER AND TOLD YOU THAT SAME DAY BEFORE IT GOT DARK?

A. IT, IT IS POSSIBLE, YES.

Q. DO YOU REMEMBER WHAT CAR YOU WERE DRIVING BACK THEN?

A. (PAUSE) UM...I USED TO HAVE A CAMERO AND THAT YEAR WE GOT, WE SOLD IT AND GOT A TOYOTA BUT I THINK MAYBE I WAS DRIVING A VOLKSWAGEN STATION WAGON AND MY SISTER HAD THE TOYOTA, I'M...BECAUSE THERE WAS A TRANSFER OF CARS, THAT SUMMER, I'M NOT SURE WHAT I WAS DRIVING.

Q. IF I TOLD YOU FROM MIKE'S RECOLLECTION WAS THAT HE, UH, THAT YOU WERE DRIVING THE CAMERO AT THAT TIME, COULD THAT BE ACCURATE?

A. THAT COULD BE ACCURATE.

Q. OK. HIS RECOLLECTION IS THAT YOU WERE DRIVING YOUR CAR AND HE WAS IN THE CAR WITH YOU, THE CAMERO..

A. UH HUH.

Q. YOU HAD LEFT YOUR FATHER'S HOUSE, HE DIDN'T REMEMBER WHERE YOU WERE GOING, AND HE RECALLED HEARING IT ON THE CAR RADIO. COULD THAT HAVE BEEN POSSIBLE?

A. IT COULD HAVE BEEN POSSIBLE.

Q. AND, I'LL TELL YOU AGAIN LATER ON THE REST THAT HE SAID BUT I'LL TRY AND JUST TRY AND GET TO, SEE WHAT YOU REMEMBER. UM, DO YOU REMEMBER WHAT THE FIRST ACTION YOU AND HE TOOK WHEN HE BROUGHT IT TO YOUR ATTENTION OR YOU HEARD IT ON THE CAR RADIO, UH, WHAT YOU AND HE DID?

A. (PAUSE) I, I DON'T.

Q. DO YOU RECALL DOING ANY..DO YOU RECALL DOING SOMETHING IN REGARDS TO UH..

A. WELL I DO RECALL UM, BEING IN HIS CAR, AT NIGHT TIME DRIVING

UP STREETS IN HOLLYWOOD LOOKING FOR ADAM. AND I WOULD THINK THAT WOULD HAVE BEEN SOON AFTER HE WAS ABDUCTED.

Q. COULD IT HAVE BEEN THE SAME NIGHT?

A. IT COULD HAVE BEEN THE SAME NIGHT OR THE NIGHT AFTER.

Q. DO YOU REMEMBER HOW MANY TIMES YOU DID THAT?

A. UM, I REMEMBER DEFINITELY ONE EVENING DOING THAT AND THEN I DO REMEMBER DISTRIBUTING FLIERS WITH HIM.

Q. OK. DO YOU REMEMBER WHERE?

A. NO, I JUST REMEMBER GOING TO THE..I THINK THE HOLLYWOOD POLICE STATION TO GET THE FLIERS.

Q. SO IT WOULD HAVE BEEN THAT DAY AND A NIGHT WHERE YOU TWO, THE TWO OF YOU WERE TOGETHER DOING THESE THINGS.

A. UH HUH.

Q. IS THAT ACCURATE?

A. THAT'S ACCURATE.

Q. WAS THERE MORE THAN THOSE TWO NIGHTS THAT THE TWO OF YOU WERE ACTUALLY DOING SOMETHING IN REGARDS TO THAT CASE? EITHER KNOCKING ON DOORS, OR ANSWERING PHONES, ANYTHING?

A. NOT THAT I CAN RECALL.

Q. SO AT LEAST TWO NIGHTS OR TWO DAYS?

A. YES.

Q. COULD IT HAVE BEEN MORE?

A. IT COULD HAVE BEEN MORE.

Q. DO YOU REMEMBER GOING TO THE WALSH HOME AFTER THE ABDUCTION OR AT THE TIME WHEN HE WAS REPORTED MISSING?

A. I REMEMBER....VAGUELY.

Q. OK.

A. AND I DON'T REMEMBER IF I SAW THE WALSH'S THERE. BUT I, I DO REMEMBER GOING TO THEIR HOUSE. AND I VAGUELY REMEMBER IT BEING AT THE TIME OF THE ABDUCTION BUT THEN I'M NOT SURE IF I HAD BEEN THERE...EVEN BEFORE THE ABDUCTION HAD TAKEN PLACE.

Q. OK. IS IT POSSIBLE THAT YOU AND MIKE AND I'M INCLUDING MIKE AT THIS TIME TOO..

A. UH HUH.

Q. IS IT POSSIBLE THAT THE TWO OF YOU WENT TO THE WALSH HOME?

A. IT'S POSSIBLE.

Q. EITHER THE SAME DAY OR MAYBE THE DAY AFTER THE ABDUCTION?

A. YES.

Q. OK. (PAUSE) TO THE BEST OF YOUR RECOLLECTION, HOW MANY TIMES FROM THAT DAY, OF THE DAY OF THE ABDUCTION TO THE TIME THAT UH, THE HEAD WAS FOUND..

A. UH HUH.

Q. WHICH WOULD HAVE BEEN ABOUT...TWO WEEKS..

A. UH HUH.

Q. HOW MANY TIMES DO YOU RECALL SEEING MIKE? I KNOW IT'S A LONG TIME AGO..

A. UM..

Q. IN OTHER, WHAT I'M...

A. I DON'T RECALL SEEING HIM BUT I DON'T RECALL NOT SEEING HIM EITHER.

Q. THAT WAS GOING TO BE MY NEXT QUESTION. NOT THAT, NOT THAT YOU ACTUALLY REMEMBERED SEEING HIM, BUT DO YOU REMEMBER HIM GOING AWAY FOR ANY TIME?

A. NO I DON'T REMEMBER HIM GOING AWAY.

Q. DID YOU NORMALLY KEEP IN CONTACT UH, AFTER YOU CAME BACK FROM COLLEGE, YOU WERE THERE THAT SUMMER..

A. YES.

Q. EITHER BY PHONE OR IN PERSON?

A. YES.

Q. COULD IT BE EVERY DAY THAT YOU WOULD HAVE HAD SOME KIND OF CONTACT?

A. YES.

Q. DO YOU RECALL THAT?

A. YES.

- Q. TO BE THE CASE? OR YOU BELIEVE..
- A. YES I DO.
- Q. OK. (PAUSE) DO YOU REMEMBER WHERE MIKE WAS LIVING AT THE TIME?
- A. (PAUSE) I, I WOULD SAY AT HOME BUT I..I CANNOT SAY THAT WITH CONFIDENCE.
- Q. COULD HE HAVE BEEN LIVING UH..
- A. HE COULD HAVE BEEN LIVING OUT OF THE HOUSE, YES.
- Q. DO YOU REMEMBER WHEN HE WAS LIVING IN MARGATE?
- A. YES.
- Q. WAS THAT ABOUT THAT, RIGHT, THAT TIME?
- A. I, I CAN'T RECALL.
- Q. OK. (PAUSE) DO YOU EVER RECALL AN INCIDENT INVOLVING MIKE WITH A UH, MACHETE WHERE HE WAS NOT ARRESTED BUT HE WAS QUESTIONED ABOUT IN A POLICE INVESTIGATION IN OAKLAND PARK?
- A. I DON'T, I DON'T RECALL IT.
- Q. DID YOU KNOW HIM TO HAVE GOTTEN IN TROUBLE WITH THE POLICE?
- A. YES.
- Q. OK. DID YOU KNOW EVERY INCIDENT HE WAS INVOLVED IN OR HE WOULD TELL YOU ABOUT?
- A. YOU MEAN FROM THEN UP UNTIL PRESENT OR..
- Q. DURING THAT TIME.
- A. DURING THAT TIME WHILE WE WERE SEEING EACH OTHER? UM...I, I...I CAN'T.. I CAN'T RECALL.
- Q. OK. (PAUSE) DID YOU KNOW A PERSON BY THE NAME OF JIM, OR JIMMY OR JAMES CAMPBELL?
- A. YES.
- Q. HOW DID YOU KNOW HIM?
- A. THROUGH MIKE MONAHAN. THROUGH THE...POOL AT THE DIPLOMAT.
- Q. OK, SO MIKE, WHEN YOU WERE DATING MIKE, UM, YOU HAD MET JIMMY OR JAMES CAMPBELL WHEN YOU, YOU AND MIKE HAD GONE TO THE POOL AT THE

DIPLOMAT? IS THAT HOW IT WENT?

A. YES. YES.

Q. DID YOU GO THERE OFTEN?

A. YES.

Q. HOW ABOUT DURING THAT SUMMER? THIS TIME FRAME WE'RE TALKING ABOUT; DID YOU GO THERE A LOT?

A. I WOULD THINK SO.

Q. WHAT DID YOU KNOW OF JIM CAMPBELL; OTHER THAN JUST UH..

A. I KNEW THAT HE LIVED WITH THE WALSH'S AND THAT HE...WAS..WORKED AT THE POOL AT THE DIPLOMAT. OTHER THAN THAT I DID NOT KNOW MUCH ABOUT JIM CAMPBELL.

Q. OK. DID YOU KNOW HOW UH; MIKE AND JIM WERE ASSOCIATED? WERE THEY FRIENDS? OR WERE THEY JUST ACQUAINTANCES OR DID THEY APPEAR TO BE CLOSE FRIENDS?

A. UH; THEY WERE FRIENDS; I DON'T KNOW IF I WOULD SAY CLOSE FRIENDS.

Q. OK. DID YOU, WAS THERE EVER ANY TIME WHEN YOU AND MIKE WENT OUT WITH JIM CAMPBELL WITH THE THREE OF YOU?

A. NOT THAT I RECALL.

Q. HAVE YOU EVER MET THE WALSH'S; INCLUDING ADAM AND JOHN AND REVE WALSH?

A. YES.

Q. DO YOU REMEMBER HOW MANY TIMES?

A. MINIMAL BUT I HAD MET THEM.

Q. DO YOU REMEMBER WHERE? WAS IT AT THEIR HOME OR THE MONAHAN HOME OR THE DIPLOMAT OR THE BEACH?

A. UH; IT; WITH ADAM IT MAY HAVE BEEN AT..AT THE POOL WITH JIM CAMPBELL.

Q. AT THE DIPLOMAT?

A. YES.

Q. WITH JIM CAMPBELL?

A. YES.

Q. DID YOU KNOW OF JIM CAMPBELL BRINGING ADAM THERE, UH, BY HIMSELF OR DO YOU KNOW IF HE HAD THAT RESPONSIBILITY?

A. AS I..AS I RECALL, IT WAS OFTEN BUT I THINK I DO RECALL THAT.

Q. UH..(PAUSE) AS FAR AS ADAM IS CONCERNED, WHAT KIND OF CHILD WAS HE, IF YOU REMEMBER?

A. I REMEMBER HIM TO BE UH, A CUTE, HAPPY, LOVED CHILD.

Q. WHEN YOU SAY LOVED, YOU MEAN BY EVERYONE THAT WAS ASSOCIATED WITH HIM?

A. EVERYONE THAT WAS ASSOCIATED WITH HIM AND HE..

Q. WOULD THAT INCLUDE MIKE?

A. YES.

Q. AND JIM?

A. YES.

Q. AND THE WALSH'S?

A. YES.

Q. I'M SORRY, I CUT YOU OFF, YOU WERE GOING TO SAY SOMETHING ELSE? OR DID YOU FORGET.

A. NO.

Q. AS FAR AS MIKE AND ADAM WERE CONCERNED, THEY APPEARED TO BE CLOSE? WHEN I SAY CLOSE, I DON'T REALLY MEAN CLOSE, WHAT I MEAN IS HOW DID THEY ASSOCIATE TOGETHER? DID THEY..

A. THEY ASSOCIATED WELL. I THINK MIKE LIKED CHILDREN AND UH, HE LIKED ADAM.

Q. AND JIM AS WELL?

A. YES.

Q. I MEAN THE TIMES YOU SAW THEM TOGETHER, HE APPEARED TO BE UH..UH..GOOD TO ADAM?

A. YES.

Q. OK THIS SAME TIME FRAME OF THIS SUMMER, DO YOU RECALL WHAT KIND OF CAR MIKE WAS DRIVING?

A. IT WAS A VERY OLD LIGHT BLUE CAR. I DON'T KNOW.. A RAMBLER MAYBE?

Q. WHEN YOU WERE DRIVING, YOU MENTIONED THE NIGHT THAT YOU WERE PASSING OUT FLIERS, YOU WERE IN MIKE'S CAR?

A. YES.

Q. IS THAT THE SAME CAR?

A. THAT'S THE SAME CAR.

Q. DO YOU EVER KNOW WHAT HAPPENED TO THAT CAR?

A. NO.

Q. (PAUSE) WHAT KIND OF PERSON UM, WAS MIKE BACK THEN? I MEAN HOW WOULD YOU, WHAT WOULD YOU CONSIDER HIM TO BE?

A. UH, A TROUBLED PERSON. UM...I WANT TO SAY TROUBLE ALWAYS SOUGHT MIKE OUT, UM, AND I COULD JUST TELL THAT IT WAS UM, A..SOMETHING HE WAS NOT GOING TO OUTGROW OR GET OUT OF..

Q. RIGHT.

A. IT WAS JUST UM, UNFORTUNATELY HIS, HIS PLACE IN LIFE.

Q. WAS HE EVER VIOLENT? DID YOU EVER SEE HIM BECOME VIOLENT?

A. UM..(PAUSE) YES. BUT I..I...CAN'T REALLY THINK OF AN INSTANCE RIGHT NOW BUT I WILL SAY HE DID HAVE A SHORT TEMPER.

Q. OK. NOW, HOW ABOUT JIM CAMPBELL? DO YOU KNOW HIM WELL ENOUGH TO KNOW WHETHER HE WAS VIOLENT?

A. I DIDN'T KNOW HIM WELL ENOUGH TO SAY IF HE WAS VIOLENT OR NOT. WHAT I, FROM WHAT I DID SEE I DID..I DIDN'T PICTURE HIM TO BE A VIOLENT PERSON.

Q. OK. NOW REGARDING THE ARTICLES IN THE PAPER, YOU MAY REMEMBER SEEING IT ON THE NEWS, IT'S BEEN ON THE NEWS, ALLEGATIONS THAT WE ARE QUESTIONING MICHAEL MONAHAN IN REGARDS TO THIS HOMICIDE, UM...ARE SOMEWHAT FALSE, THEY ARE INACCURATE. BUT IT IS ALLEGED BY OTHERS THAT MIKE MONAHAN WAS INVOLVED IN THE ABDUCTION AND THE HOMICIDE OF ADAM WALSH. WHAT ARE YOUR THOUGHTS ABOUT THAT?

A. I DON'T BELIEVE THAT HE WAS INVOLVED WITH THE ABDUCTION OR MURDER OF ADAM WALSH.

Q. WHAT DO YOU BASE THAT ON?

A. I..I..BASE THAT ON..ME SEEING HIS RELATIONSHIP WITH THE WALSH'S AND WITH ADAM..UM..AND I DON'T KNOW OF ANY SITUATION THAT MIKE WOULD BE IN WHERE HE WOULD ABDUCT A CHILD AND UM, HARMFULLY HURT THAT CHILD.

Q. MUCH LESS ADAM?

A. MUCH LESS ADAM. ESPECIALLY ADAM.

Q. ESPECIALLY ADAM. NOW WHEN UH, DO YOU RECALL WHERE YOU WERE AND UH, WHO WAS WITH YOU WHEN YOU HEARD THAT THE HEAD WAS FOUND UP IN, ACTUALLY UP IN VERO BEACH HERE?

A. I UM, THE MORE I THINK ABOUT THIS, THE, I AM NOT SURE IF, WHEN I RECALL THIS INSTANCE OF HIM COMING TO MY FATHER'S HOUSE...NOW I'M NOT SURE IF HE, AT THAT TIME WAS TELLING ME ADAM WAS ABDUCTED OR AT THAT TIME WAS TELLING ME THAT ADAM'S HEAD WAS FOUND.

Q. OK. IF I TOLD YOU YOUR MOTHER, WHO I SPOKE TO YESTERDAY RECALLED THAT THE DAY THAT SHE SAW ON THE NEWS OR HEARD IT ON THE NEWS THAT ADAM'S HEAD WAS FOUND, YOU AND MIKE WERE AT THE BEACH AND WHEN YOU AND MIKE HAD COME HOME, SHE SAID THAT SHE INFORMED THE BOTH OF YOU OF THAT. DO YOU RECALL THAT?

A. I DON'T RECALL THAT.

Q. COULD IT HAVE..

A. IT COULD, YES, IT'S..IT COULD BE UM, IT MAY HAVE HAPPENED, I DON'T RECALL IT.

Q. HOW ABOUT MICHAEL'S PERSONAL REACTION, IF YOU REMEMBER WHEN HE EITHER TOLD YOU OR YOU ALL WERE TOGETHER WHEN IT WAS BROUGHT TO YOUR ATTENTION THAT THE HEAD WAS FOUND, DO YOU REMEMBER HIS REACTION?

A. I DON'T, I DON'T REMEMBER HIS REACTION.

Q. DO YOU REMEMBER YOUR REACTION?

A. AND I DON'T REMEMBER MY REACTION. UM..I, IF IT WERE TO HAPPEN NOW, I COULD TELL YOU HOW I WOULD FEEL NOW..

Q. RIGHT.

A. IT'S BEEN SUCH A LONG TIME AGO, I CAN'T REMEMBER MY REACTION TO IT.

Q. A SUBSEQUENT..GO AHEAD.

A. WELL NOW YOU MEAN, LIKE, DID I CRY?

Q. DO YOU REMEMBER.

A. I..I'M SURE I DID BUT I DON'T REMEMBER.

Q. OK. BUT IT IS, IS IT POSSIBLE THAT WHAT YOUR MOTHER'S RECOLLECTION COULD BE ACCURATE?

A. YES IT IS.

Q. HOW ABOUT AFTER THE HEAD WAS FOUND, DO YOU REMEMBER ATTENDING A FUNERAL, DOING ANYTHING ELSE WITH MIKE AND WHAT HIS REACTIONS WERE AFTER THAT?

A. I DON'T REMEMBER ATTENDING A FUNERAL. (PAUSE) I DO REMEMBER MIKE'S FATHER COMING UP HERE OR ALREADY BEING HERE TO IDENTIFY..

Q. OK, YOU RECALL THAT?

A. YES I DO.

Q. DO YOU REMEMBER WHERE YOU WERE WHEN YOU HEARD HE WAS GOING TO DO THAT OR UH..

A. I DON'T REMEMBER WHERE I WAS...BUT I DO REMEMBER THAT MIKE'S FATHER WAS COMING UP HERE OR WAS ALREADY HERE.

Q. HAVE YOU MET MIKE'S FATHER BEFORE?

A. YES.

Q. (PAUSE) IS THERE ANYTHING ELSE YOU CAN THINK OF THAT I HAVEN'T ASKED YOU THAT MIGHT BE IMPORTANT? OR ANYTHING THAT I CAN MENTION OR BRING UP THAT MIGHT REFRESH YOUR MEMORY? YOU'VE BEEN FAIRLY CLEAR. I MEAN FOR SOMETHING THAT'S BEEN 14 YEARS AGO.

A. I, I DON'T RECALL ANY..ANY...OTHER DETAILS AND I THINK THAT THE QUESTIONS YOU HAVE ASKED HAVE HELPED TO UM..HELPED ME WITH MY MEMORY BUT IT WAS A LONG, LONG TIME AGO.

Q. YES IT WAS.

A. SO IT IS HARD TO REMEMBER DETAILS FROM THAT FAR BACK.

Q. I BELIEVE I ASKED THIS QUESTION BUT I THINK I ASKED IT A DIFFERENT WAY. FROM THE TIME, DO YOU BELIEVE IT WOULD HAVE BEEN POSSIBLE BASED ON THESE ALLEGATIONS THAT THE PAPER AND THE MEDIA ARE MAKING THAT MIKE MONAHAN COULD HAVE BEEN INVOLVED IN THIS?

A. I DON'T, I DON'T THINK SO.

Q. AT ANY POINT DURING THOSE TWO WEEKS, AND I KNOW I ASKED THIS QUESTION, I DON'T KNOW IF I ASKED IT RIGHT...FROM THE TIME OF THE ABDUCTION TO THE TIME THE HEAD WAS FOUND, WOULD IT HAVE BEEN POSSIBLE FOR MIKE TO HAVE BEEN ABLE TO KEEP FROM YOU OR HIDE FROM YOU THE FACT OF ANY KIND OF INVOLVEMENT IN THIS THING?

A. (PAUSE) POSSIBLY UH, IF I DO LEARN THAT HE WAS INVOLVED IN THIS I, I WILL BE SURPRISED.

Q. NO ONE'S SAYING, I'M NOT SAYING, WHAT I'M TRYING TO GET IS..

A. NOTHING THAT HE DID OR DIDN'T DO AT THE TIME LED ME TO BELIEVE HE WAS INVOLVED.

Q. HIS PERSONAL REACTION ABOUT, DO YOU REMEMBER HOW HE ACTED ABOUT THE FACT THAT ADAM WAS MISSING? DID HE APPEAR UPSET?

A. UM, I WOULD HAVE TO SAY THAT HIS REACTION WAS A NORMAL ONE. I WOULD HAVE FELT IF HE HAD HAD A, ANY, A STRANGE REACTION THAT WOULD HAVE SEEMED, SEEMED ODD TO ME.

Q. OK. TO THE BEST OF YOUR RECOLLECTION HE ACTED PROPERLY AS SOMEONE THAT WAS CLOSE TO ADAM..

A. YES.

Q. THAT HE WAS MISSING AND SUBSEQUENTLY MURDERED.

A. YES.

Q. OK. I'M SURE IF I TALKED TO YOU THE WEEK AFTER THAT HAPPENED YOU WOULD HAVE BEEN MUCH CLEARER ON THAT BUT THAT'S CLEAR ENOUGH. OK, I CAN'T THINK OF ANYTHING ELSE. IS EVERYTHING YOU TOLD ME BEEN TRUE TO THE BEST OF YOUR KNOWLEDGE, THE COMPLETE TRUTH?

A. YES.
