ON THE SAID DATE THIS DETECTIVE CONTACTED RAY GRANDON W/M 3-21-61 AT HIS RESIDENCE. RAY STATES THAT HE WA A RUNAWAY AND WAS PICKED UP BY A SUBJECT WHILE WALKING DOWN ORANGE BLOSSOM TRAIL IN ORLANDO. THIS WAS DECEMBER 1981. THE W/M TOOK HIM TO AN APT. WHERE OTIS TOOLE AND HENRY LUCAS WERE AT. LUCAS AND TOOLE WERE TALKING ABOUT WOMAN THEY KILLED. TOOLE SAID HE PICKED UP A BOY IN HALLANDALE OR HOLLYWOOD. TOOLE SAID THE KID WAS SCREAMING AND LUCAS CUT HIS HEAD OFF.

GRANDON SAID HE WAS DRUNK WITH TOOLE AND LUCAS. TOOLE GAVE GRANDON A GUN AND TOLD GRANDON TO SHOOT HIM.
