PM: As an investigator with the State Attorney's Office and a police officer I have the authority to take your statement under oath. So I ask you to raise your right hand and do you solemnly swear and affirm that the statement you are about to give will be the truth, the whole truth so help you god?

PW: Yes so help me god to be the truth.

PM: For the record again just please state your full name and date of birth?

PW: Patricia Ann Waldo, January 3, 1992.

PM: 1942 isn't it?

PW: 42 I'm sorry.

PM: Just to refresh. I took the statement from you at your home back on Friday, June 14, 1996 do you remember that?

PW: Yes I do.

PM: And basically the subject of the conversation was the whereabouts of Larry Leon Waldo on July 27, 1981 correct?

PM: So obviously something has jogged your memory and you now remember a little bit more about where Larry Waldo was on that date, so why don't you just tell me in your own words what you remember?

PW: Ok. Well after you left we had started into town and my daughter in law said you know I remember the day that that happened and she started telling me where I was at and I said yea I remember where I was at too. I said yea I was right there in the living room. My parents were living here at that time and said I was so shocked and then all of a sudden I just quit talking because it just came to me. I told her I went back to my house. We were living in a trailer out there then while we were building our house and later on that evening I was talking to - well that night late I was talking to my mother in law on the phone about it and during the time we were talking about the little boy missing she said that it was Larry's birthday and that he had come by and she had made him a banana cake and I said well that dog, I can't believe you made him a banana cake knowing that I liked it that well and could not have any. You know I was going on at her about it. So I immediately thought maybe this will help you or not but -

PM: So basically that is what pin points that date for you. That it was Larry's birthday?

PW: It was Larry's birthday and that banana cake.

PM: And you called down and spoke to Pearl Waldo?

PW: Pearl Waldo.

PM: Did she indicate that she in fact saw Larry that day?

PW: She said he came by to eat his birthday cake.

PM: Ok, that is pretty much saying the same thing then. Anything else?

PW: That is it.

PM: This will conclude the statement and the statement is being concluded for the record at 8:25 AM.
