A: Okay, this guy got out of his car and I don't remember the color of the car or what kind of car it was cause I didn't see the car and he started walking forward and me and my mom got out and he kept on turning around lookin at me, then he went on walking up until he got to the pay phone and he turned there and went kinda like he was calling or calling somebody and we, me and my mom passed . . .

Q: Okay describe this individual for me at this time.

A: Slender built, tall, I don't know about height.

Q: Approximately how tall would you say? Would you say he's under six foot . . .

A: Oh under six foot, under six foot. Uum about five ten, five eight, five ten, somewhere in there.

A: Not exactly he waited a couple of minutes you know, until we got a basket and we went on to walking.

Q: Okay. Now you enter the K-Mart Store and now what happens.

Q: Okay, did you leave the store before he did or did he leave the store before you did?

A: I don't know.

Q: Okay you just lost sight of him at that time.

A: Yea.

Q: Did you or your mother ever contact the security of K-Mart to report this incident or the police?

A: Well no.

Q: Okay. Let me ask you this, when he spoke to you, okay, about pushing you in the cart, how was his speech, can you describe that for me?

A: Poor grammer.

Q: How do you mean poor grammer HEIDI,

A: He wasn't, he wasn't - I don't know how to put it - he wasn't, he spoke clearly but his grammer was like he was puttin ain't and stuff like that.

Q: So would you say he was fairly uneducated?

A: Yea I would say that
