NORVELLA TOOLE is currently in Community Hospital Room 61. This statement is commencing on Friday, October 28, 1983, at approximately 1333 hours.

Prior to taking your statement Miss TOOLE are you aware that it is a crime under Florida State Statutes to knowingly furnish false information while under oath?

A. Yes I know that.

Q. Did there come times that he'd pick up and leave for a couple days and then reappear later?

A. I don't know because I didn't live with OTTIS all the time.

Q. Oh you never lived with him at all times?

A. That's right.

Q. Okay let me record your memory to August of 1981 or July of 1981, when you and OTTIS moved into an apartment of BETTY GOODYEARS. Do you remember that date?

A. We lived down on 7th Street.

Q. Is that one of BETTY GOODYEAR's places?

A. Ottis, the last time I saw him?

Q. Yeah.

A. When I took them cigarette up to the jail and that...

Q. You saw him in the jail already?

A. I saw him one time and then he cut me off from visiting, you know I told you that. He cut me off his visiting list, cut everybody off I guess.

Q. Did he ever tell you that he confessed to the police to murdering an ADAM WALSH, a six year old boy?

A. No, Lord no, uh uh!!!!

Q. Did you ever read that in the paper or see that on the news?

A. I didn't hear it and read it in the paper until, no I didn't read it in the paper this man from Channel news told me about it.

Q. Can you verify possibly his whereabouts on July 27th 1981, OTTIS'?

A. No sir. I stayed away from him so much I couldn't tell you nothin, really.

Q. You just don't remember dates that well?

A. The only thing OTTIS was good to me and that's all I know, I mean he never mistreated me, he never beat me or nothing, he always called me baby,
