This statement is in reference to any knowledge and information that Bobby Lee Jones may possess concerning a Homicide/investigation that occurred in Hollywood, Broward County Florida at the Sears Hollywood Mall..occurring on July 27, 1981 .. this statement is being obtained by Det. Hickman #434 and Det Hoffman #0038 of the Hollywood P.D. and is being obtained in the Duval County Jail, Jacksonville Fl. on Wednesday 11/2/83 @ 6:20 P.M.

Q. MR JONES, before I take this statement from you I am going to place you under oath by virtue of my commission as a Notary Public at large .. Please raise your right hand. Do you solemnly swear that the information you are about to give will be the truth, so help you God?

A. Yes

Q. For the record, state your complete given name, and date of birth.

A. BOBBY LEROY JONES March 22, 1965

Q. BOBBY, LEROY JONES, HAVING APPEARED BEFORE ME A NOTARY PUBLIC AT LARGE, IN AND FOR THE STATE OF FLORIDA, HAVING BEEN DULY SWORN, DEPOSES AND STATES:

Q. I would like to know what your knowledge is of ITTIS TOOLE.. first of all how long have you been in jail with OTTIS TOOLE?

A. I was in the cell with OTTIS TOOLE for a month

Q. That is recently?

A. Recently

Q. During the time you were in jail with Ottis Toole, did he ever talk to you about a murder case in Ft Lauderdale?

A. Well, Ottis Toole used to talk about a lot of murders to me and I thought he was jiving about the way he was talking about them..he would laugh at some of them..some he would get serious about.

Q. What type of victims would he discuss?

When I knowed him on the streets he used to come to work and a guy had made him mad one day and he went back to the house and came back, pulled out a shotgun and stuck it in the guy's mouth and told him he was going to blow his head off..

Q. This happened at Southeast..Color Kote.

A. Yes sir

Q. Was that on the job site ..

A. On the job site

Q. How long ago was this?

A. It was in '82..

Q. How long did you work with him when you were on the street?

A. I worked about a week and a half

Q. Was that the first time you ever got to know him..when you worked for

A. It was a week after I seen him driving that car..he wanted me to go
for a ride with him one day but I turned him down..I think I was going some-
where else and he said OK and I left

Q. In relationship to the incident where he stuck the shotgun in this guy's
mouth..did you see him in the Cadillac after that incident or before that inc
dent?

A. Before.. he drove off in the Cadillac to get the gun and he came back in
the car. He stepped out and he went to the trunk, opened up the trunk,
pulled this gun out and closed the trunk. He told the guy if he said another
word, he'd blow his head off.

Q. Were the Jacksonville police ever called to this incident?

A. Yes sir

Q. Is the police report on file?

A. Yes sir

A. I don't know his name but me and him was sitting down in the cell one day and we was talking about it

Q. Did OTTIS stick around till the police came

A. He slpit..he jumped in the car and took off.

Q. And you saw a uniformed police officer arrive and take the report?

A. I was up on the roof and I was watching

Q. These homicides that he had discussed with you where he told you how he committed these homicides, shootings,,what other methods did he tell you about

A. He was telling how he was cutting some of them up, shooting..removing their penis from their bodies..and stuff like that ..removing the head from the shoulders.. it was gross but he would laugh about it.. just sitting back and laughing..

Q. Did there ever come a time when he would discuss these murders and become serious.. change his character?

A. He would sit up on top of the bed ..and all of a sudden he would start

A. He had guns in his car I don't know why he'd want tools..he had a butcher knife under the seat
