HOFFMAN #0038 of the Hollywood Police Dept. and is being obtained at her place of business 117 East 2nd St., Jacksonville, Florida commencing on Friday, 11/4/83 at 12:14 P.M.

Q. MS. GOODYEAR before I take this statement from you by virtue of my commission as Notary Public at large I am going to place you under oath for your testimony. Do you understand that?

A. Yes sir

Q. Would you raise your right hand. Do you solemnly swear the information you are about to give in this statement to be the truth the whole truth so help you God?

A. I do

Q. Would you for the record state your complete name, date of birth and your home address?

A. BETTY GOODYEAR, 1931 Taylor St., Jacksonville, Florida

Q. We want to talk to you today concerning some receipts we had asked you about in the month of July of '81 and you have produced for us what you gave to DET. TERRY and he gave to myself and DET. HOFFMAN this morning. The bill of July, I have one here for July 31. This particular receipt here, is that your handwriting on the bottom of it?

A. One week right here.

Q. One week and how much did he pay you on that?

A. He paid me \$20.00 and then that paid him up from the 31st which I believe what would that run him to the 7th.

Q. Right, the bill indicates here til August 7th. Now is that the first time you had seen OTTIS TOOLE in that month of July?

A. Yes as far as I know that's the first time.

Q. And who did he come here with when he asked for that room? Who was with him?

A. His wife, I don't know if she was with him at the time that he first came here but he came to rent a room here for him and his wife in which his wife lived in with him.

Q. Would that be RITA?

A. RITA

Q. How did they move in. Did they have a car that they drove here and just took the stuff out of the car or did somebody help him?

A. She's living down here on Market St. I don't know...she's in the 1200 block on the right hand side.

Q. Of Market St.?

A. Yes sir. She works for this convalescent home down here on the corner of 3rd and Market.

Q. And her name is MARIE RADCLIFF?

A. Right

Q. Do you know if she knew MR. TOOLE?

A. Yes sir she knows him

Q. Did she know him before this date July 31, 1981?

A. I don't know. As far as I..I don't think she did.

Q. Let's back up and take it up to about the 25th of July. Here is another receipt dated July 28, 1981 to a MIKE GOLDMAN?

A. MIKE JOHNSON

Q. Is he still around?

A. He lives here at 117, this is a different house.

Q. Does he know OTTIS TOOLE?

A. He's in Orlando, Florida (DORA MICHELLE) W/F, DOB 10/7/53 who is a daughter of BETTY GOODYEAR who is also present in this room during this state

Q. He's in Orlando, Florida now?

A. Yeh he's working for....(inaudible)

Q. MS. GOODYEAR there is a receipt here dated 7/26/81 to a MR. LEO RULEY is that correct?

A. Yes sir but I don't know who he is.

Q. O.K. you don't know his whereabouts or who he is?

A. No I don't know who he is. That was 1306 that was a law student that was here.

Q. There is another receipt here 7/25/81 to a MR. KEITH RIDER?

A. I know the name but I don't know who he stayed with.

Q. So you don't know his whereabouts neither?

A. Probably just somebody passing through.

Q. Now the book that you have allowed us to have. MR. GERALD POWELL, the receipt is for \$10.00 for July 28th. Actually the date of July 26th to August 2nd?

A. Just a transient probably. I don't know.

Q. How about it looks like DELORES MILLER on the 28th?

A. 129 and 131 these is all books on '81 right here.

Q. MS. GOODYEAR I would like to call your attention to this second rent receipt book that you have furnished us with dated 8/7/81. Number 1 receipt from MR.V. TOOLE of \$20.00 from August 7th to August 14th. Can you explain that rent receipt?

A. His wife if I remember his wife came over and she told me to put the rent receipt in the V. TOOLE. I didn't know really what his name was at the time so she said put it in V. TOOLE so that's the way I wrote it out

A. No

Q. We determined so far that MARIE RADCLIFF.....

A. And this other TINA is another one would be a good one to talk to.

Q. How would we find BIG TINA

A. TINA, I don't know what her name is, I can't think of what her name is.

Q. And that's the 1100 block of Market?

A. She's in the 1200 block of Market right there. Most of them live in the same block. TINA lives on this side of the street in the big house, the second house from that store down here but she lives right in the back and you look through the back alley right there. (Inaudible)

Q. And MARIE RADCLIFF is at 30 Market in a convalescent home. MS. GOODYEAR
