The following will be a voluntary sworn statement with reference to an abduction/murder that occurred on or about July 27, 1981, occurring at 300 Hollywood Mall, located in the City of Hollywood, County of Broward, State of Florida. This statement is being obtained from an individual identified as TOOLE, OTTIS ELWOOD, W/M, DOB: 3-5-47, who is presently incarcerated in the Duval County Jail located in Jacksonville, Florida. This statement is being obtained by Det. J. Hoffman #0038 and Lt. R. Banks of the Hollywood Police Department. This statement is commencing on Friday, January 6, 1984, at approximately 0956 hours.

Q. Prior to taking your statement OTTIS I want to place you under oath by virtue of my commission as a Notary Public for the State of Florida, Broward County. Would you please raise your right hand. (Let the record reflect that the witnesses right hand is raised) OTTIS ELWOOD TOOLE do you solemnly swear to tell the truth, the whole truth and nothing but the truth so help you God?

A. Yeah.

OTTIS ELWOOD TOOLE HAVING APPEARED BEFORE ME A NOTARY PUBLIC FOR THE STATE OF FLORIDA AND AFTER HAVING BEEN DULY SWORN DEPOSES AND STATES:

Q. Prior to taking your statement OTTIS I'm going to advise you of your rights under the law okay?

A. Yeah.

Q. And you are, have been officially charged with other cases in the Jacksonville area and have been indicted on those, so I do want to advise you of your rights prior to taking your statement. Is that okay?

Q. Anything you do say may be used against you in a court of law. Do you understand?

these months now from the first time I met with you and the numerous interviews that we conducted and also crime scenes that you have taken us to along the turnpike, indicating that you were responsible for the abduction and murder of ADAM WALSH? Can you tell me why you stuck to your story all this time.

A. Ah I was trying to hang HENRY LUCAS at first but ah I found out he was in jail and ah, and so I changed it three or four different times, I did.

Q. What was your reason for changing it? Why didn't you come out and say you know I was not responsible for the murder of that boy at that time. Once you knew that HENRY was in jail up in Virginia, or Maryland?

A. Well after I already made the statement I didn't know if I could change it back or not. That's why I kept telling different stories about it, cause I didn't know as anybody would believe it or not. I didn't know how to turn it back around but I really didn't kill ADAM WALSH.

Q. So you were kind of scared to retrack your confession then?

A. Yeah.

Q. Do you recall to the best of your knowledge what you did when you arrived back in Jacksonville from Virginia?

A. Umm, Well I stayed around Nancy's a little bit but not too much. I don't remember what nights I stayed over there. I stayed over there a night or so, something like that.

Q. For the record that would be NANCY JACKSON?

A. Yeah. And ah I was sleeping outdoors cause I hadn't got my job back, I mean I I already had my job when I went to Virginia and all travelling around

Q. How do you get paid at your job.

A. At my job? With check.

Q. By check?

A. Yeah.

Q. You're certain you were working at Southeast Color Coat at that time?

A. Yeah.

Q. And after you were in town there was a period of time where you stayed at NANCY's and you say RITA and PAT and three kids were there?

A. Yeah.

Q. Where were you staying at the time he did that?

A. I was living at 131 East Second Street.

Q. And what place would that be?

A. Ah in a rooming house.

Q. Could that be referred to as BETTY GOODYEAR's rooming house?

A. Yeah.

Q. Okay, then the date of the incident with your brother was August 1, 1981,

A. Yeah.

Q. We have a rent receipt from BETTY GOODYEAR's rooming house on July 31st

A. Umm I had, I believe I did, I ain't exactly, exactly sure.

Q. Cause we could never find records to verify that.

A. Not exactly sure.

Q. Did John Jr ever pay you off the books without a check?

A. Um, no uh uh. No he wouldn't pay me without that.

Q. During the period of time when you arrived back from Jacksonville how did you obtain money?

A. I, I had about 300 dollars when I came back. I had it under the house.

Q. That's true then, that part of the information you gave us in your previous statements?

A. Yeah that part's true.

Q. Okay. What would you do in the evening hours?

A. What would I do in the evening hours?

Q. Yeah would you go out?

A. Oh I'd go out, I'd go out drinking quite a bit. I'd go bar hopping, go from one bar to another bar. If this bar seemed like it was dead I'd go to another bar. Go where the crowd is.
