On the above indicated date and time a specific polygraph examination was administered to one, Mary E. Green.

The purpose of the examination was to determine if the subject was involved in or had any knowledge of the abduction and murder of Adam Walsh between Monday, July 27, 1981, and Monday, August 10, 1981. The abduction occurred at Sears-Roebuck store in Hollywood, Florida.

Information available indicates that an informer reported to the Sheriff's Department that the above named subject had told him that she and three other persons, Frank Godderas, Fran Mullins, and Pearly had abducted the Walsh boy and that Godderas had killed the boy in the presence of the others, and also present at the time of the murder was a man by the name of Tom.

Prior to the examination the subject signed a form giving her permission for the examination to be conducted. This executed form is being incorporated as a part of our company files.

The subject willingly participated in the examination and was interviewed in a private room. During the examination standard polygraph procedures were adhered to and a C. H. Stoelting, Ultra-scribe, Model 80445 instrument was utilized, which is designed to indicate and record changes in blood pressure, rate and strength of pulse beat respiratory patterns, and changes in galvanic skin resistance.

During the pre-test interview the subject stated in essence as follows: She has no personal knowledge of the Walsh abduction and murder, other than what she has read in the papers and seen on television and that she has never told anyone anything such as is alleged. She states that she is acquainted with Frank Godderas, Fran Mullins, and a man named Pearly, but does not remember anyone of that group called Tom. She denies being in the Hollywood, Florida, area during the month of July, 1981.

Following the pre-test interview and a thorough review of the questions to be used during the first polygraph examination the test was conducted.

In addition to the routine test questions the following relevant questions were propounded to the subject during the course of the examination:

2. Regarding whether or not you were involved in the abduction of Adam Walsh on Monday, July 27, 1981, - Do you intend to answer truthfully each question about? Answer-Yes.

4. On Monday, July 27, 1981, were you involved in the abduction of Adam Walsh from Sears store in Hollywood, Florida? Answer-No.

6. Did you participate in any way, in the abduction of Adam Walsh, on July 27, 1981? Answer-No.

7. At the very time Adam Walsh was abducted, were you present at Sears store in Hollywood, Florida? Answer-No.

8. Could you show me where the body of Adam Walsh was disposed of? Answer-No.

11. Did you tell anyone that you, Frank, Fran, Tom, and Pearly were involved in the abduction of Adam Walsh? Answer-No.

9. Regarding whether or not you were involved in the abduction of Adam Walsh on Monday, July 27, 1981, have you answered truthfully each question about that? Answer-Yes.

Following this examination and a thorough review and analysis of the polygraph charts it was the opinion of the examiner that there were no unresolved responses noted on the polygraph charts that were indicative of deception.

Following a thorough review of the questions to be used during the second polygraph examination the second examination was conducted.

In addition to the routine test questions the following relevant questions were propounded to the subject during the course of the examination:

2. Regarding whether or not you were involved in the death of Adam Walsh - Do you intend to answer truthfully each question about that? Answer-Yes.

4. Were you in anyway involved in the death of Adam Walsh in July, 1981? Answer-No.

6. Were you present when Adam Walsh was killed? Answer-No.

7. Do you know for sure who killed Adam Walsh? Answer-No.

9. Regarding whether or not you were involved in the death of Adam Walsh - Have you answered truthfully each question about that? Answer-Yes.

Following this examination and a thorough review and analysis of the polygraph charts it was the opinion of the examiner that there were no unresolved responses noted on the polygraph charts that were indicative of deception.

Based on these findings and the findings of the first polygraph examination it is the opinion of the examiner that the subject may be considered as having been truthful in her answers to the questions on both examinations.
