This statement is being taken by DETECTIVE R. HICKMAN Badge #0434 of the Hollywood Police Department and is being obtained on Friday, July 16, 1982 commencing at 12:45 P.M. and being obtained at the Hollywood Police Department, Detective Bureau Conference Room.

Q. Ralph before I obtain this statement from you, by virtue of my Commission as a Notary Public at large and power to take statements and placing people under oath. I want to take a statement from you under oath. Do you understand what it is to be placed under oath?

A. Yes.

Q. Explain it to me, what's going to happen?

A. Well, by law that I have to tell you the truth.

Q. When you swear to tell the truth?

A. Yes.

Q. When you are asked to swear to tell the truth by a person empowered to place you under oath, that would be myself.

RALPH MEDINA HAVING APPEARED BEFORE ME A NOTARY PUBLIC AT LARGE IN AND FOR THE STATE OF FLORIDA AND AFTER HAVING BEEN DULY SWORN DEPOSES AND STATES:

Q. Ralph I want to talk about the information that you brought to my attention today at approximately 9:45 A.M. this morning. First off I understand you talked to two members of this Police Department yesterday afternoon and gave them certain information concerning one individual by the name of ALEJANDRO MARCOS - spelled A-L-E-J-A-N-D-R-O M-A-R-C-O-S Latin male, DOB: 4-28-48 who resides at 390 N.W. 2nd Street, Apt. #812 in Miami and is a person you know as Alex is that correct?

A. Yes.

Q. You have given information that this individual had told you that he killed Adam Walsh. Is that correct?

A. Yes.

Q. What I want you to do is to relate to me the circumstances surrounding his giving you that kind of information. What prompted him or made him tell you that he killed Adam Walsh?

A. He always, he likes to show off, he likes to feel like he, you know, like he's a big honcho, you know that he's a big guy and he gets his kicks out by telling people what he likes to do, like choke kids and molest them and give them drugs. He gets, he likes he likes doing that.

Q. Do you think he actually killed Adam Walsh? You just said he did it because he wants to brag.

A. Yeah he likes to, the way he told me it sounded like he was bragging. But he done it, I'm pretty sure he did because the way he acts, the way he treats these kids and he really weird, he will beat a, I am pretty sure, I'm very sure that he did it, he threatened me that if I said anything about this he was going to kill my brother the same way, and I thought he was going to kill me if I said anything to the Police.

Q. The context that you just said that to me in, is indicating that he told you he killed Adam Walsh and then threatened to do the same to you if you told the Police. But that was not what you told me in the interview. You indicated to me in the previous interview this morning that I had with you that he mentioned that to you, about killing Adam Walsh, because he was getting aggravated about you trying to take your brother Ernesto, who is fifteen years of age, out of this guy's apartment and cause Ernesto to go back home. Is that correct?

A. Ummm.

Q. Was that the real reason why he told you about Adam Walsh, was to stop you from trying to take your brother out of his house?

You told me this morning in the first interview that I had with you, that he told you that he would kill your brother and you if you mentioned to the Police the activity that he was involved in concerning his homosexual activity and drug dealings with children, is that correct?

A. me?

Q. Was that the real reason why he said he would kill you and your brother like he did Adam Walsh, if you told the Police about his drug activities?

A. No he he I .

Q. Want me to explain it to you a little bit better?

A. Yeah.

Q. When I was talking to you this morning, sometime around 9:45 or 10:00, you indicated that approximately two weeks ago, Alex told you that he would kill your brother and you like he killed Adam Walsh if you went to the Police concerning what he is doing to your brother with drugs and homosexual activity?

A. ...If I would have said anything about what he told me he would kill my brother and me. He will kill my brother, he'll kill me if I tell the Police anything of what he said and he'll kill my brother the same way.

Right, he'll kill me, yeah he said he would do that he said that when I went to go out to my brother, he pulled out a revolver, I could just hear the click, I was standing in the door asking for my brother and he says, get away I got a gun, I got a gun, I told you not to come by here, I told you about coming around here, okay I got a revolver in my hand, I'm going to kill you and then the next thing you know I'm standing right there, I mean, I'm frozen and my legs like stiff and my mind is telling my legs lets go and the next thing you know I hear a click and it totally just scared me half to death and I just had to force myself to move away from the door because this could have blown the door right there and I could've been killed, I was totally terrified.

Q. Why did he pull a gun on you?

A. I don't know.

Q. Why, you just told me why.

A. He threatened that he was going to kill me.
