UNSIGNED. I WAS AFRAID OF THE RIDCULE THAT MAY HAVE FOLLOWED THIS LETTER.

SIR:

I COMPOSED THE ENCLOSED LETTER. WHEN I FIRST CAME INTO CONTACT WITH  
KATHERINE AND HER DAUGHTER PEGGY, BOTH TOLD ME BASICALLY THE SAME THING  
SEPERATELY. OVER THE PERIOD OF ABOUT THREE MONTHS, I TOOK NOTES OF WHAT  
BOTH WOMEN WERE TELLING ME AND WHAT WAS BEING DESCRIBED TO ME BY THEM.  
IN JULY OF 94 WE WENT TO FT PIERCE FL. AT FIRST WE WENT TO AN AREA THAT  
WAS TOLD TO US OF BEING THE PLACE WHERE ADAMS HEAD WAS FOUND. THIS TURNED  
OUT TO BE A FALSEHOOD. WE KEPT DRIVEING AROUND TRYING TO LOCATE A PLACE THAT  
LOOKED LIKE WHAT THE WOMEN HAD SEEN. AT THIS TIME NIETHER WOMAN HAD BEEN IN  
FT PIERCE, NOR WAS FAMILIAR WITH THE AREA. I HAD BEEN IN FT PIERCE A FEW TIMES  
AND HAD TAKEN A FIREARMS INSTRUCTOR TRAINING COURSE WITH SIG ARMS AT THE ST  
LUCI CO GUN RANGE. THE BUILDING IN THE PHOTO, WAS DESCRIBED IN SHAPE AND THE  
OUTSIDE AIR CONDITIONING DUCT WORK ON THE WEST SIDE OF THE BUILDING IS A MATCH  
FOR THE SKETCH ~~HAD~~ IS IN MY NOTE BOOK. ALSO AT THIS TIME THE SENSATION OF AN  
UNKNOWN PRESENCE WAS FELT BY BOTH WOMEN, AND IS EVERYTIME WE GO BY THIS PLACE.  
I WAS TOLD THAT THE PROPERTY AT ONE TIME WAS A ORANGE GROVE, AND A POTATO  
PACKING HOUSE. WHERE THE ROOF DRAINS AND CATCH BASIN ARE OR ~~RUNOFF~~ PIPEING  
IS, IS UNKNOWN TO US. MAYBE THE BUILDING AND ZONE DEPT WOULD HAVE SOME OLD TIME

MAPS AND CONSTRUCTION PLANS SOMEWHERE. FOR THE LAST THREE YEARS THE SENCEING OF  
AND THE DREAMS OF BOTH WOMEN STILL PPACE THE LAST REMAINS SOMEWHERE NEAR THE ANTIQUE  
STORE BUILDING IN SOME TYPE OF CONFLUNENCE OF UNDERGROUND PIPEING. ONE OF THE  
SENSATIONS THAT PEGGY HAD WAS THAT ADAM WAS FLYING THROUGH A DRAIN PIPE OF SOME  
KIND UNTIL ADAM WAS HUNGUP IN THE JOINING OF A PIPE. I KNOW THAT MOST OF FLORIDA'S  
LAW ENFORCEMENT AGENCY SCOFF AT PYSCHICS, BUT AS BOTH WOMAN HAVE REAL<sup>y</sup> SUPPORTED  
EACH OTHER AND THE DETAILS OF THE BUILDING WERE SO ACCURATE. IT IS HARD NOT TO  
BELIEVE THAT THERE MAYBE SOMETHING TO THIS. THANK YOU FOR YOU CONSIDERATION.

SIR:

I HOPE YOU WILL RECEIVE THIS LETTER. WE CHOOSE TO REMAIN ANONYMOUS AS WE DESIRE NO REWARD OR PUBLICITY. THE EVENTS I AM GOING TO TELL YOU ABOUT HAPPENED IN APRIL MAY AND JUNE OF 1993, AND SINCE. THERE IS NO EVIDENCE TO SUPPORT WHAT I AM ABOUT TO TELL YOU. IF YOU BELIEVE IN PSYCHIC PHONEMA THEN YOU WILL SEE SOME POSSABLITIES. FIRST LOCATION. FORT PIERCE FL, AS YOU PASS UNDER THE FL TURNPIKE ON HWY 70 EAST BOUND, THE FIRST INTERSECTION TURN NORTH. SOUTH IS THE TURNPIKE ENTERENCE. I DO NOT REMEMBER THE STREET NAME. AFTER PASSING UNDER THE I 95 OVERPASS'S YOU COME TO AN INTERSECTION THE EAST WEST STREET IS KING SOMETHING OR OTHER. ON THE NORTHWEST CORNER IS AN OLD CITRUS BARN, ONCE A POTATO BARN AND NOW A RED ANTIQUE SHOP. I HAVE ENCLOSED A MAP OF SORTS. DRAWING NUMBER ONE IS A COMPOSITE OF MY WIFE AND HER DAUGHTER, THIS IS THE KILLER OF ADAM AND AT LEAST TWO OTHER CHILDREN. DRAWING NUMBER TWO, IS A COMPOSITE BY THE SAME ARTIST WHICH INVOLVED AN ATTEMPTED STRONG ARM ROBBERY IN MAY OF 93. THE WOMEN SAY IT IS THE SAME PERSON. WHILE ON THE SUBJECT OF THIS SUSPECT HERE IS THE INFORMATION ABOUT HIM. YOU HAVE THE AGE AND PHYSICAL DESCRIPTION. THIS PERSON IS EITHER A PART OF A MOTORCYCLE GANG OR GANG'S OR HANGS AROUND THE FRINGES OF THEM. HE WORKS SOMETIMES IN CIRCUS'S OR CARNIVAL'S. HE HAS ALSO WORKED ON SHRIMP BOATS. HE HAS WORKED AS A CLOWN AND RENTED OUT AT SOME BIRTHDAY PARTIES AS A CLOWN. HE HAS LIVED IN AND SLEPT IN HWY CULVERTS AND IN HOBO VILLAGES AFTER THE ARTIST GAVE US DRAWING NUMBER TWO, WE VISITED A POSSABLE PLACE HE WOULD HAVE BEEN, AND HE HAD JUST LEFT.

I MET MY WIFE IN APR 93, I HAVE HAD SOME EXPRIENCE BEFORE THIS WITH PSYCHIC ABILITY. THIS HAS BEEN BY HISPANIC AND AMERICIAN INDIAN FEMALES. MY WIFE TOLD ME ABOUT HER ABILITY AND HER DAUGHTERS. I HAVE FOUND THEIR ACCURACY TO BE ABOUT 85% OR BETTER, INCLUDEING SOME EVENTS WHICH CONCERNED ME AND CAME TRUE. BOTH WOMEN HAD THE SAME TO SAY IN THE CASE OF ADAM, WITH ONLY MINOR DIFFERENCES. ALL THE CLUES WE USED, CAME FROM BOTH WOMEN, AND FROM A PROFESSIONAL PSYCHIC. MY WIFE HAD BEEN TO FT PIERCE ONCE, AND THE DAUGHTER NEVER UNTIL WE PERSUED THE VISIONS AND DREAMS TO WHAT WE FOUND. WE WERE FIRST GIVEN FALSE INFORMATION AS TO THE LOCATION OF THE FIRST FINDING OF ADAM. WHEN I TALKED ONE OF THE POLIC OFFICERS IN INDIAN RIVER I FOUND OUT THE TRUE LOCATION. WE HAD SPENT THE GREATER PART OF TH DAY IN THE WRONG PLACE. WHEN WE WERE ON THE NORTH SOUTH ROAD FROM HWY 70, AND AS WE PASSED UNDER THE I95 OVERPASS, BOTH WOMEN FELT THAT ADAM WAS NEAR BY. AS WE NEARED THE BARN THE FEELINGS BECAME VERY INTENSE. A CLUE PREVIOUSLY GIVEN WAS THE PAINTING ON THE FRONT SIDE OF THE BARN. AT THIS POINT THE FEELING OF ADAM BEING NEAR BY WAS VERY STRONG AT THIS POINT IN BOTH WOMEN. THE WOMEN WENT INSIDE AND THEY CAME OUT AND TOLD ME THAT, THE FEELING OF ADAM WAS ALL OVER THE BUILDING. ALSO THAT THE STEPS LEADING TO THE LOFT WHERE EXACTLY THAT OF THEIR VISIONS. UNTIL THIS TIME NEITHER WOMEN HAD BEEN IN THIS AREA OR IN THIS BUILDING.

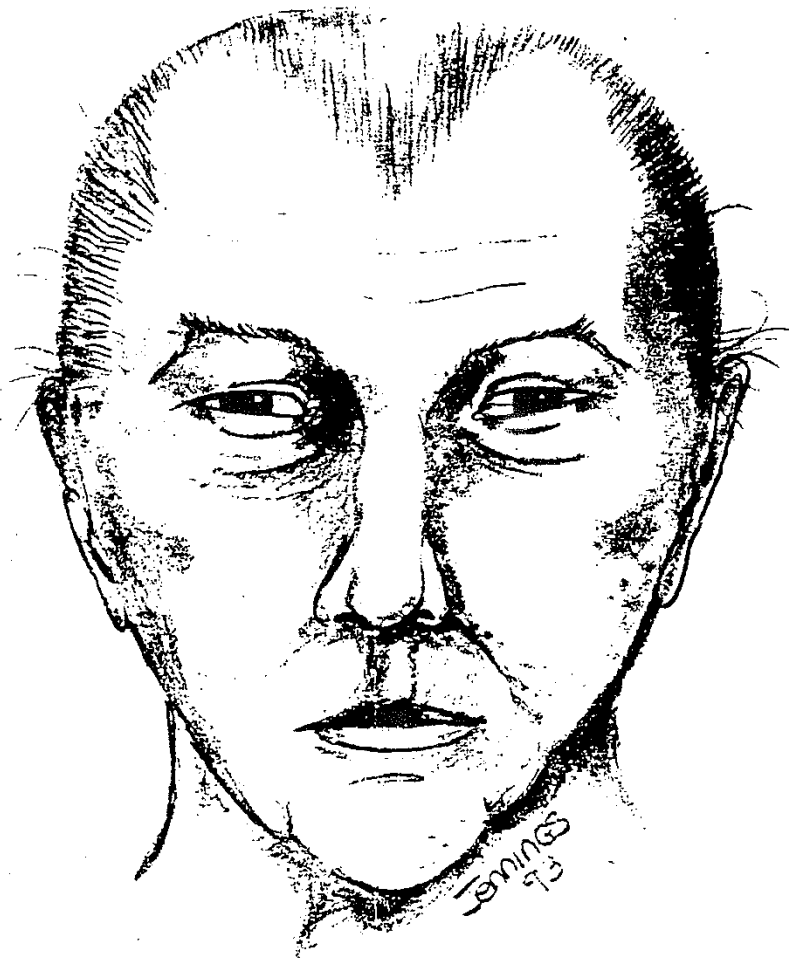

WE ASKED THE OWNER IF WE COULD LOOK AROUND THE BUILDING AND HE DID BY OURSELVES. ON THE WEST SIDE OF THE BUILDING, LOOKING EAST, BOTH WOMEN SAID THAT THE BUILDING WAS EXACTLY WHAT THEY HAD SEEN IN THE VISIONS. WE WENT BACK AND ASKED THE OWNER IF WE COULD LOOK IN AND UNDER TWO MAN HOLE COVERS ON THE SOUTH SIDE OF THE BUILDING. HE LET US. WHEN WE OPENED THE MAN HOLE COVERS, ONCE AGAIN CLUES THAT WERE SEEN IN THEIR VISIONS WERE PRESENT. WE THEN LEFT AS WE DID NOT WANT THE OWNER TO THINK WE WERE CRAZY AND CALL THE POLICE. WE RETURNED AT NIGHT A COUPLE OF WEEKS LATER AND AGAIN WALKED AROUND THE BUILDING AND ALONG THE SEA WALL BY THE CANAL. AGAIN THE STRONG FEELING OF ADAM CAME OVER BOTH WOMEN. WE DID NOT LOCATE ANYTHING OR OTHER CLUES. WE THEN DECIDED TO RETURN ON A SUNDAY WITH A BOAT AND LOOK AROUND THAT WAY. AGAIN NEAR THIS BUILDING BOTH WOMEN FELT ADAM'S PRESENCE. ONLY THIS TIME THE DAUGHTER HAD THE FEELING OF ADAM SAYING THIS WAY OR THAT, ALMOST AS IF PLAYING HIDE AND SEEK. I WATCHED BOTH WOMEN VERY CLOSELY, AND BOTH AT ALL TIME WERE VERY HIGHLY AGGITATED.

HERE IS WHAT BOTH WOMEN SAW IN VISIONS AND DREAMS, THERE ARE ONLY SMALL DIFFERENCES AND THESE WERE NOT DISCUSSED PRIOR TO, OR BEFORE EACH HAD THESE VISIONS. IT SEEMS THIS GUY TOOK ADAM TO THIS BARN, AT THE TIME I BELIEVE IT WAS EMPTY. (NOTE: TWO OTHER CHILDREN ENTERED THESE VISIONS AT THE SAME TIME, EITHER TIED TO THE BARN OR TO THE KILLER). AFTER ADAM WAS KILLED HE WAS HUNG BY THE NECK IN SOME TYPE OF CISTERN OR TANK THAT HAD METAL RUNGS IN ONE SIDE FOR GETTING IN OR OUT. SOME HOW EITHER BY KNIFE OR THE WIRE HANGING HIM ADAM'S HEAD WAS SEPERATED AND THE BASIC BODY FELL DOWN TO THE BOTTOM OF THIS TANK. AT THE BOTTOM THERE ARE OPENINGS JUST BIG ENOUGH FOR ADAMS BODY TO ENTER. ALSO THERE IS A OPENING SOMEWHERE IN THE MIDDLE OF THE TANK. THE VISIONS OF BOTH, BUT STRONG AND MORE VIVID BY THE DAUGHTER HAS ADAM MOVEING THROUGH ONE OF THESE PIPES TO SOME KIND OF JUNCTION WHERE HE IS STUCK. WE USED THE BOAT IN AN ATTEMPT TO FIND AN EXIT PIPE IN THE CANAL AROUND THIS BARN. WE WERE NOT ABLE TO DO SO. WE RETURNED ANOTHER TIME, THIS TIME TO CHECK THE AREA AROUND THE BARN AND TRYING TO GET THE LAY OF THE LAND AS IT MIGHT HAVE BEEN AT THE TIME OF ADAMS DEATH. WE COULD NOT, AS IT HAS BEEN MADE INTO AN INDUSTRIAL PARK TO THE WEST AND NORTH OF THE BARN. AS WE STARTED TO AROUSE SOME ATTENTION WE LEFT AND HAVE NOT BEEN BACK. WE HAVE SPENT MANY HOURS, TRYING TO FIND WAYS TO BE ABLE TO GET BUILDING AND ZONEING MAPS AND CONSTRUCTION DRAWING TURNED INTO THE COUNTY TO SEE WHERE THE PIPES AND TANKS MIGHT HAVE BEEN, BUT BECAUSE OF THE IDEAS OF PEOPLE ON PSYCHICS WE HAVE STAYED AWAY. WE FEEL THAT GOD HAS CHOSEN THIS WAY AND TIME TO TRY TO GET ADAM REUNITED WITH HIS FAMILY AND SELF. WE ARE ONLY INTERESTED IN THAT REUNION AND NOTHING ELSE. I HOPE THAT WITH YOUR STATUS AS A HOST OF A TV SHOW, THE DRIVING FORCE IN THE CAUSE OF LOST CHILDREN, HAD SOMETHING CAN COME OF THIS. MY WIFE IS AN ADVIVID FAN OF AMERICA'S MOST WANTED. IF YOU FEEL THAT WE COULD BE OF FURTHER SERVICE, YOU CAN USE THAT MEDIUM FOR US TO CONTACT YOU AGAIN. I HOPE THAT THIS INFORMATION LEADS TO PEACE FOR YOU AND YOUR FAMILY.

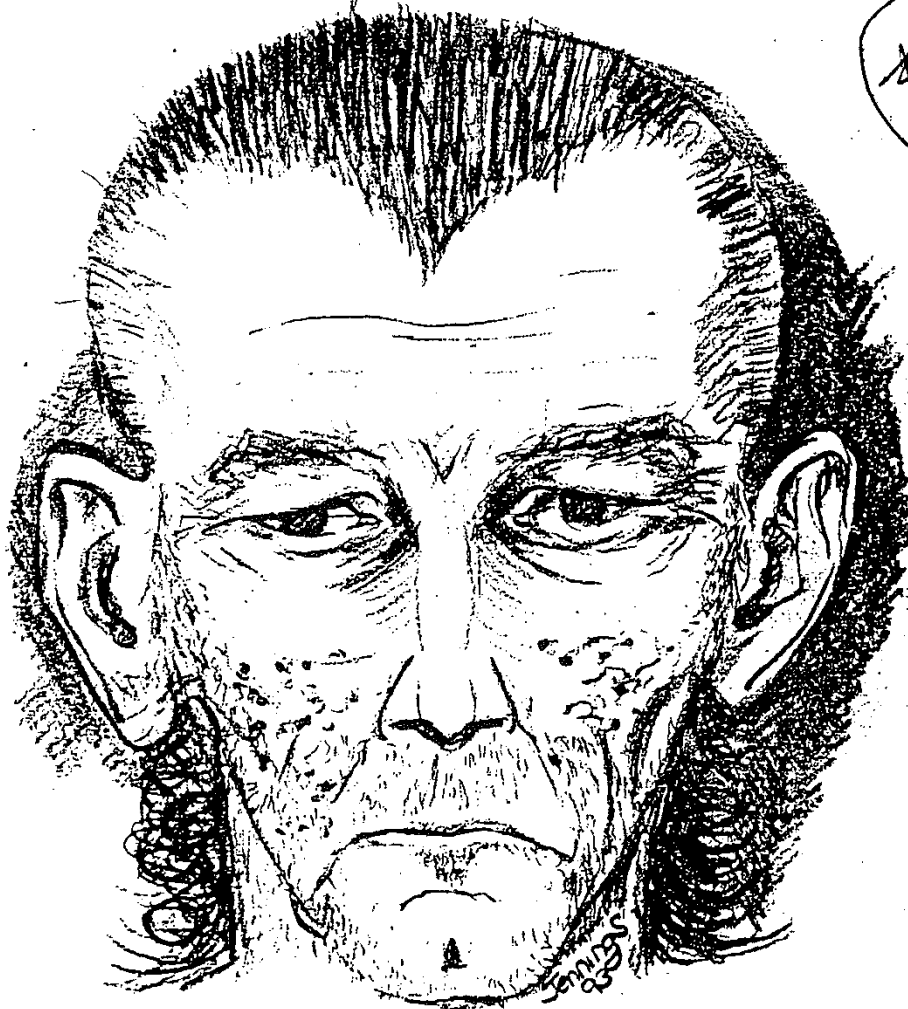

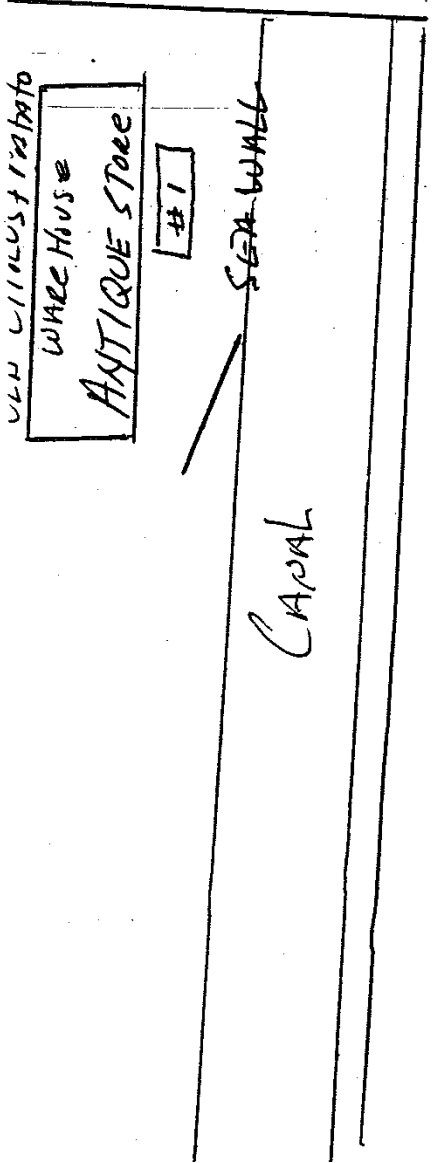
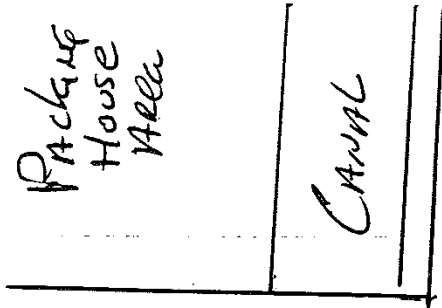
