Donald Evans re: Adolfo Constanzo  
(Adam Walsh)

December 11th, 1996

Greetings & Salutations Tony!

Just a letter to re-hash our conversation today.

First of all... should we ever have to talk again, do not set it up where you call back through the prison switchboard. I have my reasons! The calls will be straight collect from me!

Now... about the Walsh situation. Somehow we began speaking in terms of "1982". Wrong! It was Sept. to Oct. 1981 that I had many interactions with Adolpho Constanzo. My main thing with him was me buying cocaine from Constanzo.

It was right after my interactions with Constanzo that I went North to Jacksonville, where I was arrested in Nov. 1981 for theft of a chainsaw; or, Auto burg, as the charge read.

But Constanzo is the person who did Walsh.

I know other things, but what I told you today should serve to get some folks off their lazy asses.

Too many damn office jinky philosophers in this ~~use~~ world of wannabe cops that

really don't know diddly-squat. I find such self-proclaimed smart-folks a cheap source of entertainment. Better than Bugs Bunny!

Now... about the art I put into the record, and that was made a part of the competency hearing in July 1995.

the steering wheel go, it goes back to "center". You people never even notice this tiny bit of evidence that "blew" Keene bullshit story apart.

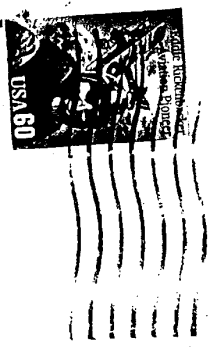
So you need to listen to me now in the Walsh deal, Art theft deal, and Fogleman deal.
